2 'JMB men' arrested in Pabna

Police in a drive arrested two suspected operatives of banned militant outfit Jama'atul Mujahideen Bangladesh (JMB) raiding a house at Palpara village in Sujanagar upazila of the district on Saturday night. The arrestees are Mohammad Omar Faruk, 30, son of Shaban Ali of Ullapara upazila in Sirajganj, and Mohammad Sanaullah, 35, son of Abdul Gani of Gokulnagar village in the upazila. The law enforcers also seized some books on jihad from the arrestees' possession. Officer-in-Charge Mohammad Nur Islam of Sujanagar Police Station said police arrested the two while they were holding a secret meeting there.

Female worker raped

A female worker of Akij Jute Mills was gangraped at Nehalpur in Monirampur upazila of Jessore on Thursday night while she was returning home along with a coworker. The incident occurred when the 16-year-old girl of Fedaipur village was returning home along with a colleague around 11:00pm on Thursday after watching a movie in a local cinema hall. The victim filed a case with Monirampur Police Station on Saturday against five people accusing them of raping her, said Officer-in-Charge (investigation) Lutfur Kabir.

Trade thru' Benapole resumes

Prisoner dies in Dinajpur

One killed over land dispute

A youth was murdered and his brother was injured critically in a family feud over land dispute yesterday at Nazirpur upazila in the district.

The deceased is Suruzzaman Sheikh, 26, and the injured is Badal Sheikh, 22, sons of Sarwar Hossain Sheikh of Raghunathpur village in the same upazila.

The clash began immediately after a team of village arbitrators, who came to resolve the dispute, left the house saying that the land would be measured in dry season as the land is muddy.

At one stage of quarrel around 9:30am, Mehedi Sheikh, his father Mosharraf Hossain Sheikh and mother Mary Begum began to stab Suruzzaman and his brother Badal indiscriminately with a sharp weapon.

Suruzzaman succumbed to his injuries on the way to Bagerhat Sadar Hospital while critically injured Badal is undergoing treatment in the hospital.

Locals allege laxity of administration

A local influential person is building a multistoried building allegedly grabbing 3,600 square feet land in the Kobadak River in Moheshpur upazila under the district.

Visiting the spot recently, this correspondent found that the alleged grabber has already built five-foot-high 20 columns to construct 12 rooms on the west side of Alampur Bridge, encroaching upon a good portion of the river land.

Upazila Nirbahi Officer Ashafur Rahman said the structure, being built on river land, is illegal.

Mahbubur Rahman, a resident of Balidapara village under Kaliganj upazila in Jhenidah, who started the construction

three months ago, claimed that he has purchased the eight-decimal plot, owned by some Abul Hossain of Alampur village for Tk 15 lakh. "Before purchasing the plot, I scrutinised

the land records of 1926 and 1962. If the plot belongs to river area I will surrender it to the government," said Mahbubur, who runs fertilizer business in Kotchandpur upazila town of the same district. An elderly person seeking anonymity

said some unscrupulous people showing fake document are grabbing river land while the administration seems reluctant to take action in this regard. Water of the river in the area remains

"We will take necessary action in this stagnant round the year except some flow in rainy season.

Taking the opportunity of the reluctance of the authority, grabbers occupy the lands of the river in different parts, locals alleged.

dead by BSF

Indian Border Security Force (BSF) shot a Bangladeshi national dead on Chakiram border under Dhamoirhat upazila in Naogaon district early yesterday.

The deceased was identified as Golap Hossain, 34, son of late Khairul Hossain of Chandipur village in the upazila.

Border Guard Bangladesh (BGB) said BSF troops of 75 Battalion opened fire on a group of 10/12 Bangladeshi smugglers while they were returning home from India through Chakiram border on Saturday midnight.

Golap came in the line of fire and received bullet injuries during the firing while his other associates escaped

Later, the Indian border guards rescued injured Golap and admitted him to Balurghat Hospital in the Indian state of Pashchimbanga. He died at the hospital while undergoing treatment there around 3:00am.

Lt Col Ali Reza, commanding officer (CO) of Patnitala BGB 14 Battalion said they held a flag meeting with the BSF personnel around 12:00noon yesterday where they asked their Indian counterpart to return the body.

111 FORMER ENCLAVES

Listing of voters begins

Listing of voters in 111 former Indian enclaves under Lalmonirhat, Kurigram, Nilphamari and Panchagarh districts began yesterday, about one year after they got Bangladeshi nationality following ratifica-Bangladesh and India.

Amzad Hossain, an enumerator at exenclave Bhitorkuti in Lalmonirhat Sadar, said they are listing voters by going door-todoor and also with the help of the list prepared jointly by Bangladesh and India. Nazrul Islam, 45, of Bhitorkuti in 27,700.

Kulaghat union, said, "We got our nationality, but we have not got National Identity (NID) card. And so, we cannot avail different government or non-government facilities."

Azizul Islam, 48, of Gotamari under Gotamari union of Hatibandha upazila, said, "Election officials confirmed that we will get NID card in the first week of August this year," he said.

Union Parishad elections in nine unions -- seven under Patgram upazila, one under Hatibandha upazila and another under Lalmonirhat Sadar upazila -- have been suspended because the ex-enclave people have not received NID cards.

Around 37,370 people are living in 111 on Saturday night. tion of enclave exchange deal between ex-enclaves under Lalmonirhat, Kurigram, Nilphamari and Panchagarh districts, of them 9,670 people belong to 59-ex-enclaves under three upazilas in Lalmonirhat.

The remaining 52 ex-enclaves, of which 12 are in Kurigram, four in Nilphamari and 36 in Panchagarh, have a population of

Asad Mia, 56, of Dashiarchhara under Fulbari upazila of Kurigram, said four of his family members were listed as voters.

District Election Office sources said listing of eligible ex-enclave people as voters will continue till July 16, and taking of photographs of voters will start on July 17 and continue till July 25. The final voter list will be published on August 4. They will get their NID cards after that.

Elderly father beaten to death by sons

An elderly man was allegedly beaten to death by his sons at Shimulia village under Saturia upazila of Manikganj

The victim was identified as Afaj Uddin, 70, of the village.

Locals and police said Afaj Uddin's sons Awlad and Khorshed beat up him with sticks when he refused to give them land. He was taken to hospital where the doctor declared him dead.

Locals caught the two sons and handed them over to police. Police later arrested Awlad's wife Morjina Begum.

Habibullah Sarker, officerin-charge of Saturia Police Station, said the body was sent to Manikganj Sadar Hospital morgue for autopsy.

Proof found against JP MP Hannan Hassle-free return to city

FROM PAGE 16 a lawmaker of BNP, the then opposition in parliament.

Currently, Jatiya Party is the main opposition in parliament and three of its lawmakers are members of the cabinet of the Awami League-led government. JP Chairman HM Ershad himself is the special adviser to Prime Minister Sheikh Hasina.

Apart from Hannan, 80, who is a lawmaker from Trishal (Mymensingh-7 constituency) and presidium member of JP, other accused of the case are his son Rafique Sajjad, 62, Khandakar Golam Sabbir Ahmed, 69, Mizanur Rahman Mintu, 63, Hormuj Ali, 73, Mohammad Abdus Sattar, 64, Mohammad Fakruzzaman, 61, and

Khandakar Golam Rabbani, 63. Of the eight, Sattar, Fakruzzaman and Rabbani are fugitives, while the rest including Hannan were arrested on October 1 last year and are now behind bars.

Hannan and the four other detainees denied the allegations.

ALLEGED ROLE OF HANNAN AND OTHERS

In May last year, Rahima Khatun, widow of martyred freedom fighter Abdur Rahman of Trishal, filed a case against three people, including Hannan, for killing her husband in 1971. The two other accused in the case were Fakruzzaman and Rabbani.

After recording the complaint, a Mymensingh court sent the case to the International Crimes Tribunal in Dhaka for necessary action. Based on Rahima's case, the investigation agency started a probe in

July last year, insiders said.

Apart from the three, the investigators found evidence of involvement of another five people in the wartime crimes, they added. Sanaul Huq, agency's co-coordinator,

said Hannan was a top leader of Mymensingh Muslim League, a party which had taken a stance against Bangladesh's liberation, and general secretary of Mymensingh Peace Committee, an antiliberation organisation in 1971. When people were fighting the Pakistan

army and their local collaborators, Hannan took part in a so-called by-elections held in 1971 and became a member of the national assembly of Pakistan, he said. Sanaul further said Hannan and his son

equipped with arms used to travel in a Pakistan-flag mounted open jeep during the war and "killed many people." Even the house of Hannan in

Mymensingh was used as an arsenal for Razakars, an auxiliary force of the Pakistan army, he said, adding that the other accused of the case were Hannan's "close aides" in 1971 who committed the crimes. The senior investigator said Hannan

regularly visited the torture camps set up at Mymensingh District Council Rest House and East Pakistan Agricultural University, which later been turned into Bangladesh Agricultural University campus, during the war and used to issue instructions for the "annihilation" of proliberation people detained there.

After the war, Hannan fled but resumed his political career after joining HM Ershad's Jatiya Party in the 1980s, he said.




