Plans Rural Electrification Board

Bangladesh Rural Electrification Board (REB) has targeted 2018 as the year to bring 90 percent people under its electricity coverage to supplement the government's ongoing development process.

The REB brought 1,56,25,000 consumers under its power supply network and provided new connections to 1,59,000 till June this year through its 78 Palli Bidyut Samity across the country over the last 38 years of its service, according to REB sources.

"The government is pledge-bound to make 'Digital Bangladesh' by ensuring access to power for all by 2021," Sate Minister for Power, Energy and Mineral Resources Nasrul Hamid told the news agency yesterday. He said the government has under-

taken projects to construct transmission lines, enhance its capabilities, reduce hassle and bring more rural people under the coverage. "Currently 76 percent people are enjoying electricity...," he said. He said the government has a plan to increase power generation capacity to 24,000 megawatt in 2021 and 40,000MW in 2030.

Director General of Power Cell Engineer Mohammad Hossain said the power generation capacity is now over 14,500MW including captive power.

The REB sources said the government is planning to expand rural electrification coverage providing some 25 lakh new connections in the rural areas.

## SC okays removal of factory from Dhaleshwari

The Supreme Court yesterday upheld a High Court order that asked the government to remove Deen Furniture's factory from Dhaleshwari river area in Keraniganj.

A four-member bench of the Appellate Division of the SC headed by Chief Justice Surendra Kumar Sinha dismissed an appeal filed by Deen Furniture's owner Shamsul Haque challenging the HC order. Following a petition filed by Human

Rights and Peace for Bangladesh, the HC on May 25 asked the Bangladesh Inland Water Transport Authority chairman to take steps to remove the factory built within the territory of the Dhaleshwari river area at Char Golgolia in Keraniganj in 30 days.

The petitioner's lawyer Manzill Murshid told The Daily Star that the factory was built within the territory in violation of environment protection law, water bodies law and relevant provision of the constitution.

# Farmers to get prepaid Tribunal seeks cards for irrigation

The government has launched a project to introduce prepaid metre system in Muhuri Irrigation Project, one of the country's important projects in Feni, to help farmers get water for irrigation using cards.

Bangladesh Water Development Board (BWDB) has started the work under the Irrigation Management Improvement Project (IMIP) with financial support from the Asian Development Bank (ADB), BWDB executive engineer (Feni O&M Division) Md Kohinoor Alam told the news agency during its recent visit to

the Muhuri project.

the project area and farmers will be able to use prepaid cards to get water for irrigation during the dry season, which will cut their irrigation cost, he said. Muhuri Irrigation Project, launched

in 1977-78 and completed in 1985-86, depends on the waters of Feni, Muhuri and Milunia rivers. Md Jahir Uddin, sub-divisional

engineer of BWDB, said the IMIP will rehabilitate water infrastructures of the project for 60,258 hectares of the areas.

He said the rehabilitation of water infrastructure will ensure sustainable operation and management of the project. BWDB extension overseer

Humayun Kabir said the prepaid The Tk 457 crore IMIP will install system will help farmers cut expenses

around 800 metres of water pumps in in irrigation significantly. "Now framers spend Tk 4,000 to Tk 4,500 for water supply on one acre of land. If the prepaid metre system is introduced, the cost will be Tk 2,000 to Tk 2,500 per acre," he added.

About 427 canals will be reexcavated to bring 17,000 hectares of land under irrigation of the prepaid metre system, Kabir said, adding that the new scheme will benefit about 8,000 families in the region.

The IMIP for the Muhuri Irrigation Project is expected to be concluded by 2019. BWDB officials said about 2,000 hectares of arable land will be brought under the prepaid irrigation scheme by next year through installing 81 pumps with prepaid metres.

International Crimes Tribunal-1 yesterday directed the prosecution to submit on September 20 the formal charges, if there were any, in a case against Jatiya Party lawmaker MA Hannan, his son and six others over crimes they allegedly committed during the 1971 Liberation War.

Moreover, the prosecution completed placing closing arguments on factual aspects in a case against nine

former Jamaat-e-Islami and BNP lawmaker Shakhawat Hossain, who are facing five charges of similar crimes.

Jessore men, including

The three-member tribunal led by Justice Anwarul Haque fixed AL lawmaker from the district. the date after prosecutor Sultan Mahmud Simon sought two months to prepare and submit the formal charges.

Chief Prosecutor Office received the probe report and other documents on Monday, said Sultan.

The accused are Hannan, 80, lawmaker from Trishal (Mymensingh-7) and also a presidium member of Jatiya Party; his son Rafique Sajjad, 62; Khandakar Golam Sabbir Ahmed, 69, Mizanur Rahman Mintu, 63, Hormuj Ali, 73, Mohammad Abdus Sattar, 64, Mohammad Fakruzzaman, 61, and Khandakar Golam

Rabbani, 63. Sattar, Fakruzzaman and Rabbani are fugitives while the rest behind bars.

The tribunal's investigation agency on Monday said Hannan, his son and six of his associates had direct links with three torture camps set up in Mymensingh and were involved in at least five incidents of crimes.

The charges are over the abduction, torture and killing of sculptor Abdur Rashid of Purohitpara in Mymensingh on April 23 and 24; killing of Jatish Chandra Chakraborty Sentu of Bolar Hindupara in Trishal on August 2, injuring two others and torching of houses of Hindus; abduction, torture and killing of Abdur Rahman of Boiral Munshipara in Trishal between August 7 and 9; abduction, torture and killing of Khandakar Abdul Ali Ratan of Jail Road area in

Mymensingh between November 17 and December 7; and abduction and torture of Abed Hossain Khan of Natun Bazar in Mymensingh and KM Khalid Babu, a former


Defence counsel Abdus Sattar Palwan afterwards started placing his arguments before the tribunal adjourned proceedings until today.
