ARSON CASE

Court to decide on charges against Khaleda August 10

A Dhaka court yesterday fixed August 10 to decide whether

the charges brought against BNP Chairperson Khaleda Zia and 26 leaders and activists of the BNP-led 20party alliance in three arson cases will be accepted.

Judge Kamrul Hossain Mollah of the Metropolitan Sessions Judge's Court set the date.

All the three cases were filed with Darussalam Police Station for the attacks during the alliance's countywide blockade last

In the first case, it was alleged that as per the BNP chief's directives, BNP leaders and activists torched a minibus in the capital's Shah Ali Mazar area on February 4 last year.

On May 11, police pressed charges against Khaleda and 23 others.

In the second case, it was mentioned that as per her directives, a passenger bus was torched by a group of the BNP-led 20-party alliance on February 14 last year in Darussalam area.

Khaleda and 26 others were charged for the arson attack on May 30.

In the third case, it was alleged that on the BNP chief's instructions, BNPled 20-party activists set fire to a minibus at Gabtoli on March 3 last year. Khaleda and 27 others were charged for arson attack on May 11. SEE PAGE 11 COL 6

WAR CRIMES CASE AGAINST 3 MOULVIBAZAR MEN

ICT seeks probe report Records defence's closing arguments in case against 9 of Jessore

STAFF CORRESPONDENT

International Crimes Tribunal-1 yesterday asked the prosecution to submit on September 27 the investigation report, if there were any, in a case filed against three Moulvibazar men who allegedly committed crimes during the 1971 Liberation War. Moreover, the tribunal for the second day

recorded the defence's closing arguments in a case against nine Jessore men, including former Jamaate-Islami and BNP lawmaker Shakhawat Hossain, who are facing five charges of war-time crimes. Yesterday was fixed for the Moulvibazar report's

submission. Prosecutor Sabina Yesmin Khan Munni sought two months to complete the investigation and the thee-member tribunal led by Justice Anwarul Haque granted it.

The accused are Abdul Aziz alias Habul, Abdul Mannan, and Abdul Matin, of Barlekha upazila of Moulvibazar. Of the three, Aziz and Mannan are now in jail while Matin is on the run.

According to the case's investigation officer Shahjahan Kabir, the accused were involved with Razakar Bahini, an auxiliary force of the Pakistani occupation army. He has already got evidence over their involve-

ment in at least two incidents of crimes involving rape, arson and torture in Barlekha upazila, Shahjahan told The Daily Star earlier. JESSORE CASE

Defence counsels Abdus Sattar Palwan and Abdus Shukur Khan placed their arguments and claimed that the prosecution failed to prove the charges. The tribunal adjourned proceedings until today. All the accused are from Keshobpur upazila.

Shakhawat, now involved in Jatiya Party's politics, and Billal Hossain Biswas are in jail and Lutfar Morol died of old age complications on May 6.

The rest, Ibrahim Hossain, Sheikh Md Mujibur Rahman, Kazi Ohidul Islam, Aziz Sardar, Aziz Sardar, Lutfar Morol, and Abdul Khaleq Morol, are on the run.

Security beefed up at Ctg airport

Security at Chittagong Shah Amanat International Airport has been tightened after the recent militant attacks in the capital's Gulshan and Sholakia in Kishoreganj.

Contacted, Airport Manager Wing Commander Reazul Kabir told The Daily Star that the number of security personnel and check posts had been increased and all the airport officials were instructed to be cautious.

He, however, said there was no specific threat to the airport. "We have strengthened the security after analysing the overall threat and present situation...," he added.

Contacted, Arefin Jewel, additional deputy commissioner (immigration) of Chittagong Metropolitan Police, said, "There were 200 on duty armed police battalion personnel in the airport but now the number has been increased to 300. Number of check posts has been increased from 11 to 14."

ENDING VIOLENCE AGAINST CHILDREN

New strategies launched

BSS, Dhaka

The World Health Organization (WHO) and partners together launched new strategies to end violence against children globally as the approaches shown concrete results in their field test.

WHO hopes that the seven interlinked strategies will

dramatically reduce instances of violence against children globally, says a press release. Up to 100 crore children experienced physical, sexual or

psychological violence in the last one year, according to a recent study published in pediatrics, that says homicide was among the top five causes of death for adolescents. It says one in four children suffers physical abuse, and

nearly one in five girls is sexually abused at least once in their lives. "Knowledge about the extent and harms of violence against children is growing, together with evidence about effective strategies for prevention," noted Dr Etienne Krug,

director of WHO. "Now we need to build on that knowledge to work collectively to create the safe, stable, and nurturing environments that protect children and adolescents from violent harm," Dr Krug added.
