Mother of Mizanur, Jahanara Begum, said, "Police tortured my son and sent him to jail illegally."

"I am also facing a false case of attacking police," said Mizanur Rahman.

Rain spoils aman seedbeds in 3 coastal districts

Heavy rain damaged aman seedbeds on 1200 hectares of land in three coastal districts Patuakhali, Barguna and Pirojpur.

Our Patuakhali correspondent reported that continuous rainfall destroyed seedbeds on nearly 1000 hectares of land in different upazilas of Patuakhali and Barguna districts.

Farmers in the area are getting frustrated as Aman is the main crop in these areas.

Mahfuzur Rahman, upazila agriculture officer in Rangabali of Patuakhali, said Department of Agriculture Extension (DAE) set a target to cultivate aman paddy on 36,000 hectares of land and prepared seedbeds on 500 hectares this year. Of the land, seedbeds on 100

hectares are totally rotten. He also suggested the farmers to

prepare new seedbeds for the purpose. In the beginning of the season

farmers prepared seedbeds but the

seedlings got affected due to heavy rainfall for the last two weeks. In Barguna district, about 500 hectares of aman seedbeds in 42 vil-

lages under Amtali and Taltali upazilas were spoiled due to water logging caused by the incessant rainfall. Rustam Ali, a farmer of Godanga

village in Amtali upazila said he prepared seedbeds on 50 decimals of land but all his saplings were ruined as it is under knee deep water for the last two weeks.

Nizam Uddin of Chaulapara village in Taltali upazila said it will be difficult for the farmers to prepare new seedbeds in a short time.

Away in Pirojpur, aman saplings on about 200 hectares of land in different upazilas of the district were damaged as rain water inundated seedbeds. Upazila agriculture office sources

said to recover the losses, a number of farmers have started to prepare new seedbeds. Nirmal Kanti, a farmer of

Sikdermallik village in Sadar upazila, said he will have to prepare seedbeds again as all his saplings have already been damaged due to excessive rain and tidal water.

DAE set a target to cultivate aman on 65,200 hectares of land and prepared seedbeds of 4,900 hectares of land.

Abul Hossain Talukder, deputy director of DAE in Pirojpur, said they have suggested the farmers to use fertilizer to save their damaged saplings from rotting.

Sale halted after unusual purchase for 2 days

Brickfield operators allege huge amount of coal went to a syndicate

Authorities of Barapukuria Coal Mining Company Ltd (BCMCL) temporarily suspended sale of coal from Wednesday after 60,000 tonnes were sold within 48 hours (Monday and Tuesday) following a rumour of a rise in the price of coal.

The mine sells around 4,000 tonnes of coal every day, which has gone up to 30,000 tonnes in the last two days.

Mine authorities informed the coal buyers about the suspension through a notice issued yesterday.

Brickfield operators, who each. mostly use coal as their primary fuel for baking bricks, alleged on men by paying higher price.

"All the coal goes to the local syndicated group," said tonnes. Ashraful Alam, a brickfield operator in Panchbibi upazila of Joypurhat. He said

the decision of suspension was taken when the brickfield operators are preparing for the next season.

Hearing about the sudden rise in the sale of coal, hundreds of brickfield operators of Dinajpur and surrounding districts gathered at the coalmine area in Parbatipur upazila of Dinajpur to buy coal for the coming season.




Judge SM Ahsanul Haque of the Additional Chief Judicial Magistrate's Court granted seven
