14 Brief description of the services/assignments
Terms of Reference (TOR) for Digitization of BBS Publications and Online Secondary Data Collection:
The Government of the People's Republic of Bangladesh has mandated Bangladesh Bureau of Statistics (BBS) as the 'National Statistical Organization (NSO)' to produce national statistics through various surveys and censuses for formulating evidence-based planning and policy decision. It has been regulated by the 'Statistics Act 2013'. Meanwhile, BBS has already been conducted several surveys and censuses since independence. But, there is a limitation of the web based soft copy of the previous survey and census results/publications due to lack of proper digital preservation methods. For this reason, the stakeholders don't have easy access to the previous BBS publications or reports. On the other hand, BBS has to collect secondary data from several institutions to produce national statistics. Currently, most of the secondary data are collected manually which is basically time consuming, expensive and old fashioned.
Considering the abovementioned issues, the BBS authority has taken the initiative to digitize all the publications by BBS since independence and to establish retrievable systems for all previous, current and future publications with the facility of searching Optimization (Like Google). Moreover, BBS has planned to develop online data collection system to collect secondary data from various institutions on a regular basis to generate monthly and other related publications/reports automatically.

MBA Admission Test (2015-2016) of Institute of Business Administration (IBA), University of Dhaka, will be held on Friday, July 22, 2016 at 10:00 am.

For all other foreign certificates/degrees, equivalence is determined by the Equivalence Committee of IBA. Without such equivalence, the applicants are not allowed to sit for the admission test.

ELIGIBILITY

Applicants must have at least a Bachelor Degree in any field of study. The minimum qualifying point is seven (07) for all applicants. The points are calculated as follows:

* Letter grades of O-Level and A-Level subjects are converted into grade points as follows: A = 4, B = 3, C = 2 and D = 1. Grade Point Average (GPA) is calculated by averaging the grade points of the best five grades for O-Level and the best two grades for A-Level.

Candidates with third division or GPA of less than 2.5 in SSC or HSC or GPA of less than 2.5 in O-Level or less than 2.0 in A-Level examinations will not be eligible for application.

Applicants who have taken O-Level examinations must pass at least five (05) subjects (including mathematics) with a minimum of grade D in each of the subjects.

Applicants who have taken the A-Level examinations must pass at least two (02) subjects with a minimum of grade D in each of the subjects.

An applicant with foreign nationality with minimum 75 percentile in GMAT may be exempted from the written assessment. However, he/she will be required to appear at an interview.
