Ex-LGED official lands in jail

A court here sent a former government official to jail, rejecting his bail prayer in a case for embezzling government fund. On June 15 in 2014, Anti-Corruption Commission (ACC) in Kushtia filed the case against Safayet Hossain, the then chief accountant of Local Government Engineering Department (LGED) in the district. According to the case statement, Safayet withdrew Tk 17 lakh from an account of LGED by forging signature of its chief engineer on October 20, 1998. Later, a departmental case was filed against him in 2000. The accused then challenged the case by filing a writ with the High Court (HC). On April 13 in 2013, a HC bench rejected the writ.

Chased, drug peddler dies

Following a 'chase by police', an alleged drug peddler died after hitting a lamppost in Goyra Bazar area under Sharsha upazila of Jessore on Sunday. The deceased is Abdul Khalek, 50, son of Abdul Malek of Kaiba village. Family members said Khalek hit a lamppost while trying to escape during a chase by police at night and died on the spot. OC Md Moniruzzaman of Sharsha Police Station said on secret information, a police team raided the area and arrested Mazed and Laltu with 100 bottles of phensidyl. Sensing presence of the law enforcers, drug peddler Khalek tried to flee the scene and died from heart attack.

Four kids drowned in Lalmonirhat, Jessore and Tangail districts yesterday. Hira Moni Akhter, 8, and Himu Moni Akhter, 5, daughters of Habibur Rahman of Lalmonirhat, drowned in a pond. In Jessore, Hridoy Ahmed, 8, son of Julhas in the town, drowned in a hole filled with water. Rakib Hossain, 12, of Chakleshwar village, went to take bath in the River Bonsai in Mirzapur upazila of Tangail on Sunday and went missing. The following day, firefighters recovered the body.

Lalmonirhat floods worsen further

Jamuna devours 500 houses in Manikganj

With the surge of floodwater from upstream in Teesta and Dharla rivers, the flood situation in Lalmonirhat has worsened. Meanwhile, due to the onrush of

water in the Jamuna, around 500 homesteads have been washed away by erosion in Manikganj. In Lalmonirhat, the flood situa-

tion worsened yesterday as the water level was rising in the Teesta and Dharla rivers. Many fresh areas were flooded yesterday due to onrushing water from India in the last few days. Officials of Water Development

Board (WDB) in Lalmonirhat said the flood situation at 80 villages in the Teesta and Dharla river basin areas worsened yesterday due to onrushing water from upstream. The Teesta River was flowing

above the danger level at Kawnia point and Dharla River was flowing only one centimeter below the danger mark at Kulaghat point at noon yesterday, WDB officials said. Over 50,000 people in 80 villages

of 16 unions under five upazilas in the district have been facing scarcity of food and pure drinking water, as the surrounding areas are submerged in three to four feet of water.

3,000 people of 600 families in the erosion. village under Mohishkhocha union were suffering due to increase of flood water in the last two days.

Mosaddek Hossain Chowdhury, chairman of Mohishkhocha UP, said Gobordhan, Balapara and Kutirpar villages of his union were badly affected by the flood water, adding that he has requested the administration for relief materials.

"We have been passing our days taking dry food like chira, gur, muri and bread as we can't cook due to the flood water in our houses," said Ayesha Begum, 45, of Bagdora village in Lalmonirhat Sadar. They are suffering due to shortage of pure drinking water as the tube-wells have gone under flood water.

In Manikganj, due to the erosion by the river Jamuna, around 500 homesteads in eight villages of two unions under Daulatpur upazila were washed away by the Jamuna in the last two weeks.

The villages are Chuadanga, Jelepara, Charbanga, Uttarkhanda, Sheikhpara and Subuddia under Bachamara union, and Kathaltoli, Lalpur, Beparipara, Bagpara and Mandalpara villages under Charkatari union.

During a visit to the villages of Bachamara union last week, this correspondent found that some families were going to safer places with their belongings.

Rokeya Begum of Charbanga village, who has been staying at Amena Khatun Girls' School with her family members for the last 14 days after her homestead was eroded, said she did not get any help from any government or non-government organisation.

Abdul Latif, chairman of Bachamara Union Parishad, said at least 300 families of Chuadanga, Jelepara, Charbanga, Uttarkhanda, Sheikhpara, Subuddia under the union were washed away into the river in the last couple of weeks. He did not get help from any government or non-government organisaion for the erosion affected families, he added.

The list of erosion victims was sent to the office of Mohammad Shafiur Rahman, upazila nirbahi officer of Daulatpur.

At least 100 families of Shredharnagar, Kushta and Mailagi villages under Sadar union of Ghior upazila lost their homesteads due to erosion by the Dhaleswari River in the last one month. Mailagi government shelter and Ghior-Daulatpur-Nagarpur road are now under threat.

Voter listing halted in 4 Nilphamari ex-enclaves

Complying with a High Court (HC) order the Election Commission (EC) on Sunday suspended voter registration and work for preparation of national identity cards in all four former enclaves under Nilphamari district. After the enclaves were

swapped in 2015, the four exenclaves--Boro Khanki, Boro Khanki Khariza Gidaldaha, Boro Khanki Khariza and Nagor Zikabari--once part of Mekliganj district in the India state of Pashchimbanga, were merged with Dimpla upazila of Nilphamari. The commission has started

voter listings in all former 111 Indian enclaves under Kurigram, Lalmonirhat, Panchagarh and Nilphamari districts from July 10. On December 3, 2016, the local government ministry

published a gazette (Annexure-

K-1) delimitating the areas

with surrounding unions under respective upazilas. According to the gazette, Boro Khanki (former chhit No-28) was merged with Gayabari union under

Dimla upazila. Challenging the gazette

Khagakharibari union parishad under the upazila, filed a writ petition to the HC bench of Bangladesh Supreme Court claiming the enclave as an integral part of his union which was mistakenly merged with adjacent Gayabari union in the gazette.

Ministry of local government, Nilphamari deputy commissioner (DC), Dimla upazila nirbahi officer (UNO) and chief election commissioner were made the respondents of the petition.

Responding to the petition, a HC bench comprising of Justice Syed Muhammad Dastagir Husain and Justice AKM Shahidul Huq issued a Rule Nisi on March 9 asking the respondents to show-cause why the relevant part of the gazette should not be declared as illegal.

The HC bench also issued a stay order on the relevant part of the gazette for three months which was later extended on May 25 for further six months.

After the listings started on July 10, Rabiul Islam sent a letter to the Election Commission informing them of the HC stay-order.

Villagers repair 2-km road thru' self-help

Taking spades and other tools from their homes, several hundred villagers of Boaldar union under Hakimpur upazila of the district joined hands for making a road suitable for vehicular movement as it turned from bad to worse with the beginning of the rainy season this year.

The 2-km long mud road from Chemgram to Bishapara connected at least 10,000 people of Chengram village to Hakimpur upazila headquarters.

During a visit there on Saturday, this correspondent found several hundred people equipped with spades working hard to repair the road. They started repair works on

Sajibul Karim, project implementation officer of Hakimpur upazila, claimed that there was no corruption in repairing the road. The repairing works is yet to be finished. They suspended the work for rain, he added.

One murdered, three injured

A man was murdered and three others were injured by opponents in Bhandaria upazila under the district on Sunday night.

The deceased is Phul Mia Khan, 40, son of Abdul Hamid Khan, and the injured are Emadul, 45, Md Shah Jahan, 50, and Abdul Jalil, 35, of Irki village in the upazila.

Around 9:30pm on Sunday, they were returning home from local Ikri Bazar when 15-20 men attacked them with sharp weapons in front of Board Primary School and hacked them, locals said.

Locals rushed in and the attackers left. Locals took the four victims to upazila health complex and from there Phul Mia, Emadul and Jalil were sent to Barisal Sher-e-Bangla Medical College Hospital after primary treatment. Phul Mia died on the way to Barisal around 1:00am yesterday.

Local leaders of Jatiya Party (JP-Manju) and Awami League exchanged blame for the incident.
