Combat militancy, ensure security

PM asks lawmakers, DCs

Prime Minister Sheikh Hasina yesterday asked her party lawmakers to form active anti-militancy committees in their respective constituencies to fight extremism and militancy.

"We will have to ensure people's security for the sake of continuation of the country's overall development," she told an emergency meeting of the Awami League Parliamentary Party (ALPP) at the Jatiya Sangsad Bhaban.

Earlier in the day, the PM asked all concerned, including the deputy commissioners of districts, to combat terrorism and militancy with their utmost efficiency, strength, merit and talent.

Hasina was addressing the inaugural session of the four-day Deputy Commissioners Conference 2016 at her office, reports UNB.

At the ALPP meeting, the premier directed MPs to form social resistance against terrorism and militancy so that the extremist forces cannot create any volatile situation in the country.

During the hour-long meeting, she asked the legislators to oversee whether the Khutba of Juma prayers were being of its plan to strengthen local governrecited in mosques across the country in line with suggestions made by Islamic

Foundation to create anti-militant sentiment among people.

She directed MPs to hold antimilitancy rallies, processions and carry out other activities in their constituencies to create awareness against militancy.

Lauding the law enforcement and intelligence agencies for their actions during the recent militant attacks, she said her government tackled all the law and order situations successfully.

'PREPARE FOR POLLS'

Hasina, also the AL president, advised party lawmakers to make preparation for the next general election. "Over two years of our govern-

ment's tenure have already passed. The next election will be held after around two-and-a-half years. You [lawmakers] will frequently visit your areas and oversee the government's ongoing development activities. You will also publicise the development and the government's successes among people," she said.



Went missing from Bogra a year ago

He is Rakibul Hasan Reagan of Bogra Sadar who, police claim, is a militant.

He sustained bullet injuries during the police operation in the early hours yesterday. Before being hit by bullets, he jumped from the building and broke his legs.

Police took him into their custody and he is now under treatment at Dhaka Medical College Hospital.

The 19-year-old claimed himself to be a member of Islamic State, the terror group that controls a large territory in Iraq and Syria, police and DMCH sources said.

The terror group took credit for many of the targeted attacks, including the July 1 Gulshan siege, in the country over the past three years, but the government insists IS has no organisational presence in

Bangladesh. Son of late businessman Rezaul Karim and Rokeya Akhter of Jamilnagar area of Bogra town, Rakibul left home on July 26 last year to attend classes at Retina Coaching Centre in

the town, said police and his mother. Retina is a medical coaching centre known to be run by Shibir, the student wing of Jamaat-e-Islami.

However, when he did not return home, his mother, a senior medical assistant at Bijrul Union Health Complex under Nandigram upazila of the district, filed a general diary the next day, seeking law enforcers' help to

According to the GD, Rakibul passed SSC from Karotoa Multimedia School and College in 2013 and HSC from Government Shah Sultan College in 2015.

The family looked for him in various places, finding his phone switched off, she said in the GD.

After his detention, when Rakibul said he was from Bogra, police took his mother and the father-in-law of his sister to the local police station to confirm his identity, which they did.

They were later released, Abul Bashar, officer-in-charge of Bogra Sadar Police Station, told The Daily

Talking to the BBC Bangla yesterday, his mother said: "My son can't take the path willingly unless he was brainwashed. My son can't take a wrong path willingly."

RAKIBUL: A COOK?

When he was taken to the DMCH around 3:00am yesterday, Rakibul initially said he cooked for the alleged militants, who were later killed in the raid, police and DMCH sources said.

When police questioned him further, he said they all belonged to IS, added the sources.

Police then asked him to "spell" IS. He then elaborated it, saying: "Islamic State."

MASUD AND SHIHAB IN JAIL

The three friends were students of Govt Shah Sultan College in Bogra,

For about one year, Shihab and his mother and sister lived in the house of Rakibul as tenants. Masud used to live in a mess in Swajankuri village of Bogra's

Bogra Sadar Police Station and also investigation officer of the GD filed by Rakibul's mother, told The Daily Star yesterday that during investigation, he came to know that the three had gone missing on the same day.

Later, they learnt that Masud Rana, of Keshalata village under Adamdighi upazila in Bogra, was arrested from Dhaka in connection with the killing of Assistant Sub-Inspector Ibrahim Mollah.

Ibrahim was stabbed to death in the capital's Gabtoli on October 22 last year. Masud had accompanied the alleged killer, Kamal, and was caught red-handed from the spot.

Law enforcers then told The Daily Star that Masud was a Shibir activist of Bogra's Adamdighi upazila.

Around noon, Dhaka Metropolitan Police Commissioner Asaduzzaman Mia said that militants killed in Kalyanpur and the gunmen who attacked the Gulshan café might belong to the same group.

It primarily appeared that the nine in Kalyanpur and the Gulshan café attackers might be members of the same group, the DMP commissioner said at a press briefing at the DMP headquarters in the capital. He said all nine militants are

between the age of 20 and 25 and most of them are from well-off families. "Most of them were well educated. They wore black panjabis and jeans ... all except one wore a pair of sneakers.'

"Their accents, attitude and dresses suggest that they are from elite class,"

Replying to a query, Asaduzzaman said they would be able to ascertain which organisation the nine militants belonged to after investigation.

The five Gulshan café attackers too had worn black robes and scarves and posed for photographs in front of an IS flag with guns. US-based Site Intelligence, which monitors jihadi activities, on July 2 posted the photos, saying the images were released by IS.

The five were also from well-off families and their ages were similar to Kalyanpur "militants".

In previous attacks, IS claimed responsibility for the attacks, according to the Site Intelligence. But the government and police maintained

"Storm 26" was launched at 5:51 am. The dead were in black outfits and red-white chequered scarves similar to the ones five Gulshan attackers were wearing in the IS photos posted by

SITE Intelligence Group. The black outfit and the scarf are often seen in pictures of IS militants in the media.

Islamic State's another recognisable symbol is its black and white flag adorned with Arabic lettering. Black cloths resembling the IS flag were also

found at the flat. Following the operation, an official of the DB's bomb disposal unit said the bodies were lying on the floor in pools of blood with some of them holding knives. Others had grenades

DMP boss Asaduzzaman Mia at the briefing said that after the gunfight, the joint force recovered 13 locally made grenades, around five kg gel, 19 detonators, four 7.62mm pistols, seven magazines of 7.62mm pistols, 22 bullets, three commando knives and 12 guerrilla knives and two black flags

OPERATION STORM 26 At 5:51am, around 50 members of Special Weapons and Tactics (SWAT) in combat gears launched the hourlong operation "Storm 26" assisted by

members of other agencies and units. One of the SWAT members said they faced strong resistance as one grenade after another was hurled at them. "We had a plan to catch the militants alive but could not as they kept throwing grenades at us."

He added that shells of bullets, grenades and firearms were scattered all over the floor.

go there, claimed Rahima. The family said they chose to stay in the building as the house rent was reasonable.

This building where nine suspected militants were killed during yesterday's standoff is known as "Jahaz [ship] Building" because of its appearance.

The six-storey building has four flats in each floor except for the ground floor which is used as a parking space.

A neighbour, who has been living in a nearby building for about 23 years, said the owner of the "Jahaz Building" used to rent out flats only to married people before.

Bachelor tenants started to move in to the flats some five to six years ago, added the neighbour.

The building, which had so many bachelors as tenants, was raided several times during the countrywide blockade enforced by the BNPled alliance last year, said another local, wishing not to be named. **BUILDING OWNER ARRESTED**

Police have arrested Momtaz

Parveen, owner of the building, and her son Mazharul Islam Jewel for not providing police with information about their tenants, said Deputy Commissioner (Mirpur division) Masud Ahmed. However, before his arrest, Jewel

told reporters that he had asked all his tenants to provide him with their information which they did not do.
