Police arrested three suspects and learnt from them that their nine accomplices managed to escape, it

The names of the nine suspects, including Shazad (Shezad as mentioned in the document), Nibras Islam and Tawsif Hossain, were mentioned as suspects without addresses.

SM Raisul Islam, investigation officer of the case, told this newspaper yesterday that Ahmed Shammur Raihan alias Chiller, 23, was one of the three arrestees. During interrogation, he told police that Shazad was his cousin.

Shammur is out on bail since April 19. Raisul said according to the information they had gathered, Nibras and Tawsif studied at Monash University in Malaysia and were

friends. Nibras and Tawsif went missing from Dhaka on February 3. Tawsif's father Ajmal Hossain filed a general diary with Dhanmondi Police Station on that day, the police officer added.

About a media report that Nibras, Tawsif and Shazad were friends, Raisul said, "I also learnt it from the media but I am not sure about it." FATHER TRIES TO IDENTIFY BODY After seeing photographs of the bodies of suspects on social media and on a news portal run by Dhaka Metropolitan Police, Shazad's father Touhid contacted the DMP, Masudur Rahman, deputy commissioner (Me-

Change said on Tuesday that they had received the political clearance for the visit by an expert team to Bangladesh.

The chief wildlife warden of Assam is trying to get visa for members of the team.

Project Elephant director RK Srivastava told PTI that it was decided to send the rescue team to Bangladesh on August 3 for rescuing the animal but it would depend on factors like weather condition.

"The Project Elephant division of the ministry is constantly in touch with the Bangladesh forest department, chief wildlife wardens of Assam and Meghalaya and other relevant agencies to rescue the stranded elephant and bring it back to India," he said.

The Bangladesh forest department is constantly tracking the movement of the stranded elephant, the official said.

On June 27, it was reported that a wild female elephant was separated from its herd in Assam and floated along with the currents of the Brahmaputra river into Bangladesh.

In search of food, the pachyderm is now reportedly in conflict with villagers living in those regions.

"The elephant has reportedly become feeble due to lack of food so her rescue at the earliest is necessary to prevent further distress to her as well as the locals living in the region," Humane Society International, an animal rights NGO, had said in a statement recently.

The Bangladeshis reached Hazrat Shahjalal International Airport by a special US airline flight around 3:00am, said Kamal Uddin, 40, one of the returnees.

The US police interrogated them several times and contacted the Bangladesh embassy in Washington DC. All the Bangladeshis sought political asylum in the US, said Kamal, from Noakhali.

However, this correspondent could not communicate with the embassy for its comments.

The US courts held hearings to settle the issue and finally rejected their appeals and ordered them to be sent back home last year.

#### Kerry: US avoiding 'confrontation' in sea row

US Secretary of State John Kerry yesterday said Washington wanted to avoid "confrontation" in the South China Sea, after an international tribunal rejected Beijing's claims to

Kerry made the remarks after meeting with Philippine Foreign Secretary Perfecto Yasay in Manila where they discussed the Southeast Asian nation's sweeping victory in the arbitration case against China.

America's top diplomat said the United States wanted China and the Philippines to engage in talks and "confidence-building measures". "The decision itself is a binding

decision but we're not trying to create a confrontation. We are trying to create a solution mindful of the rights of people established under the law," Kerry said. A tribunal based in The Hague this

month ruled that China's claim to most of the strategic waterway was inconsistent with international law. The decision angered Beijing, which vowed to ignore the ruling. But Kerry said the United States

saw an "opportunity" for claimants to peacefully resolve the row. "We hope to see a process that will

narrow the geographic scope of the maritime disputes, set standards for behaviour in contested areas, lead to mutually acceptable solutions, perhaps even a series of confidencebuilding steps," he said. Vietnam, Malaysia, Brunei and Taiwan also have claims to the South

China Sea, a vital waterway through which \$5 trillion in annual trade passes. It is also believed to sit atop vast reserves of oil and gas. Kerry, who arrived in Manila on

Tuesday after attending a regional summit in Laos, met with new Philippine President Rodrigo Duterte.
