Keep watch on educational institutions

Education minister asks DCs to prevent students getting involved in militancy

Education Minister Nurul Islam Nahid yesterday called upon deputy commissioners to increase surveillance at all educational institutions across the country in order to prevent students from getting involved in militancy.

At the DC's meeting with the education ministry, Nahid said his ministry had already instructed all educational institutions to take measures for curbing militancy, and asked the executive magistrates to help implement the

In reply, the DCs said they were aware of the government directives and that they would extend all-out support to curbing militancy and terrorism.

Following the closed-door meeting with the DCs on the second day of the four-day DC conference, the minister told the media what had been discussed.

Nahid told journalists that the DCs had already received directives from the prime minister and some other ministries. His ministry cautioned them against students' involvement in militancy.

Students constitute one third of the population, he said. The youths are being lured into militancy and "so we all have to be very cautious."

Emphasising the importance of the teachers' role, the minister said teachers should know their students properly and maintain communication with their parents.

"We asked the DCs to get involved in this issue."

A Dhaka court yesterday upheld a verdict of a lower court that had sentenced former officer-in-charge of Khilgaon Police Station Md Helal Uddin to three years' imprisonment for torturing a former Dhaka University student.

Judge Md Zahidul Kabir of the Fifth Additional Metropolitan Sessions Judge's Court passed the order dismissing an appeal filed by Helal Uddin challenging the lower court verdict.

The court ordered the then OC within 30 days to surrender before the lower court that had sentenced him to three years' imprisonment for his involvement

IS bomb attack kills 44 in Syria

A massive bomb blast claimed by the Islamic State group killed at least 44 people and wounded dozens yesterday in the Kurdish-majority Syrian city of Qamishli. It was the largest and deadliest attack to hit the city since the beginning of Syria's conflict in March 2011.

Syrian state media gave a toll of 44 dead and 140 injured in the bombing, which hit a western district of the city where several local Kurdish ministries

are located. The Britain-based Syrian Observatory for Human Rights monitor gave a toll of 48 dead, adding that children and women were among those killed. Kurdish officials said the attack was carried out by a suicide bomber

driving an explosives-laden truck. The blast was initially described as a double bombing, but local officials and the Observatory said the bomb had detonated a nearby fuel container,

leading to reports of a second explosion. An AFP journalist saw devastating scenes in the bomb's aftermath, with distraught civilians, some covered in blood, staggering through rubble past

twisted metal and the burned-out remains of cars. One man running along the streets was completely covered in blood, his shirt drenched red.

He was gripping the arm of a small boy whose face was grey and red with blood and dust.

They ran past a hysterical woman who was crying and screaming, her clothes torn. A girl and boy stood next to her, apparently in shock.

49 back home from US

Deported for illegal stay

Forty-nine Bangladeshis were deported yesterday for their illegal entry into the US. They had left Bangladesh for the US without having proper knowledge about their journey to the United States of America.

Thinking the USA as a better option to earn more and bring solvency to their families, the Bangladeshis took risk of their lives and reached their destination after travelling through 10 to 12 other countries.

They used air, water and land routes in their long journey. They travelled through the UAE, Bolivia, Brazil, Venezuela, Ecuador, Columbia, Panama, Costa Rica, Nicaragua, Honduras, Guatemala and Mexico and finally entered California in the US on different times.

Later, they were caught by the US immigration police and landed in jail. After serving different jail terms from one year to two years, they were finally deported yesterday.

Dhaka, Delhi to talk security cooperation

Home minister-level meeting today

Bangladesh and India are expected to discuss enhancing security cooperation, particularly in counterterror efforts, as home ministers Azaduzzaman Khan Kamal and Rajnath Singh hold talks in the Indian capital today.

Kamal arrived in New Delhi yesterday afternoon leading a high-level delegation that also includes Home Secretary Dr Md Mozammel Haque Khan and Inspector General of Police AKM Shahidul Huq on a four-day visit for the fourth home minister-level talks between the two countries.

"The talks are expected to further strengthen and enhance the excellent cooperation between the two countries on security and border management matters," an official statement said yesterday. The ministerial-level

talks will be held from 4:00pm to 6:00pm.

According to official sources, a key aspect of the talks will be how to increase coordination between security agencies of the two countries in tackling terror, particularly in the backdrop of the recent ghastly attacks in Dhaka and Sholakia on July 1 and 7 respectively.

Ahead of today's talks, Shahidul Huq yesterday had a packed schedule visiting the headquarters of several Indian security agencies --SEE PAGE 13 COL 6
