### 4 held with arms, bullets in 2 districts

Four people were held with arms, bullets and drugs in Chapainawabganj and Jessore districts in the last two days.

Rapid Action Battalion (Rab) in separate drives arrested two drug peddlers and an arms trader in Sadar and Shibganj upazilas of Chapainawabganj yesterday and the day before.

They also seized a pistol, two magazines, four bullets, 28 bottles of foreign liquor and 183 Yaba tablets from their possession, reports our correspondent.

The arrestees are arms trader Imam Hossain, 25, of Namo Jagonnathpur village in Shibganj upazila, and drugs peddlers Harun ur Rashid, 48, and Rubel Ahmed, 21, of Mora Pagla village in Sadar upazila. They were handed over to

### Lightning kills 2 in Rangpur

Two people were killed and three others injured by lightning in Pirganj upazila of Rangpur yesterday morning.

The deceased, Sumon Mia, 25, son of Mofazzal Hossain, and Abdur Razzak, 30, son of Abdul Matin, were residents of Arifpur village in the upazila.

Locals and witnesses said a thunderbolt struck five people while they were working in paddy field at the village around 9:00am, leaving them seriously injured.

Later, they were rushed to Pirganj Upazila Health Complex where the doctors declared the duo dead, Officer-in-Charge Rezaul Karim of Pirganj Police Station said.

# Boat only transport for 90 Sunamganj villages

Familiar to generations of Bangladeshi school-goers, 'A Journey by Boat' is a common passage and essay topic. But in Sunamganj these days it's more than an abstract lesson. In around 90 villages of 3 upazilas, for students and the community at large, boat is currently the only means of transport.

As a result of the rainy season and perilous flooding, boats have been selling like hot cakes in Sunamganj over the past few weeks, and not all are especially seaworthy. Yet, anticipating that floodwaters will not recede any time soon, boats are popular.

"We can't use the Nabinagar -Sunamganj Road," says rickshaw puller Munim Ali from Nabinagar village in sadar upazila. "It's been devoured by the river. We have to travel by boat."

"We haven't been able to attend class for six days," says Class VIII student Sohag Islam, of Elahi Box High School in Tahirpur upazila, "because our school is across the river and it's difficult to cross."

Surma River boatman Mojnu

meanwhile says he and his colleagues are reaping good profits due to high water levels. "When water is low we lose money," he says. But customers are not pleased.

"We are forced to pay hiked boat fares," complains one passenger, Mobrul Hosain from Tahirpur upazila. "We have no alternative to reach Sunamganj town."

Another passenger agrees. "The boatmen often misbehave if anyone refuses to pay their increased fares," says Sirazul Islam from Doarabazar upazila. "I have used this route regularly for the last 3 years but even I do not escape harassment for higher ticket Sajal Rozirio. prices."

But there is no alternative, he adds.

According to Sirazul, some villagers are calling for the establishment of a government sponsored boat service until the water recedes, but there has been no response from the government.

Doarabazar upazila chairman upazila have been forced to rely on boats as transport for the past week or so. "Anybody going to office,

school or college or for business purpose must use a boat," he says, "If government sponsored services were available fares could be kept in check to the benefit of locals."

The upazila nirbahi officer of Tahirpur upazila, Mohammad Khaledur Rahman says such a government sponsored initiative isn't easy to implement but if locals demand it the administration must take action. The cost of inflated fares is

particularly onerous on the poor, who previously travelled on foot. "To reach Sunamganj sadar from Doarabazar town now costs at least Tk 100," says NGO staffer

For some who cannot afford such "luxury" the only option is to choose makeshift vessels made from bamboo sticks or banana

Many locals also blame the Water Development Board for the crisis, alleging it has not taken any action to reduce or control the floodwaters. The board's deputy M Idris Ali says 5 unions in the divisional engineer Dipok Kumar Das says a lack of funds is impeding their efforts to take effective flood control measures.

But he hoped the situation would improve if the government allocates funds for the purpose. Barrister Enamul Haque Imon

who works for the Sunamganj district administration says, however, that higher authorities have been informed about the issue. He further alleges that the Water Development Board's inaction has less to do with a lack of funds and more to do with fund mismanagement and corruption. Perhaps along with the poor

those who suffer the most are students. According to district primary education officer in Sunamganj, Hazrat Ali, during a recent field visit he observed most students only had the option of boat if they wanted to attend class.

"The Jadukata, Cholti, Surma Rivers and Tanguar Haor continue to swell," he says. "It's really risky for students since most of the boats that carry them are not at all seaworthy vessels."

For now the students and general public of Sunamgani are learning a new lesson: while in the textbook 'A Journey by Boat' might be a curiosity, in reality it's all too often burdensome.

#### Housewife killed for dowry

A housewife was killed allegedly by her husband for dowry at Ichhapur village in Chowgachha upazila of Jessore district on Wednesday. The deceased was identified as Sonia Akhter, 27, wife of Touhidur Rahman of the village. Police and family sources said Touhidur often tortured Sonia for Tk 20,000 since their marriage. He beat her mercilessly, leaving her dead on the spot, following an altercation over the issue on Wednesday night. Locals caught Touhidur and handed over him to police. The body was sent to Jessore Medical College Hospital morgue for autopsy, said M Mashiur Rahman, officer-in-charge of Chowgachha Police Station.

for brainwashing."

Terming the recruiters "good psychologists", the DMP official said they do not approach a boy and ask him to join jihad at the outset. Rather, they observe him, collect his information and then approach him.

He added that the "motivators" also target youths from impoverished families and give them financial assistance.

"They have a huge supply of cash ... The poor boy is not only motivated by the promise of heaven after death but also given financial incentives," said the top police official.

Talking about seven of the nine militants identified on Wednesday, he said two were students of North South University, while another one graduated from there; three were madrasa students and another one was barely educated.

He informed that all the militants left their homes in the last four months to two years.

"We contacted many of their families who admitted that they [militants] did not keep in touch with them. Some had very little contact but none of their families had any specific phone number or address," Monirul said. The process of silent

radicalisation and brainwashing begins well before they leave home, Monirul explained. "They leave home at the final stage."

He also talked about some writings by militants seized by police, and some information gleaned from arrested militants.

"The writings say 'when you are caught by law enforcers, imagine that you are a dead body. You are not in your senses. Even if they apply third degree method on

you, imagine that you have no senses," Monirul said.

Distorted ideologies and interpretations of religion and verses of the holy Quran and Hadith taken out of context are used in brainwashing the boys to such a point that they lose all ratio-

"(If) a murtad or kafir is standing in front of you, kill him. You will go to heaven if you kill him," Monirul quoted the writings.

When the new recruits are at the primary stage of being brainwashed, they do not live together. They meet each other when they have reached the final stage. By that time they forget everything of whatever background they are from, the DMP official

"After a prolonged training and brainwashing, the differences between those from madrasa and those from North South disappear. They are only driven by blood thirst. Monirul added that the

statement of a case filed in connection with the Kalyanpur incident mentioned some names of persons who provided militants with finance, arms, and shelter. "Police also found some

documents, but the militants destroyed two of their laptops, burnt the cash and some documents," he said.

"But we got hold of some documents from which we identified some militants. We are trying to catch them and bring them to book."

Monirul opined that until the masterminds and trainers are brought to book, they would keep recruiting new boys.
