Suspected JMB men blasted bombs simultaneously in Chittagong, Chandpur and Laxmipur courts on October 3, 2005, killing two people and injuring 34 others.

Yesterday, the HC bench of Justice M Enayetur Rahim and Justice JBM Hassan came up with the verdict after hearing the death references and appeals filed by the accused.

The grounds for the verdict could not be known as the full text of the judgment was not released.

Talking to The Daily Star, Deputy Attorney General Shaikh AKM Moniruzzaman Kabir said the government would move appeals before the Appellate Division of the Supreme Court challenging the portion of the HC verdict that commuted death sentences of two convicts and acquit-

ted two others of the charges. Helal Uddin Mollah, lawyer for death row convicts Saidur and Taibur, said his clients would file appeals with the SC after receiving the full text of the HC verdict.

The confessional statements of the two convicts were not true as those were not made voluntarily, he claimed.

Saifur Rashid Sabuj, lawyer for another death row convict Enayet Ullah, said the HC confirmed the death sentence of his client based on his confessional statement. Enayet did not make the confes-

sional statement voluntarily, Saifur told this correspondent, adding that there was not enough evidence against the accused. The lawyer said his client would

lodge an appeal against the HC ver-

On June 20, 2013, Judge Md Motahar Hossain of Speedy Trial Tribunal-4 of Dhaka had sentenced all the 10 accused to death. The accused later filed separate appeals with the HC challenging the trial court's verdict.

"He called me about a month ago and said he was working at a sweater factory and living at his aunt's house in Gazipur," Nasir said.

where humans had no part to play.

By then it was already clear outside and the boat crews had woken up. People on both sides of the river were on the move and a pond heron was out, looking for its morning snacks. The cook lit the stove to boil water as I returned to my place and flipped through the pages of my book. Coffee arrived and the boat sailed south taking advantage of the receding tide.

We entered the Sundarbans at midday -- the scorching sun at its peak and the wind not even blowing. The wall of vegetation on both sides of the river stood still.

The purpose of this trip was to find the most elusive bird called the Masked Finfoot that occurs in the Sundarbans in Bangladesh, a definite place in the world to find it with confidence. We have been studying this bird over the last five years in order to gather basic information on its ecology and biology that have never been fully studied before. Our aim is to understand and assess its population status in the Sundarbans, its threats, and hotspots to recommend conservation measures to the forest department and other interested parties.

Over the years, we have developed a method to observe the bird without disturbing it, which means the species accept your presence within the vicinity of its home. This allows developing a relationship with the species, which ultimately encourages the observer to speak on their

behalf. As the day slipped by, we travelled further south through the murky water of the Sundarbans. The monsoon sky changed its colour, the clouds changed their courses and the tide took its toll. At night with our

boat bathed in the moonlight, we stared at the stars, the moon and celestial bodies in the sky. There was no digital interference, no urge to attend calls, check emails or be absorbed in social media posts. We only communicated with our crew members, like a happy family.

As the search for the elusive bird continued the following days, our dingi would ride up and down the canals, with our tired bodies at times carrying nothing else but hope, enduring both the heat of July, and the monsoon rain of August. There were days when we came back with fuller spirits, having spotted Masked Finfoots foraging during low tide, and there were days when nothing, absolutely nothing was found, except for unravelling the other mysteries of the Sundarbans -- the common kingfishers, the calls of the Mangrove Pitta, the footprints of the spotted deer. We were overly delighted at finding an active nest once, as a beacon of our having overcome the shadows of uncertainties, dealing with the changes in the mighty tides, the mysterious jungle and our

fading confidence. Looking back at the last couple of summers and our quest in the Sundarbans, there are many memories that come to mind. Strangely, it's not the hardships that I see, but the positives and the unravelled mysteries -- the finding of the nest, the attachment to the Masked Finfoot families, the gradual understanding of their behaviour, and later, the steps to take to improve their condition. Like tigers in the Sundarbans, we want to raise the profile of the finfoots to help protect these mag-

Quoting Nayeem's relatives and locals, Gopalpur police said his father died when he was four. Later, his mother Halima Khatun left the village and went to his maternal grandfather's house in Jamalpur. Nayeem was then admitted to a madrasa there.

After completing education at the madrasa, he married his cousin Sakhina Khatun in 2000, according to police.

Kuakata as a day labourer at "Sagor Nir Project" of a real estate company and worked there till 2007, said Altaf Hossain, the then assistant manager of the project. "As far as I can recall, Nayeem was a pious man. He used to talk less and

The Daily Star correspondent visited Nayeem's father-in-law's house at Chapaid village in Madhupur upazila yesterday noon and found the house empty.

One of Nayeem's relatives said In 2003, he started working in Nayeem visited his house at Hironbazar village of Modhupur upazila around two months ago.

Contacted, Mahbub Alam, superintendent of police in Tangail, said law enforcers are yet to trace Nayeem's wife Sakina. "We are investigating the matter and

checking whether any of Nayeem's relatives or any other person in this area is involved in militancy," he added.
