The situation of Paturia and Daulatdia ferry terminals deteriorated as three more ferries went out of operation with engine problems yesterday.

Nine ferries out of 18 are in operation on Paturia-Daulatdia river route.

Due to disruption in ferry service, several hundred vehicles were seen stranded at Paturia in Manikganj and Daulatdia in Rajbari.

The passengers of 17 southern districts have been facing serious problems for the last 11 days.

Manager (commerce) of Bangladesh Inland Water Transport Corporation (BIWTC) at Daulatdia office Shafikul Islam said landing station No 3 is now under threat of erosion. The landing stations No 4 and 2 remained closed on Friday.

Ro Ro ferries -- Amanat Shah and Khanjahan Ali were sent to Narayangaj Dockyard on July 29 for repairing while Bir Shreshtha Hamidur Rahman, Bir Shreshtha Motiur Rahman and Shah Mokhdum -- were anchored at Paturia ghat as they cannot move against strong current of Padma, said Mohiuddin Rasel, manager of BIWTC at Aricha.

# Ex-Bangladesh enclave people in India lack basic needs

Many trying to return as they are still jobless

Some 14,000 people of former Bangladeshi enclaves are still deprived of basic civic amenities although they got Indian citizenship one year ago following the official exchange of adversely possessed lands between Bangladesh and India.

Meanwhile, many of the dwellers of former Indian enclaves inside Bangladesh, who had opted for shifting to India, are now trying to return to Bangladesh as they did not get any employment.

Talking to this correspondent during the last few days, enclave dwellers narrated their plight in the changing circumstances.

"Earlier we faced problems with our nationality. Now we are facing problems with livelihood and land. Despite the government's announcement for compensation, we did not get anything in last one year," said Saddam Hossain, a resident of Moshaldanga, a former Bangladeshi enclave.

India, is among 921 people who opted for going

to India after the enclave exchange deal.

"We are minority Muslims in this country. We celebrate the Eid festival after one month long Ramdan fasting. But we did not get even sugar or vermicelli from the government on the occasion of the Eid," he told this correspon-

"I was a resident of No 1 Chhoto Goral Jhora enclave under Bhurungamari in Kurigram district inside Bangladesh. I earned Tk 10,000 to Tk 15,000 a month by running a medicine shop there.

"I came to Hinhata camp in India on November 22 last year but did not get any work here till today," he said.

Ashwini Kumar Roy, a resident at Haldibari camp in Cooch Behar district under India, said he got nothing from the government except 30 kg of rice, 5 kg of lentil, 5 litres of edible oil, 7 litre of kerosene, one kg of salt and one packet of powder milk.

Roy, who was an HSC student in Bangladesh, crossed Indian border recently to participate in Osman Gani, a resident of Hinhata camp in the examinations. After staying inside Bangladesh for three months to sit for the exam-

inations, he returned to Indian camp.

Rajya Sabha member from West Bengal and CPI (M) leader Ritabrata Banerjee and Congress leader Pradip Bhattacharya recently became vocal in the Rajya Sabha following the allegations made by the residents of former enclaves.

"The union government did not keep its promises made to the 921 residents of former enclaves when they came to India. Many of them have returned to Bangladesh and some others are trying to go back as they did not get any work in West Bengal," Ritabrata Banerjee told The Daily Star.

Pradip Bhattacharya, former president of West Bengal chapter of Congress, said lack of coordination between the state government and the union government and corruption at local level are responsible for the plight of the residents of former enclaves.

Of the 921 people who came from Bangladesh, 486 people of 96 families of former Indian enclaves who came from Bangladesh have been staying at Haldibari camp, 245 of 58 families are living in Hinhata camp and the rest are living in Mekhliganj camp.

#### Tk 75 lakh sandalwood seized

### Woman gets life for murder

A court here yesterday sentenced a woman to life term imprisonment for killing her stepdaughter in 2010. The lifer is Morium Begum, 40, wife of Alamgir Hossain of Bishnukathi village in Nesarabad upazila. The court also fined her Tk 10,000. In default, she is to suffer another six months in jail. According to the prosecution, as Alamgir loved his seven-year-old daughter Afifa very much, Morium felt jealous of her. Over the issue, Morium drowned Afifa in a pond on June 23, 2010. The following day, Alamgir filed a case with Nesarabad Police Station, accusing Morium. After examining witnesses and evidence, District and Sessions Judge found her guilty and pronounced the verdict.

#### **Fratricide**

A man was killed allegedly by his brother over a disputed land at Joyda village in Muktagacha upazila yesterday. The victim is Akhter Ali, 55, son of late Abdul Haque of the village. Police and family sources said there was a longstanding conflict between Akhter and his younger brother Akbar Ali, 50, over the land. Akbar stabbed Akhter, leaving him dead on the spot following an altercation over the issue. Police later arrested Akbar from the spot.

#### Man held with phensidyl

Rapid Action Battalion (Rab) arrested a man with 1,930 bottles of Phensidyl in Chapainawabganj on Saturday. The arrestee is Ayub Ali, 45, son of late Bashir Uddin, of village Baipur under Nachol upazila of Chapainawabganj. Acting on a tip-off, the elite force raided Ayub's home at night and arrested him with the phensidyl, said ASP Arafat Hossain of Joypurhat Rab.

#### 2 drug peddlers jailed

A mobile court yesterday jailed two drug peddlers and fined another in Muktagacha upazila yesterday. The convicts are Delwar Hossain, 45, Shafiqul Islam, 24, and Monju Miah, 35. Of them, Delwar was sentenced to six months' imprisonment while Shafiqul to 15 days in prison. The court also fined Monju Tk 5,000. The three were arrested with hemp.

# Indigenous 'chambol' needs protection

In Mymensingh's Rasulpur Forest the monsoon months of Ashar and Shraban were once a time to ramble; on random expeditions in search of 'chambol', the fruit of the indigenous chapalish tree. The chambol, renowned for a taste of sweet and sour, has long been considered a delicacy.

Also called the "forest jackfruit" in Mymensingh and a relative of the breadfruit, chambols were once familiar to all; but nowadays they're rare.

As atocarpus chaplasha, the chapalish tree, is generous in giving not only tasty fruit but also in providing timber suitable for fashionable furniture, many were felled over the years, and snatched away from the forest. Yet still a few chapalish trees remain.

ripe chambols were a quintessential component of the lush and plentiful atmosphere donned by the forest to mark each monsoon. In Muktagachha the chambol was, for visitors, a special attraction.

One who is aware of the chambol's virtues is Dr. Md Abdur Rahim, director of the Germ Plasm Centre at the nearby Bangladesh Agricultural University. "The fruit which is now endangered has good nutritional value," he says. "The sweet and sour taste is attractive and the seeds can be used for cooking." In recognition of its attributes and rarity, the university has Shantoshpur Forest of Phulbari planted chapalish trees on its cam-

But beyond nutrition and taster, the chambol served a social good as well. In years gone by, struggling families found daily survival in collecting the wild fruit at this time of the year, for local market sale.

Until the 1990s the trees were in good number but thereafter their According to local memory, the prevalence declined, making vul-

nerable the tree's existence locally. Moreover, since the decline of the chapalish and other indige-

nous trees, several forest animals, once commonplace in Rasulpur and Shantoshpur, and in adjacent areas of Madhupur Forest in Tangail, have largely or entirely vanished. Gone are the tigers and leopards, the deer and bears. Indeed the number of avian species is also fewer than before.

With indiscriminate logging the food supply for many species of fauna has dwindled. Even the hundreds of monkeys in upazila are nowadays hungry, a situation that has the forestry officials concerned.

"We have taken some steps to protect indigenous fruit and trees for better ecological balance," says divisional forest officer Gobinda Roy. "And in the coming fiscal year preservation of the chambol will get top priority."

"There's a need for new orchards of indigenous fruit trees including the chapalish to be planted in forest areas to ensure the survival of these species," he added.

# Chuadanga bauls worried as attackers scot-free

Police are yet to arrest any of the culprits involved in assaulting bauls and burning down their akhra at Gobindpur village in Damurhuda upazila of Chuadanga early Saturday.

spot of burnt akhra yesterday to protest the incident.

They blamed lack of proper step by the law enforcers for repeated attacks on bauls.

"We are worried as the police have failed to bring to book the real offenders," Moniruzzaman aka Dhiru Baul, president of Baul Parishad of Chuadanga, told this correspondent over phone from the spot.

Attacks on bauls continue in different areas in pre-planned ways as vested groups do not like flourishing of the baul ideology, he said.

Meanwhile, Julmat Ali, a baul mentor of the burnt akhra, filed a case with Damurhuda Police Station on Saturday night accusing

nine unnamed people for the attack.

Rashidul Hasan, superintendent of police in Chuadanga, visited the akhra the same night and assured stern action against the criminals.

Earlier on July 17, unidentified criminals Bauls from different areas gathered at the attacked a baul akhra at Ektarpur in Jiban Nagar upazila of the district, leaving four bauls, including two women, badly injured. The akhra was vandalised too.

> Police arrested one Jamat Ali, a local activist of Jamaat-e-Islami, who often went to the akhra and followed the activities of the bauls there. There are around 100 baul akhras in

Chuadanga, Meherpur and Kushtia, the largest one being at Chheuria in Kushtia centring the grave of Fakir Lalon Shah.

Mohammad Shah, chief khadem (caretaker) of Lalon akhra in Kushtia, urged the administration to take necessary steps to protect the innocent bauls.

### 50 school kids fall sick

The school authorities suspended classes.

The students were affected by mass hysteria, a kind of mass psychogenic illness, said Dr ATM Nasir Uddin, chief medical officer of PSTU health center.
