Mayors seek more revenue to improve services

The two city mayors in Dhaka on Wednesday sought the support of the tax authority to collect more revenue to provide better services to the city dwellers.

The chiefs of the city corporations cited a law passed in 2009 that provides these local government authorities to collect revenue from 26 areas in the form of tax, sub-tax and

"A city corporation is not a business entity. It has to get money from some sources such as government, to provide better services to people," said Annisul Huq, mayor of Dhaka North City Corporation. revenue to provide services."

The call was made at a meeting with top officials of the National Board of Revenue at

its headquarters. NBR Chairman Md Nojibur Rahman chaired the meeting.

"We are discussing how more revenue can be collected," Huq told The Daily Star.

As per their proposal, tax could be imposed on products that would enter the city for consumption, use and sale, and also on products that would go out of the city.

"It's people's money for people's services," Hug said.

Sayeed Khokon, mayor of Dhaka South City Corporation, said the corporation cannot carry out all its expenditures due to inadequate revenue.

There is scope to impose additional taxes as per the city corporation law by issuing "There is a law that gives scope to collect separate rules under the law that was passed in 2009. The rules are yet to be framed.

Both the city corporations have prepared draft rules to implement the law.

Beximco first to access US pharma market

Beximco Pharmaceuticals yesterday announced its first export of medicines to the United States, one of the most regulated drug markets in the world.

It shipped out Carvedilol, a prescription drug to treat hypertension. This is the first time a pharmaceutical product made in Bangladesh has hit the American market.

"As we deliver our first shipment of Carvedilol to the US market, we begin a new era for the pharmaceutical industry in Bangladesh," Beximco Group Vice-Chairman Salman F Rahman said at a function in Dhaka.

"We believe our continued focus on building and strengthening the group's presence in the western markets will cement Bangladesh's posi-

tion as a major exporting country." Beximco Pharma received permission from

the US Food and Drug Administration (FDA) to export medicines in November last year. US Ambassador in Dhaka Marcia Bernicat said it is a testament to Beximco's hard work, as

well as the quality of its products, that Bangladesh is able to celebrate this occasion. The pharmaceutical industry is arguably the most knowledge and technology-intensive

export industry in Bangladesh, she said. However, the industry still only accounts for 1 percent of GDP, Bernicat said. "I look forward to seeing pharma's contribu-

sive industries grow."

Bernicat said she is proud to see that US con-

sumers will now be able to take a lifesaving drug and see 'Made in Bangladesh' printed on the bottle.

Nazmul Hassan, managing director of Beximco Pharma, said the US is the largest and most lucrative pharmaceutical market in the world. "As a leading exporter of medicines, we strive to capitalise on the generic drug opportu-

nities in the world market." "We believe our competitive products, especially with specialised and differentiated generic products, will help strengthen our presence in

the US and other advanced markets," he added. Administrator barred from taking charge of Dhaka Mercantile Cooperative

The government appointed an executive officer for the controversial Dhaka Mercantile Cooperative Bank Ltd last month but the cooperative officials did not let him join office citing a stay order from the High Court.

The appointment was made after the Department of Cooperatives and Bangladesh Bank detected gross irregularities in the cooperative.

"We will continue our legal fight against the cooperative," said Mofizul Islam, registrar and director general of the Department of Cooperatives that regulates the country's cooperative firms.

The Rural Development and Cooperatives Division issued an order in the first week of July asking the department to appoint an executive officer (administrator) in the errant cooperative with immediate effect.

Accordingly, the Department of Cooperatives appointed its joint registrar Md Nuruzzaman to join Dhaka Mercantile

Cooperative. "I went to the office of Dhaka Mercantile Cooperative on July 14 but the firm declined to accept my joining letter showing a stay order of the High Court," said Nuruzzaman.

The cooperatives regulator has taken the issue seriously and is trying its best to vacate the stay order as soon as possi-

"We have informed the ministry and the attorney general about the updates on the matter," said Nuruzzaman.

In April this year, the central bank warned people not to do banking activities with the cooperative as it has no

The BB in a statement alleged that Dhaka Mercantile Cooperative has been running banking activities such as taking deposits and giving loans by illegally using the word 'bank' in its name.

The cooperative has collected deposits of Tk 981 crore and disbursed loans worth Tk 1,079 crore as of December 31 last year, according to a BB inspection report.

Air cargo ban not going so soon

A lot needs to be done: UK envoy



improved a lot, but a lot needs to be done to get the ban on Dhaka-London direct air cargo withdrawn, British High Commissioner Alison Blake said yesterday. Blake spoke at a press con-

ference after a meeting with Commerce Minister Tofail Ahmed at his secretariat in Dhaka. "We have been working for

a long time with the government of Bangladesh on the FY11-12 FY12-13 ban issue. It is an ongoing programme. Many things have improved," Blake

said. The government hired a British company on

March 22 for screening export goods at the airport. "We provide advice to the British company," she Blake said many exporters and manufacturers may

face difficulty due to the ban, but the price of taking any wrong decision is very high. The UK imposed the ban on March 8 as the airport



rescreened in any third country like Dubai, Qatar or Thailand. Bangladesh has been enjoying a duty-free benefit



for exporting its goods to the UK under the EU's Everything But Arms

scheme since 1971. The high commissioner, however, did not clearly say whether the UK will continue providing the benefit to Bangladesh after Brexit.

Britain is the third largest export destination for Bangladesh after the US and Germany. In 2015-16, Bangladesh

exported goods worth \$3.8 billion to the UK, up from \$3.20 billion in the previous FY15-16 fiscal year, according to data from the Export Promotion Bureau. Bangladesh imports goods worth nearly \$300 mil-

lion a year from the UK. Blake said militant attacks are not a challenge for

Bangladesh only, it is global problem now. Bangladesh and the UK have been working together to

fight terrorism, she said. Still, there is a travel alert for the British people in Bangladesh, she said.

British people have been asked to continue to travel, but they will have to take advice from the local authorities on safety, she added.

The commerce minister said Bangladesh's trade with the UK will rise further as there are chances for the British government to continue providing the duty benefit to

Bangladeshi products. Ahmed said the British investors want to construct a rail

line between the Padma bridge and Kuakata, and they also want to invest in developing the Payra seaport.

"The British envoy discussed this issue with me." The government has appointed consultants for building an airport named Bangabandhu International Airport at Shibchar in Madaripur, he said.

Star Kabab faces VAT dodging charges

The VAT Intelligence Directorate has detected Tk 4.63 crore in value-added tax evaded by Star Kabab and Restaurant, a

popular eatery in Dhaka. The VAT Intelligence Directorate, an office under the National Board of Revenue, detected the dodging based on records it seized from the restaurant's 11 outlets during raids in April.

The tax office however did not mention the timeframe in which Star Kabab dodged the tax.

The office had filed nine cases against nine scams based on the documents it seized at that time.

"This is the result of our operation in April," said Belal Hossain Chowdhury, additional director general of VAT Intelligence.

They have already requested VAT commissionerates to start the process of collecting the revenue from Star Kabab as per law, he said.

Revenue officials raided Star Kabab's Banani, Dhanmondi, Wari, Tikatuli, Elephant Road and Thatari Bazar areas. The raids were conducted following complaints from people over the phone and online over a long period of time, the VAT Intelligence Directorate said in a statement

yesterday. This was the biggest raid by VAT Intelligence in terms of the involvement of its officials.

VAT Intelligence officials said they found that the restaurant was not issuing receipts in many instances, despite having electronic cash registers at the outlets. The restaurant was issuing bills for customers on blank paper or their official pad, according to the statement.

"In many instances, they received bills without a receipt. It is an offence under the VAT law," said the statement.

The NBR's VAT office said the amount of VAT paid by the restaurant increased in the months after the raid.

It said it does not intend to dishonour or affect any business entity. The main objective is to encourage people to pay taxes and ensure compliance, according to the VAT Intelligence Directorate.

"Our main goal is to create awareness among all that none is above the law. We will not go after any business if it

pays tax properly," Chowdhury said.
