AL leader, 11 others sued in Bogra

Matshajibi Samabay Samity in Bogra's Shibgonj sued president of Awami League's Shibgonj upazila unit Azizul Haque and 11 others for "extortion, looting of fish from its farm and attempted physical harassment of a female member".

Its president Eshahaq Ali lodged a case with the court of Senior Judicial Magistrate (Bogra-2) Md Kamruzzaman.

Accepting the case, Kamruzzaman ordered the upazila fisheries officer to submit a report to his court after investigating the allegations.

Quoting the case statement, complainant's lawyer Abdur Razzak alleged that the Samity took a four-bigha government water body on lease for three years. On July 22, after being failed to take the water body on lease, Azizul and his party men demanded Tk 1 lakh extortion money from the Samity and threatened to foil its fish farming.

They beat its members, including a female one, and looted fish the following the day when they barred them from fishing in the water body, added the lawyer.

Azizul's cell phone was found switched off despite several attempts to contact him.

Eshahaq alleged that they went to lodge a case with Shibgonj police after the incident, but the police did not accept it. So, they lodged the case with the court, he said.

Asked why they did not accept the case, Inspector (inquiry) of Shibgonj Police Station Kamruzzaman Mia declined to say anything about this.

He, however, said they would look into the matter and take necessary steps if the court ordered them to do so.

BGB arrests 15 pvt university students

A court yesterday sent 15 students of different private universities to jail a day after Border Guard Bangladesh (BGB) had arrested them from near Kashinagar border area in Brahmanbaria.

They were arrested while roaming 'suspiciously' in the border area, said Lt Col Shah Ali of BGB-12.

Officer-in-Charge of Bijoynagar Police Station Ali Arshad said the arrestees are aged between 20 and 22. Four of them hail from Brahmanbaria and the rest from Dhaka. The youths claimed that they went to visit the place, the OC said.

Death anniversary

Today is the eleventh death anniversary of eminent journalist and writer

Santosh Gupta.

On this occasion, Santosh Gupta Smriti Parishad will place wreaths at his memorial at the Postagola crematorium at 10:00am, said a press release.

Born in 1925 in Runshi village of Jhalakathi, Santosh Gupta was involved with left politics before starting journalism. He made significant contribution to all democratic movements in the country and was jailed for about 12 years.

An honest and courageous writer, he wrote 14 books on arts, poem, politics, literature and journalism and edited some 30 books.

For his outstanding contribution to journalism and literature he was awarded Ekushey Padak, Sher-e-Bangla Padak, Maulana Tarkabagish Padak and Jahur Hossain Memorial Padak.

He died in 2004 due to brain hemorrhage at the age of 80.
