Amputee dreams of higher edn

She needs help for treatment, artificial leg

SSC examinee Sharna Khatun had a dream to bring solvency to her poor family after getting higher education, but a road accident turned everything upside down seven months ago.

Sharna, 15, daughter of rickshaw van-puller Harun-ur-Rashid of Domdoma village in Shantahar union under Adamdighi upazila, was an SSC examinee from nearby Shantahar Golsha Ahsanullah Institute this year.

She got serious injuries to her right leg in a collision between a three-wheeler and a motorcycle near Shantahar railway station area when she was returning home from a

coaching centre on December 7 last year.

"After the accident she was rushed to the upazila health complex. As her condition deteriorated, she was admitted to Shaheed Ziaur Rahman Medical College Hospital on February 7 this year. There doctors said cancer developed in her bone and suggested sending her

abroad," said Sharna's father Harun. Meanwhile, seriously ailing Sharna failed to complete

"We are too poor to send her abroad. We admitted her to Khwaja Yunus Ali Medical College Hospital in Sirajganj on February 29 this year. There doctors arranged amputating her right leg from bellow the waist on March 2," said her

her SSC examinations this year after attending only two

"Now she will need at least 7-8 sessions of therapy, each costing Tk 25 thousand, but it is impossible for her father to afford it," said Sharna's uncle Enamul Haque.

Doctors said that proper treatment will enable her recovery and she will be able to walk with the help of an artificial

Sharna, now passing her agonising days on the bed at home, said, "I want to start my study again to stand on my own feet and I need proper treatment and an artificial leg for the purpose."

Arshadul Haque, who assumed chairmanship of Shantahar union parishad recently, said, "I will help the family as much as possible. I also urge the rich and generous people to help the accident victim schoolgirl to see her dream come true."

Grabber feasts on Kuakata

Criminals fell at least 70 kewra trees

A real estate company named The Sunrise Beach Resort hung a signboard in Gangamoti area on Kuakata beach, 'occupying' khas land.

The company hung the signboard on the bank of the Bay about 4 km to the east from Kuata zero point near Gamgamoti reserve forest while a local gang felled at least 70 kewra trees in the area.

The gang later set fire to the trunks of the felled trees to destroy

all evidence, said Patuakhali forest department sources.

There is a reserve forest, covering 13,980 acres of land including Gangamoti, Latachaplee, Khajura, Kuakata and around 14,000 species of trees there. Of them, most of two local varieties -- Kawra and Akashmoni -- are in the reserve forest.

But a gang felled at least 70 kewra trees in Gangamoti area in two separate phases this year, grabbing the forest land and the beach, said the sources.

Despite filing of three cases, tree documents of the land," Abdur felling continues in the area, said Ajit Kumer Rudrho, divisional forest officer. Finding no alternative, forest

department on March 15 wrote to the deputy commissioner (DC) to take immediate steps in this regard, but to no effect yet.

Rather, a real estate company set up a signboard on the beach to occupy the land.

"We placed the signboard on our own land and we have all valid

Rahman Sohel, director of The Sunrise Beach Resort, said, claiming that they are not involved in tree felling. A section of forest robbers set up

a signboard in the area after cutting trees, the forest officer said, adding that there is no scope to claim ownership of forest land or beach.

Punitive action will be taken against the grabbers after taking information in this regard, said DC AKM Shamimul Haq Siddikee.

Slain pro-AL body leader's family seeks justice

Family members of a slain Swechhasebak League leader yesterday demanded exemplary punishment to the killers, alleging that the main culprits have not been arrested even after two weeks of the murder.

They also alleged that the killers are moving freely.

They were speaking at a press conference at the Pabna Press Club auditorium. Amin's family members claimed the criminals are moving freely and threatening them to withdraw the case as they are influential ruling party men.

"Shahid and his men killed my husband, who protested against Shahid's drug business. Shahid is an influential party man so we are worried we may not get justice," Farzana Parvin, wife of the deceased, told journalists.

Amin's father Bablu Pramanik said, "My son did politics for the Awami League, but the party rivals killed him. I want justice for killing of my son." Amin Uddin, 28, publicity

secretary of Pabna poura unit of Swechhasebak League, was hacked and shot dead by the party rivals on July 23 over supremacy of drug business in the Pabna bus terminal area. Pabna poura AL

President Advocate Taslim Hasan Sumon said Shahid is being politically harassed. A case was filed against

poura AL Organising Secretary Shahidur Rahman and 11 of his accomplices with Pabna Police Station, police said.

Man beaten to death in Bogra

A man died as he was mercilessly beaten at a vegetable field near the house of his second wife at Parbhabanipur Jannatpara under Sherpur upazila of the district.

The deceased was identified as Enamul Haque Babu, 25, son of Nazrul Islam of the village.

Police, quoting the victim's uncle Nurul Islam, said Enamul married Shima Akhtar of Khamarkandi Pashchimpara four years ago, and they had a daugh-

Later, Enamul built a relationship over cellphone with a girl of Burnighat of the upazila, and married her about 5 months ago.

Police arrested Enamul after filing of a case by his first wife. He was granted bail on Sunday after a reconciliation meeting between the families of the two wives, accepting the marriage.

In the afternoon, he

went to the residence of his second wife's father. He was rescued in a critical state from a vegetable field yesterday. He died while being taken to his house, police said.

Gaziur Rahman, senior assistant superintendent of police of Bogra, said there were injury marks on his stomach. Despite the marks,

police are yet to be certain

about the cause of death.

Shah Alam and his wife Nasima, herself attacked with B virus infection, see only a bleak future as their 18-monthold son is also affected with the problem. The poor couple had earlier lost two sons to the liver damaging disease.

A family devastated by B virus

Two sons die, another son, mother affected

B virus has brought immense distress to a poor family at Jolagati village in Kawkhali upazila under the district.

Md Shah Alam, 45, a day labourer of Jolagati village, is now struggling for existence with his B virus affected wife and 18-month-old son, having disease.

son Md Kayum fell ill with serious fever and I took him to Kawkhali Upazila Health Complex. Shortly afterwards, I took him to Barisal Shere-Bangla Medical College Hospital and he died there next day," said Shah Alam.

Earlier he became sick sometimes

but it was not serious, he said.

After four and a half years, his elder son Md Shameem, a student of Class IX, suddenly felt serious pain in his belly and he was admitted to a private hospital in Khulna.

"Due to serious monetary crisis, I brought him back and admitted him to Barisal Sher-e-Bangla Medical earlier lost two sons to the same College Hospital and came to know that he was attacked by B Virus, "Nine years ago, my five year old which causes death in most cases. Within one and a half months, he died," he said.

As per doctors' suggestion, bloods tests of Shah Alam, his wife Nasima Begum, 37, and daughter Aysha, 4, were conducted in Dhaka and B Virus was found in his wife's body.

"Sometimes, my body sweats, I

feel tired and my hands and feet convulse," said Nasima.

"I also tested the blood of my one and a half year old son Musa early June this year and B virus was found in his body. Now I am helpless as the doctor has said that a few lakh taka would be needed for my son and wife's treatment," said Shah Alam.

Shah Alam needs help from the solvent people to save his son, said Jakir Hossain, a local.

Md Idris Ali, Pirojpur Sadar upazila health and family planning officer, said, "When Shah Alam's son first became sick I told him to take him to Barisal for better treatment. Then I came to know that the boy was attacked by B virus that is responsible for damaging liver."

Two college students drown

11:00am and went missing. After two hours of frantic efforts, divers recovered the bodies, said police.
