Bamboo-made watchtower to check robbery

Locals have set up two bamboo-made watchtowers to tackle robbery in remote char areas on the Teesta river basin in Sundarganj upazila.

Robbery is a common incident in the char areas during the rainy season. Most of the char areas go under floodwater. Robbers become active at that time as they can easily go from one place to another by engine-run boats.

The flood-affected people are compelled to take shelter on higher ground or flood control embankments with their belongings, including cattle.

Robbers attack the flood victims and loot their valuables.

At least six robberies had happened in different places of Kapasia, Sreepur and Haripur unions before the watch-

The criminals were committing the crime even in broad daylight, said locals of Kapasia union.

With their physical labour, locals have set up the towers. At least 10 people can stay on a tower at a time for observing movement of robbers' boats. They blow whistles to alert people if they see any such boat com-

"We do our duties round the clock by rotation. At night, we run searchlights by using solar panels," said Mokbul Hossain, one of them who guards against robbery.

After setting up of the watchtowers, no robbery occurred here, said Somesh Ali of Haripur river ghat.

Locals said those towers somewhat relieved their anxiety over robbery.

Verdict today in Jessore war crimes case

The International Crimes Tribunal-1 is set to deliver verdict today in a case against nine Jessore men, including former Jamaat-e-Islami and BNP lawmaker Shakhawat Hossain, in connection with crimes committed during the Liberation War.

The three-member tribunal headed by Justice Anwarul Haque with members Justice Md Shahinur Islam and Justice Md Shohrowardi fixed the date 26 days after it had completed trial of the case.

Earlier on July 14, the tribunal kept the case waiting for delivering judgment.

The accused are facing five charges of crimes including killing and rape. Wrapping up their closing argu-

ments, the prosecution prayed for capital punishment of the accused saying all five charges have been proved. On the other side, the defence prayed for acquittal of their clients saying the prosecution failed to prove a single charge.

All the accused hailed from Keshabpur upazila in Jessore. Apart from Shakhawat, who is now involved with Jatiya Party, Billal Hossain Biswas is also behind bars. Another accused Lutfar Morol died of old age complications in May this

The other accused -- Ibrahim Hossain, Mujibur Rahman, Kazi Ohidul Islam, Aziz Sardar, Aziz Sardar and Abdul Khaleq Morol -- are on the run.

The prosecution on July 26 last year pressed charges against 12 people over the killing of two persons, rape of one and torture on two others in the Bangla month of Ashwin (between mid-September and mid-October) during the war in 1971.

The tribunal accepted charges against nine on September 8 last year and cleared the other three. The court on December 23 framed five charges against the nine and the prosecution produced 17 witnesses, including two investigation officers. The defence declined to produce any

witness. Shakhawat was a central committee member of Islami Chhatra Sangha, the then student wing of Jamaat, and a commander of Razakar force at Chingra Bazar camp. The

Afghanistan with him, we accepted it and paid him Tk 1 lakh to 1.5 lakh each for managing visas," one of the workers Ratan Mia told The Daily

The factory in Herat city of Afghanistan produces steel billet for exporting to Middle Eastern countries. It has around 100 employees, mostly from Afghanistan. "We got salaries for two months

before the closure of the factory. Since then we are not getting any money," said Ratan of Kurigram. Factory owner Abdullah Rasuli had

agreed to pay each worker \$600 a month, but he gave only \$400, he alleged.

"Now we have no work here. We are facing serious problems in managing food and proper treatment. We can't even go out. We are staying here like captives," added the worker.

In April, family members of some of the victim workers filed a written complaint with the Afghanistan embassy in Dhaka against the owner of the factory. They requested the embassy to arrange safe return of their relatives.

Some embassy officials at that time had assured the relatives of looking into the matter, but they did little about it, said Zahid Alam Zia, son of another stranded worker Shah Alam Hawlader.

Ratan said an Afghan foreign ministry team visited the workers at the taking steps in this regard.

According to Zahid, a visiting Afghan government official had a meeting with embassy officials in Dhaka and the relatives of some workers. But the meeting did not yield any result.

"We are very frustrated as four months have passed since filing of the

written complaint and there no visible progress," he said. Zia has recently given up his gradu-

The circular, applicable to nongovernment schools, colleges, madrasas and vocational institutions, came months after an outcry from guardians over a sudden increase in students' monthly tuition fees by a number of renowned private schools in Dhaka.

After the government announced the ministry circular. new pay scale for civil servants in December last year, these schools, without any prior notice, hiked the tuition fees by 50 to 100 percent this January, showing the salary hike as an "excuse".

Protesting the schools' move, many guardians even took to the streets. They demanded an immediate solution to the problem.

In February, the education ministry asked the school authorities to stop collecting the increased fees and refund the extra money. It also asked

reasons for hiking the fees.

"Institutions getting MPO facilities fully and partially and those which are not enjoying the facilities at all have abnormally been increasing the tuition fees in the context of implementing the new pay scale for civil servants, and it is totally unacceptable," said the

In no way, an institution can raise fees beyond 30 percent of the current fees, it said.

The institutions also cannot charge session and development fees more than what are described in the admission regulations.

Meanwhile, talking to The Daily Star, some guardians said the government circular was not "clear" and had scopes for misinterpretation.

"The circular did not make it clear when and how many times schools can

> "If this is to be the case, it will be an extra burden on us," he said.

Ziaul Kabir Dulu, president of Obhibhabok Oikya Forum, a platform of guardians, said the government would increase the fees," it said. circular did not specifically say which schools could raise the tuition fees.

"The governing bodies of many schools had increased the fees and did not pay heed to the government's call to stop collecting the extra fees. Now these institutions will increase 30 percent of the already-increased fees," he explained.

The ministry should set the tuition fees before making such proposals, he suggested.

According to the circular, the institutions wanting to have the fees increased will have to send the proposal to the district education officer after it is recommended by the head of same scale.

"The district education officer will

analyse the proposal and present it before the additional deputy commissioner [education] if the officer finds the reasons [for the hike] justified. Once the additional deputy commissioner approves it, the institutions

It also said the number of teachers and staff at private institutions must follow manpower guidelines and the institutions cannot introduce new branches without approval from the education ministry. "Appointment of teachers and staff

will not be legal if the branches are unapproved. Fees cannot be collected from students for paying salaries of teachers and staff appointed without approval," said the circular.

The circular also said the salary and allowances of a non-MPO-listed teacher would not be higher than that of an MPO-enlisted teacher of the
