### 'Robber' killed in 'gunfight'

An alleged robber was killed in a 'gunfight' with police in Jhenidah early yesterday.

The deceased was Abdur Rashid, 44, of son of Elahi Biswas of Dudshar in Shailakupa upazila.

ASP Azbahar Ali Seikh said informed that a gang was planning to commit robbery on Jhenidah-Kushtia highway near Dudshar Ashrayan Project they raided the area around 3:00am.

Sensing the presence of police, the robbers opened fire, forcing them to retaliate, triggering a 'gunfight'.

Later, the bullet-riddled body of Rashid was found on the spot. However, his cohorts managed to flee.

Two policemen were also hurt during the 'gunfight', the ASP claimed, adding that they recovered a shutter gun and two

bullets from the spot.

Jute price fall worries farmers STAR COUNTRY DESK

Jute price fall worries farmers in Lalmonirhat and Jessore despite bumper production of the cash crop.

The growers in Lalmonirhat are becoming frustrated due to sharp fall in jute price, reports our correspondent. They are counting losses as

jute is now being sold between Tk 1600 and Tk 1700 per maund, while its price was Tk 1900-2000 a week ago in the local markets, said the farmers. Grower Nabin Islam, 50, of

Shalmara village in Aditmari upazila, said he sold jute at Tk 1700 per maund this week while it was sold at Tk 2000 last year.

With a hope of earning more profit, he cultivated the crop on eight bighas of land this time while it was five bighas last year, said another jute farmer, Aftab Uddin, 60, of Durakuti village in Sadar upazila.

Last month, jute was sold between Tk 1900 and Tk 2000 per maund but its price now sees a sharp fall of Tk 400 to Tk 500 per maund before the arrival of new jute in the local market.

Md Sirazul Islam, a farmer of Ghurulia village in Sadar upazila, said he cultivated jute on two bighas of land this current season but its sharp price fall really worries him.

According to DAE in Jessore, 24,500 hectares of land have been brought under jute cultivation this year.

### 2 cargo boats collide in Meghna: 13 rescued

A band of rogue army personnel killed Bangabandhu's nephew Sheikh Fazlul Haque Moni, founding chairman of Awami Jubo League, and his wife Arzu Moni at their Dhanmondi residence that morning.

In another attack, Bangabandhu's brother-inlaw Abdur Rab Serniabat, the then water resources minister, was murdered at his Minto Road residence while a mortar assault by some army personnel killed 14 in Mohammadpur, taking the death toll to 34 on the fateful day.

The cases linked with these killings were filed in 1996. Two of them are still on the backburner while the accused in the case filed in connection with Sheikh Moni's murder have been acquitted by a lower court.

Law Minister Anisul Huq could not be reached for comments on this issue despite several attempts by phone yesterday.

He earlier told The Daily Star that the government would take initiatives for disposal of the two cases filed over Serniabat's killing and Mohammadpur attack.

General Mahbubey Alam and Capt Nurul Huda told this newspaper yesterday that though most of the accused in these cases had either been convicted or executed in Bangabandhu killing case, his office would take steps for vacating the High Court order that stayed the proceedings of Serniabat murder case.

The HC stayed the case's proceedings in November 1999 following a petition filed by Bazlul Huda, one of the accused executed for Bangabandhu's murder. In January 2009, five

condemned killers of the Father of the Nation were executed following a Supreme Court verdict in Bangabandhu murder case filed in October 1996. SHEIKH MONI MURDER

The Criminal Investigation Department submitted the final report in the case in August 2002.

Dhaka Chief Metropolitan Magistrate Court in December the same year accepted the report and acquitted all the accused without even notifying the complainant.

# Women labourers face wage disparity

Female farm workers are paid less than male colleagues in Thakurgaon, Panchagarh

If ever an example was needed that sincerity doesn't pay, one could visit the farm fields of Thakurgaon and Panchagarh. There, female farm labourers who are renowned for their dedication to the task at hand are consistently paid less than male

colleagues. "We have to work for a smaller wage," says Rosoda Bala, 35, a farm labourer from Bokanthapur village in Thakurgaon Sadar upazila. "Otherwise the landholder won't give us

"There's no alternative," agrees Maleka Begum, 50, of Shakoya Shahapara village in Panchagarh's Boda upazila. "Working for low wages is a matter of survival in rural areas. If I avoid work for a day or two in order to bargain about wages, my family will pass those days half-fed or without food. Working in the crop fields is essential to arrange family meals."

Bala, 30, also from Boikanthapur, with their male counterparts. are typical. She told The Daily Star while working in an Aman paddy field that her payment for that day of the food and disaster management encourage more women to work would be Tk 160, as it has been for ministry entitled "National Food outside the home and bring greater

While women make up more than half of farm labourers in Thakurgaon and Panchagarh districts, especially active in the jute and Aman fields at the current time, typical day wages for women range from Tk 150 - Tk 180 while, for the same work, men can expect to earn Tk 250 - Tk 300.




