

# 'Husband, goons' kill woman in launch, later held

A woman was killed inside a Barisal-bound launch allegedly by two killers hired by her husband early yesterday.

The deceased was Rina Akther, 23, of Manipur village in Comilla.

Police arrested three people in the launch "MV Parabat-10" yesterday morning. They arrestees are Kalam, Tushar and victim's husband Md Anis.

Satyaprokash, sub-inspector of Kotwali Model Police Station, said the couple boarded a cabin of the Dhaka-Barisal launch on Monday night. Anis left the cabin at midnight when Rina was sleeping. Kalam and Tushar entered there at that time and murdered Rina.

Selim Mia, master of Parabat-10, said hearing screams of a woman coming from the cabin, which was locked from inside, several passengers gathered in front of it.

When the people inside opened the door a woman's slit-throat body was found. The passengers detained two people from the spot and later the husband from the roof of the launch, Selim added.

The sub-inspector said Anis, a sales man at a shop in Savar, married Rina after being acquainted with her one year ago. However, he did not want to continue the relationship and hired Kalam and Tushar for Tk 20,000 to kill Rina.

## Two RU students robbed of valuables

# Road crashes kill 4

Four people, including a six-year-old boy, were killed and four others injured in road accidents in three districts yesterday and on Monday.

In Mymensingh, Mahin, 6, was killed as a truck ran him over while he was crossing the Mymensingh-Sherpur road in Rupchandrapur area of Tarakanda upazila yesterday.

Mahin, son of Shahidul Islam of Rupchandrapur, died on the spot.

In another accident, a three-wheeler driver was killed and four passengers of the vehicle were injured when a bus rammed the vehicle on Dhaka-Mymensingh highway

in Churkhai area of Mymensingh Sadar yesterday.

The deceased was Soheli Miah, 30, of Akua Madrasa Quarter area in the upazila.

In Naogaon, Abdur Razzak, 62, of Nilphamari Sadar was killed as a truck hit his motorcycle on Badargachhi-Akkelpur road in Bhandarpur village under Badalgachhi upazila on Monday.

Razzak was a retired official of the Department of Agriculture Extension (DAE).

In Jessore Sadar, rice trader Kaium Hossain, 35, of Churamon Kathi Bazar was killed as a bus rammed his motorcycle in Barobazar area yesterday.

the CPA and the navy, had been built on the Karnaphuli illegally.

Encroachment, earth filling and construction of buildings on the river had been declared illegal following the HC verdict, he added.

Yesterday, the HC bench of Justice Md Rezaul Hasan and Justice Kashefa Hussain came up with verdict after hearing the writ petition filed by Human Rights and Peace for Bangladesh, a rights organisation, in July 2010.

The organisation filed the petition as a public interest litigation, seeking the HC directives on the government to save the river. The petition was filed on the basis of media reports saying encroachment and construction of structures on the Karnaphuli are going on.

Following the petition, the HC on July 18 in 2010 had directed the government to stop encroachment, earth filling and construction of buildings on the river and asked the director general of the Directorate of Land Records and Survey and the Chittagong DC to submit a report after conducting a survey on the river.

The HC on June 2 last year stayed the effectiveness of the new circular and issued two rules upon the authorities concerned to explain its legality.

The museum authorities also filed two petitions for staying the HC orders, which the apex court on December 13 and 15 last year rejected.

The writ petitioners on January 18 this year submitted two separate supplementary petitions to the HC praying to it to order the museum authorities to submit papers relating to the recruitment before the HC, the lawyer added.
