Madrasa board sees pass rate drop

Although Madrasa Education Board has topped the list of 10 education boards in terms of pass rate for the 11th consecutive year, the rate has dropped by two percentage point on the previous year to 88.19 percent.

However, the number of GPA-5 achievers increased by 68 percent on the previous year to 2,414. Of them, 1,767 are males and 647 females.

Last year, 1,435 students scored the top grade.

A total of 89,603 students took the Alim exams this year, up from 82,558 in the previous year. Of them, 79,020

came out successful. Out of 2,706 madrasas, 585

achieved 100 percent success rate while five got zero pass rate. TECH EDUCATION BOARD

Bangladesh Technical Education Board stood second among the 10

education boards in terms pass rate this year. Although the pass rate declined by

about one percent compared to last year, the number of students and GPA-5 achievers increased this year. Under this board, 84.57 percent students came out successful this year against last year's 85.58 percent. A total of 1,02,248 students took

the exams this year, up from 98,296 last year. Of them, 86,469 examinees passed and 6,587 secured GPA-5. Students from 1,675 technical

institutions took the exams. The number of technical institutions with 100 percent success rate dropped this year to 158 from last year's 183.

Like the previous year, no institution got zero pass rate.

Hajj flight trouble to end soon

Says Menon

Civil Aviation Minister Rashed Khan Menon yesterday assured that the problems related to the Hajj pilgrims coincided with cancellation of flights would be resolved soon.

"There would be no sufferings to the Hajj pilgrims in the coming days. We are facing some problems due to the online system as it was introduced here for the first time," he said after an inter-ministerial meeting on "Fair and Smooth Hajj Management"

The minister said some decisions were made in the meeting in presence of Religious Affairs Minister Motiur Rahman. They include: the Hajj Agencies of Bangladesh was asked to submit to the ministry of religious affairs within four-five days a list of pilgrims dividing them into 50 people in each group, names of Moallems (helpers), numbers of Haj

pilgrims enlisted with respective Hajj agencies and addresses of houses rented in Saudi Arabia for the pil-"This list will be sent to Biman

Bangladesh Airlines and Saudia Arabian Airlines and the sale of tickets will be as per the list ...," he

An official release yesterday afternoon said Bangladesh will write to Saudia seeking more slots for carrying pilgrims.

The meeting was told that visas of 69,451 Hajj pilgrims have already been processed and as of yesterday a total of 41,840 pilgrims had left

Suspend move to hike gas tariff

Energy experts call on BERC at public hearing

Opposing the government's move to hike gas prices, rights groups and energy experts yesterday suggested Bangladesh Energy Regulatory Commission (BERC) should suspend the initiative until the Energy and Mineral Resources Division settled the supplementary duty and VAT issues.

Taking part in the public hearing on the tariff hike proposals of gas distributors, they questioned collecting 55 percent supplementary duty (SD) and VAT from the gas tariff.

The eight-day public hearing ended yesterday at the BERC in the capital. Distributors have proposed increas-

ing the prices by up to 94.89 percent for different categories of consumers. From the gas tariff, the government

collects 40 percent as SD, 15 percent as VAT, 11.22 percent for the Gas Development Fund (GDF), 26.29 percent for Energy Security Fund, and 3 percent as advance income tax (AIT). During the hearing, representatives of Petrobangla said the gas distribu-

tion, transmission and production companies would get Tk 840 crore out of their total income of Tk 8,000 crore if the proposed tariff was implemented. It means over Tk 7,000 crore would go to government exchequer in the

Security Fund. Prof Shamsul Islam, adviser of Consumer Association of Bangladesh, said the public hearing should be suspended as the Energy and Mineral

Resources Division was yet to settle the

name of SD, VAT, AIT, GDF, and Energy

He said there was no accountability in using the GDF fund. "There would have been no necessity to hike gas tariff if the government had utilised the GDF

fund properly."

Energy expert Prof Nurul Islam said Petrobangla was facing fund crisis as it set gas tariff without adequate transparency.

Khondkar Saleque Sufi, an internationally acclaimed energy expert from Bangladesh, said gas production cost would increase if the tariff was hiked. Ruhul Hossain Prince, representa-

tive of the Communist Party of Bangladesh, said there was no reason for hiking the gas tariff as no impact assessment has been done so far. BERC Chairman AR Khan said it

would fix the gas tariff considering the overall costs and its impact on consumers. "The BERC would announce the [new] tariff as soon as possible. We

won't announce any unjust tariff hike," he assured. Gas distributors have proposed increasing the charge for double-burner stoves in households to Tk 1,250 a

month and single-burners to Tk 1,000,

up from Tk 650 and Tk 450. Gas tariff

was last raised in September last year. Earlier, the BERC's technical evaluation committee rejected the proposal of raising the gas distribution charges of Titas Gas Transmission and Distribution Company Ltd and Gas Transmission Company Ltd as the current tariffs were enough to meet

their operational costs.

Trade bodies including Metropolitan Chamber of Commerce and Industry, Dhaka; Dhaka Chamber of Commerce and Industry; and Bangladesh Textile Mills Association opposed the government move, saying it would increase the cost of doing business.

The BNP also termed the gas price hike proposal anti-people and warned of an agitation if the tariff went up.

With a powerful network of influence in institutions such as the judiciary and police as well as the media, the former ally of President Recep Tayyip Erdogan has long been accused of running a "parallel state" in Turkey.

Tens of thousands of his alleged supporters have been detained or sacked in a sweeping post-coup purge that has worried Ankara's Western partners.

Aydinli CEO Kavurmaci condemned the failed coup in a statement on the website of the group, which also has interests in the construction sector.

"We support our president, our prime minister and our government elected with the will of the people," he said.

Police have seized books by Gulen and a plaque awarded by the preacher to Kavurmaci during a search of the CEO's office, Anadolu said. Rizanur Meral, president of the

Turkish Confederation of Businessmen and Industrialists (Tuskon), is also among the suspects, the news agency reported. Founded in 2005, Tuskon has

55,000 members and is accused by the government of financing pro-Gulen activities.

The suspects are accused of "membership in a terrorist organisation" and "financing the activities" of Gulen, according to the private Dogan news

agency. In a similar operation on Tuesday, Turkish police raided dozens of companies in Istanbul in search of 120

suspects including CEOs. Around 100 people were detained. That operation targeted Akfa, largely involved in construction, and the A-101 supermarket chain which

and bewildered on an orange chair inside an ambulance, shortly after he was rescued.

Khaled Khaled, an Aleppo-based member of the Syrian Civil Defense, a volunteer rescue group that operates in rebel-held territory, identified the boy as five-year-old Omran Daqneesh.

The boy was then rushed by members of the group, also known as the White Helmets, to a nearby hospital, Khaled told Al Jazeera. He suffered from light headwounds and was released later that night.

Three other people were killed and at least eight others, mostly women and children, were injured in the same air strike, according to Khaled.

It was the images of Omran, though, that made the headlines and drew shock and revulsion from both Syrians and foreigners on social

media. A video shot by media activists showed Omran being lifted from a house and placed, before rescuers leave him to go back to the scene. Omran is left alone in the chair, staring blankly, before rubbing his bloodied head

In a video of a chaotic nighttime scene, a man is seen carrying the boy, covered in grey dust, from the rubble of an unidentified building and placing him on a seat in an ambulance, before leaving him to go back to the scene. Omran is left alone in the chair, staring blankly.

The boy then runs a hand over his blood-covered face, looks at the blood and wipes his hands on the ambulance chair. He does not cry or make a sound.

The image has been shared thousands of times on social media platforms like Twitter and Facebook. "We can get numb seeing dead

and injured children remotely day after day," said journalist Anne Barnard on Facebook, "but some pictures particularly get to the mom in me and this is one. The orange chair. The expression. I want to give him a hug". On Twitter, Sima Diab said: "What

was your five-year-old son doing today? Mine was playing football. Not Omran, he was saved from an air strike in Syria.' The pictures of Omran - referred to of the administration to discharge by many as "the boy in the ambu-

lance" - were reminiscent of the image of Aylan Kurdi, another Syrian boy whose body was found on a beach in Turkey last year after he drowned as he and his family attempted to cross the Mediterranean in the hope of finding refuge in Europe. The image of Kurdi's body brought

world attention to the growing refugee crisis, as tens of thousands of Syrians attempted to make the same dangerous journey, fleeing war-torn homes for the stability of Europe.

Bahrain from 2005 to 2010, was one of the four. He along with 48 other Bangladeshis was deported.

Halim narrated to The Daily Star his journey of two years after falling into the trap of an international human trafficking syndicate, which targets jobseekers from Asia and Africa for smuggling to the US and other

countries in the Americas. Each of them had to pay Tk 20-25 lakh to a broker named Khorshed Alam from Dhaka for the journey in January 2014.

"Our broker set his agents in all

countries to help us overcome all possible hurdles and show us the way to reach our final destination," said Halim. They used air, water and land routes. They travelled through Qatar, the UAE, Brazil, Bolivia, Peru,

Venezuela, Ecuador, Columbia,

Panama, Costa Rica, Nicaragua,

Honduras, Guatemala and Mexico and

finally entered the US through California and Texas.

PERILOUS JOURNEY After returning from Bahrain in 2010, Halim got married in Comilla. The marriage did not last long as his wife left him. Since then he faced many difficulties as he tried to earn his living by farming and small businesses in his village.

He was not enjoying his life. He later came across the broker and decided to take the risk of travelling to the US.

"Some people from our village went to the US and are now working there. So, I thought I would be able to have a fresh start to my life after settling in the US. But I could not succeed; I have failed and am suffering even more," said the dejected man. Halim, Kabir, and two other vic-

tims from Noakhali, travelled together up to Bolivia. They paid \$100 each and managed one-month visa from the Bolivian immigration police. They got separated after staying around 10 to 15 days in Bolivia. Halim went to Peru where he

spent four to five days before entering Ecuador after a 50-hour bus jour-When he arrived in Colombia, he was astonished to see many

jobseekers from Bangladesh, India, Pakistan, Nepal, Somalia, Eritrea and some African countries. "I found around 60 to 70 people from different countries, including

Bangladesh, in the dens of the human traffickers in Colombia. Some people used to stay there as informers and security guards," he recalled. All of them were taken to Panama
