PM sees plot to unleash communal conflicts

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said there are well-hatched conspiracies to unleash communal conflicts in the country

Such evil designs, she said, could be effectively faced with united efforts

"Sometimes various incidents take

place in the country ... It seems those are staged in a well-planned manner to unleash communal conflicts," she said while exchanging greetings with members of the Hindu community on the occasion of Janmashtami at the Gono Bhaban.

Hasina said some incidents occurred in the country a few days ago and the government urged all to remain united against terrorism and militancy.

"Nobody wants terrorism, conflict and militancy, everyone wants peace. Now all are united for peace. This is SEE PAGE 10 COL 5

FIRE AT BASHUNDHARA CITY Mall authorities hope to re-open by tomorrow

Although a day had passed since a fire broke out at Bashundhara City shopping complex, firefighters were still carrying out with their work at the multi-storied mall yesterday.

Black marks created from toxic thick smoke were visible from the outside on the walls of at least three floors, although the authorities said only level-6 of the mall was affected by the blaze.

Meanwhile, about 100 shop owners and staff waited throughout the day yesterday in front of the mall to know

the fate of their shops. Fire service officials and the mall authorities were yet to assess the loss caused by the blaze.

Brig Gen Ali Ahmed Khan, director general of Fire Service and Civil Defence, yesterday said they were dampening the floors to determine whether any hidden fire remained inside the mall.

Draft Digital Security Act

cabinet sources told The Daily Star.

"The aim of the new law is to check cybercrime," Cabinet Secretary Mohammad Shafiul Alam told reporters after the meeting at the secretariat.

Talking to The Daily Star, former law minister Shafique Ahmed said a law must define what actions would be considered as offences.

He also said the law (Digital Security Act 2016) should have been enacted much earlier.

Nur Khan Liton, acting executive director of rights body Ain o Salish Kendra, said a law must clearly state its purview, otherwise there would be

scope for misuse of the law. "We hope the government will specify the law's jurisdiction before

- 5 years' jail or Tk 3 lakh fine for committing crimes using digital device

The country already has Information and Communication Technology (ICT) Act 2006 that deals with cyber offences with stringent punishment.

Besides, the Liberation War Crimes Denial Act 2016 has been drafted to check distortion and denial of established historical facts related to

The cabinet secretary said four provisions -- 54 to 57 -- would be omitted from the ICT Act and then included in the Digital Security Act

There was inadequacy in the ICT Act, and for this the new law has been framed with a wider perspective

for ensuring digital security, he said. The proposed law provides for a maximum sentence of 14 years' imprisonment and Tk 1 crore fine or both for hacking or attacking any important cyber establishments or infrastructure such as Biman Cyber Management.

It includes another provision of a maximum penalty of 14 years and a minimum of two years in prison and also a fine of up to Tk 1 crore or both for cyber terrorism.

Actions that may affect Bangladesh's unity and hinder other countries' security or help and encourage someone to commit terrorist activities would be considered as cyber terrorism, he said.

According to the proposed law, if anyone commits crimes using a computer, a mobile or any digital device, the person would face a maximum punishment of five years and a minimum of two years in jail and Tk 3 lakh fine or both.

For cheating or committing a forgery through computers, mobile phones or other electronic devices, an offender could face a maximum penalty of five years and a minimum of three years in prison and a fine of Tk 3 lakh or both.

The proposed law has provisions for two year's imprisonment and Tk 2 lakh fine or both for violating secrecy, a maximum sentence of 10 years and a minimum of two years in prison or Tk 10 lakh fine for circulating pornographic materials on the internet.

Besides, one could face a maximum punishment of two years' imprisonment and a minimum of two months in jail and Tk 2 lakh fine or both for defamation and hurting religious sentiment.

For creating enmity and causing deterioration of law and order, a person could face a maximum penalty of seven years and a minimum of one year in jail and Tk7 lakh in fine or both.

All crimes under the law will be bailable, and law enforcers will need a warrant before searching or confiscating any electronic devices. But, in special cases, law enforcers can search, confiscate or even arrest someone without a warrant in presence of an executive magistrate, it said.

The draft law proposes constituting a digital security agency to be headed by a director general with powers to direct any law enforcement agency to stop broadcast of information through electronic devices.

If necessary, the DG would order an immediate stop to any transmission, said the cabinet secretary.

The cabinet yesterday also okayed in principle the drafts of the Metrology Act 2016, the Hindu Religious Welfare Trust Act 2016, the Buddhist Religion Welfare Trust Act 2016 and the Christian Religion Welfare Trust Act 2016.

It also approved a proposal for continuing the ban on cutting of trees at reserve and natural forests till 2022 to protect biodiversity in the country.

SC stays bail of 'top militant'

Toriqul was arrested again on October 5, 2014 over the killing of former PDB chairman and so-called pir Khijir Khan in the capital's Badda. On October 25 last year, he confessed before a court that he murdered Khijir.
