# Freedom fighter gets house from PM

KONGKON KARMAKER, Dinajpur

"Bir Nibash" -- a name well-suited for the house of a hero of the country. Prime Minister Sheikh Hasina has arranged this house as a token of her appreciation for Freedom Fighter Ansar Ali's gallantry during the Liberation War of 1971.

The key to the house was handed over on August 18 to Ansar Ali from Hakimpur upazila of Dinajpur. Shibli Sadiq, lawmaker of Dinajpur-6, gave away the key to the Freedom Fighter on the PM's behalf.

Local Government and Engineering Department built the house on 5 decimals of land at Chhatni village in the same upazila at a cost of Tk 8 lakh.

A five-member bench of the Appellate Division headed by Chief Justice Surendra Kumar Sinha passed the order following two petitions by the government and eight rights organisations seeking a stay on the HC verdict.

Syeda Rezwana Hasan, a lawyer for the rights organisations, told The Daily Star that Ashiyan City authorities were not allowed to continue activities of their projects at Uttarkhan, Dakkhin Khan, Barua and Buthar mouzas in Dhaka following the SC order.

Attorney General Mahbubey Alam said the government had filed the stay petition, considering that the living condition -- low land, open space and forest that were necessary in a city -- would be damaged if Ashiyan City's housing projects were allowed.

Talking to reporters yesterday afternoon, Jasim Uddin said 11 shops were damaged completely while 20 to 22 more shops on level-6 have been affected from the blaze.

The Bashundhara authorities will also form a body with their own expert technicians and fire service officials to find out whether any negligence of duty on the part of their staff was responsible for the inferno, said Jasim.

Fire service authorities formed a fivemember body that started work yesterday, DG Ali Ahmed told The Daily Star by phone.

Meanwhile, MA Hannan Azad president of Bashundhara Shop Owners' Association, claimed that some 100 stores on level-6 were affected due to the blaze.

The Daily Star could not reach his agent or Biman for comments last night.

His wife, two sons and their wives have also come to see him off but they were waiting at the camp without any information about his flight. "It's painful that there is none to listen to my

sufferings ...," he said. Around 30,000 pilgrims have already obtained their visas from the Saudi Arabian embassy in Dhaka to perform hajj, said Abu Saleh Mostofa Kamal,

director of Dhaka's Ashkona Hajj Office. "A total of 55,616 hajjis have already flown to Saudi Arabia by this afternoon [Monday]. Over 15,000 hajjis are waiting

for their visas," he said, adding that five to six days were left to get the visas so "these pilgrims will be able to get visas by this time".

Meanwhile, a total of 483 hajj agents

have been asked to submit pilgrims' passports to the embassy for hajj visas by August 28.

"All the mentioned agents have been requested to complete visa procedures for the hajjis as the Royal Saudi embassy will not accept any passport after August 28," said Kamal.

This year, Bangladesh and Saudi Arabia selected 483 agents to handle the hajj activities of 96,558 pilgrims who have registered online. Of them, 143 agents were waiting to get confirmation from the Saudi government to send around 15,000 pilgrims, whose fate hangs in the balance, said sources at Hajj Agencies Association of Bangladesh.

AKM Masudur Rahman, consular at Bangladesh Hajj Mission in Jeddah, told The Daily Star that only 14 hajj agents could not complete the detailed procedure for their 2,500 to 3,000 pilgrims. The hajj mission is monitoring whether agents are ensuring the prom-

ised facilities for the pilgrims, he added.

NOOR'S MOTORCADE Key accused of 2013 attack arrested

Detectives yesterday arrested the prime accused in a case filed for attacking the motorcade of Asaduzzaman Noor, the then Awami League lawmaker and now cultural affairs minister, at Ramganj Haat of Sadar upazila in 2013.

"I told them that I didn't know because I was not at the house the whole day. They then started beating me up," Azad told The Daily Star. The men later entered the eight-

storey building and searched all apartments. They found Azmi in one of the apartments, blindfolded him and took him with them around 11:30pm, claimed Azad.

Earlier on August 9, Ahmed Bin Quasem, son of top Jamaat leader and convicted war criminal Mir Quasem Ali, was allegedly picked up by some unidentified men from his Mirpur DOHS home in the capital.

Hummam Quader Chowdhury, son of executed war criminal Salauddin Quader Chowdhury, was also reportedly picked up by unidentified men from a court compound in the city on August 4.

### Iraqi forces foil suicide bomb attack

Remove bomb vest from 12-yr-old 'IS boy' before blast

Iraqi security forces apprehended a teenager wearing a suicide belt before he was able to detonate it in the city of Kirkuk, security officials said yesterday.

The foiled attack late Sunday was one of a series of security incidents in Kirkuk and came a day after a child suicide bomber killed more than 50 people in Turkey. "Police forces managed to stop a

bomber thought to be as young as 12," Kirkuk police chief Brigadier General Khattab Omar Aref told reporters. He said the boy was about to carry

bomb attack on behalf of IS at a Shia place of worship in Kirkuk, an ethnically and religiously mixed city that lies 240 kilometres north of Baghdad. Nighttime TV footage showed a boy holding his hands in the air as security

forces removed the explosives belt from around his waist. The video shows him appearing to burst into tears as he is captured by police. The explosives vest was later detonated in a controlled explosion,

reports Independent. ing the boy was kidnapped by masked men who placed the explosive vest on

The thwarted attack was one of four separate security incidents in Kirkuk over a few hours, including one in which a policeman shot a suicide bomber who tried to enter a Shia prayer hall.

"The police forces have managed to foil a terrorist operation that could have caused victims and led to a catastrophe for the province," Kirkuk Governor Najmeddin Karim told AFP.

The security situation has been tense lately in Kirkuk, which is under Kurdish security control but is also home to Turkmens, as well as Sunni and Shia Arabs.

Aref said the attackers involved in the latest string of incidents entered Kirkuk recently and came from Mosul, the last remaining major bastion of the Islamic State group.

Iraqi forces are currently conducting shaping operations on several fronts to tighten the noose on Mosul --Iraq's second city -- and set the stage for an offensive.

The IS group, the most extreme organisation in modern jihad, has routinely used children to perpetrate crimes. It provides young boys in its self-

## Japan's first lady visits Pearl Harbor

The wife of Prime Minister Shinzo Abe has visited Pearl Harbor, bombed by Japanese planes nearly 75 years ago in an attack that brought the United States into World War II. It was not clear exactly when Akie

Abe made the visit. But she posted 11 pictures on her official Facebook page, apparently early yesterday. "I offered flowers and my prayers at

the USS Arizona Memorial at Pearl Harbor," she wrote. Her visit to the Hawaii memorial came just months after President

Barack Obama journeyed to Hiroshima, the Japanese city where a US plane dropped the world's first atom bomb in the closing days of World War II.

Obama's trip to Hiroshima sparked speculation that Shinzo Abe could visit Pearl Harbor in response. But top government spokesman
