Country feels mild tremor

UNB, Dhaka

A moderate earthquake jolted Dhaka and other parts of the country yesterday morning.

The tremor, measuring 5.0 on the Richter scale, was felt at 8:11:12am, Met office sources said.

The epicentre of the earthquake was in Myanmar, 409km east of the Seismic Centre at Agargaon in the capital.

Kumar expressed concern that the situation can only worsen if it was not dealt with effectively and the state would have to face more severe consequences in the coming years.

On Sunday, Kumar told reporters in Patna, capital of Bihar, that the silt deposited in the Ganges after the construction of Farakka was responsible for the floods and asked the federal Indian government to remove the dam or come out with a siltmanagement policy.

"The current flood situation has been caused by silt deposits of the river Ganga. This situation is the result of silt getting deposited in Ganga after construction of the Farakka dam. The only way to remove silt from the river is to remove the dam," Kumar told reporters after the review meeting on

"If the federal government has any option [other than removing the dam], then it should start working on it," he added.

In his Independence Day (August 15) address, Kumar had raised the issue saying that the depth of the Ganga had reduced following the silt deposition in the river due to the construction of dam at Farakka.

About the government's move to enact the Digital Security Act, he said it is a move to prevent people from speaking freely.

"New laws are being enacted frequently. People would have to face life term imprisonment or pay one crore taka in fine even if they express something through gestures," said Fakhrul.

The cabinet on Monday approved a draft law with a provision of maximum punishment of life imprisonment for spreading negative propaganda through digital devices against the Liberation War and the Father of the Nation.

Fakhrul called upon journalists to decide on what role they should play under the circumstances.

About the proposed Rampal Power Plant, he said the government is setting up the coal-fired plant near the Sundarbans as "it has its own interest in the project".

To pursue its interest, the government is carrying out attacks on people who are staging protests against the power plant, he added.

On forging a national unity against militancy, the BNP leader said other political parties attached many conditions to the issue. He urged all parties to forget everything and get united for at least once to raise voice against militancy.

Biman gets 15 extra

FROM PAGE 1 flights on August 4, it was forced to cancel at least 15 hajj flights due to shortage of hajis. Those flights could have carried over 5,500 pilgrims to Jeddah, Biman officials said.

Due to shortage of hajis, Biman flew flights with over 600 unoccupied seats. Hajj Agencies Association of Bangladesh and the Religious Affairs Ministry blame each other for their "irresponsibility and insincerity" that left many intended hajis unable to fly to Saudi Arabia, sources said.

Against this backdrop, the fate of over 6,000 hajis became uncertain unless Biman got extra slots. Saudi civil aviation authority

granted 112 slots to Biman to carry over 50,500 hajis but the cancellation of 15 flights caused concerns. Biman then asked for more slots from the Saudi authorities citing visa

issuance complications of hajis and

the Saudi aviation authority gave the

Biman slots. It however asked Biman to explain the complications in details, said highly placed sources in Biman. Several hundred hajis, who have managed to get visas, were yet to fly since they could not get tickets. Hajj agencies had not confirmed their tickets and flight schedules, sources at

Camp told The Daily Star. A total of 1,01,758 Bangladeshis are expected to perform hajj this year, likely to be held on September 12 subject to the sighting of the moon.

Motahar Hossain said with its dedicated 51 hajj flights and 19 other scheduled flights, Biman so far carried 24,307 hajis to Jeddah and was hoping to carry the rest of the hajis using the extra hajj flights within the last date, September 5.

"It would not have been possible for Biman to carry all the aspirant pilgrims who are now in Dhaka, unless Biman got permission for more slots from the Civil Aviation Authority of Saudi Arabia," he added.

A Biman official said if dedicated hajj flights seemed not enough to send all hajis to Jeddah, they would still be able to send another 500 to 600 hajis to Saudi Arabia.

HAJIS FORM HIUMAN CHAIN

Frustrated intended pilgrims yesterday formed a human chain and held a protest rally in Trishal of Mymensingh as their hajj agents had rescheduled their flights four times.

Some 70 pilgrims, including 22 women from Sirajganj, Tangail, Jamalpur and Mymensingh, were confirmed to fly on August 5 by a hajj agency. The date was rescheduled four times

later by Ali Asharaf, proprietor of Mauna Travels and Tours in Gazipur, reports our correspondent from Mymensingh.

The pilgrims also held a protest rally and submitted memorandums to the prime minister and minister for religious affairs through Trishal upazila nirbahi officer.

Phones of the officials of the agent remained switched off for the last two days.

committing the killings.

"The defendant's alleged actions strike at the very heart of our county's Muslim community," Queens District Attorney Richard Brown said in a statement on Monday. "Both victims were gentlemen of peace and their deaths are a devastating loss to their families and the community that they served."

Maulana Alauddin Akonjee, 55, and Tara Uddin, 64, were gunned down after they left their mosque on Saturday, Aug 13, in the Ozone Park neighborhood of Queens in an attack that shocked the area's largely Bangladeshi community. Authorities have said the gunman's

motive remains unclear and the possibility it was a hate crime is being investigated. Morel, who has been held without

bail since his initial court appearance last week, will be arraigned on the grand jury's indictment at a later date. If convicted, he faces up to life in prison

without the possibility of parole.

Akonjee, a father of seven, emigrated to the United States from Bangladesh several years ago. Community members who knew him well described the slain imam as a humble man who lived and breathed his religious faith.

Moreover, Queens University is having disputes over ownership. America Bangladesh University has

16 illegal outer campuses across the country apart from its campus on Progati Sarani in Norda. The commission has already sent letters to the deputy commissioners concerned to evict the campuses as per a High Court verdict, said the notice.

IBAIS University is another troubled university, according to the notice. Its board of trustees are divided into two factions and have filed cases against each other.

Sylhet International University in Sylhet and Britannia University in Comilla have similar disputes over ownerships.

The UGC asked students not to get enrolled in the unapproved campuses of five universities -- BGC Trust University Bangladesh, Southern University Bangladesh, University of Science and Technology, University of Information Technology and Sciences and Prime University, said the notice.

"If a student gets enrolled in unapproved universities or illegal outer

campuses of approved universities, the UGC or the Ministry of Education would not take the responsibility for them," the notice read. The commission was inquiring into

the irregularities in the private universities and would update the list of troubled universities later. Students would get information regarding approved universities and campuses and courses on the UGC website, the notice added.

Contacted, UGC Chairman Prof Abdul Mannan said they issue such notices every year for the interest of students.

"In some cases, we noticed that many students, after getting admitted into institutions spending a huge amount of money, get cheated as those institutions are not the approved ones," he said.

Asked how the universities run illegal outer campuses, Prof Mannan said the universities which have such campuses often notify them that they have shut down their operation.

"But all of them do not tell the truth. And we cannot be sure about it," he added.

There are 94 private universities that have government permission. Eighty four are currently operating with some 4.63 lakh students.

"After a while, I found it hard to breathe. At one point, I had almost fainted but I somehow made my way to the gate," he added.
