#### Habiganj 4-Kid Murder Charge framing deferred till August 28

A Habiganj court yesterday deferred charge framing till August 28 in the case for the murder of four schoolboys in Bahubal upazila of Habiganj on February 12.

Habiganj Women and Children Repression Prevention Tribunal special Public Prosecutor, Abul Hashem Mullah Masum, said the court deferred the date because the judge is on leave.

Abul Hashem said Habiganj Women and Children Repression Prevention Tribunal Judge Masruza Parveen passed an attachment order on July 25 for the fugitives Babul Mia, Ustar Mia and Billal Mia.

A police team led by Officer-In-Charge of Bahubal Police Station, Molla Monir Hossain, conducted the operation to attach the properties of the absconding on August 4, he added.

Four schoolboys -- Monir Mia, 7, Zakaria Shuvo, 8, Tajel Mia, 10, and Ismail Mia, 10 --were killed on February 12 due to enmity between two groups in a local Panchayat (village arbitration council), according to the charge sheet submitted to the court.

FROM PAGE 1 national broadcast act has submitted the draft to the ministry which is reviewing it. Within a few days, we will place it before the cabinet for approval," he said.

The information minister was talking to journalists at a press briefing at his ministry office.

On December 23, 2014, the government formed a 38member committee to draft the Broadcast Act according to which a broadcast commission would be constituted immediately after the law comes into effect.

The draft law has a provi-

sion of jail term and fine for violating the rules or regulations of the act and orders or directives of the proposed broadcast commission. Criminal procedures would be followed in case of probe, trial and appeal concerning any offence under the act.

One may face a maximum penalty of three months' imprisonment or a fine of Tk 5 lakh or both for violating the rules or regulations and orders or directives of the commission, it says.

Besides, if anyone runs broadcast without prior approval under the law or other related laws, the guilty person may face a maximum penalty of seven years in jail or a fine of Tk 10 crore or both, the draft reads.

It mentions 27 types of activities that a broadcaster cannot carry out without prior approval from the authorities concerned.

The commission would prepare a guideline for the broadcasters and regularly monitor whether they are properly following the National Broadcast Policy, the guideline and the code of ethics, it says.

The commission would be given the authority to take measures against a broadcaster if any content of broadcast poses a threat to security, territorial integrity, peace, public order and unity of the country or if it is

vulgar, false and malicious. In August, 2014, the information ministry published a gazette on the National Broadcast Policy-2014 for television and radio amid concerns from rights activists and media personalities

about a possible misuse of some of its provisions. About registration o online media, Inu said preparation of the draft of the proposed National Online Mass Media Policy was at the final stage. He added that they had already received more than 1,700 applications for

online media registration, which were being reviewed. "Discussion about how we will register them is ongoing. It's at the final stage," he said, adding that a final decision on registration for online

media would be made based on the online media policy.

The information minister said flow of correct information is required to resist militancy and propaganda.



# 1000-yr-old temple excavated

# Navaratha style temple found in Dinajpur is first of its kind in Bangladesh

The unearthing of a 1000-yearold sculpture of Mohini, the only female avatar of the Hindu god Vishnu, in Madhabgaon village of Dinajpur's Kaharol upazila has archaeologists excited. Not only is the discovery of Mohini unexpected, but the temple itself is designed in navaratha, nineprojection style, an architectural form commonly associated with the Kalinga temples of Odisha as well as temples in Khajuraho in Madhya Pradesh, rather than Bengal. According to Professor

Claudine Bautze Picron, an expert on South Asian iconography and art history, the depiction of Vishnu in feminine Mohini form is the rarest avatar to be observed in eastern India. She has identified the Madhabgaon temple site as a centre for the Vaishnavism tradition within Hinduism, with the temple dating from about the 11th to 12th centuries CE.



The Dinajpur temple, when it was intact, resembled this impressive temple in Odisha of India.

"We found such a rare, brickbuilt structure," says Swadhin Sen, an archaeology professor from Jahangirnagar University and head of the excavation team. "It's a first for Bangladesh."

"A navaratha style temple has never before been discovered in Bangladesh," says another professor from Jahangirnagar's archaeology department.

The temple was discovered in 2014 underneath a 7 metre high earth mound in the village. Excavation began in mid-April this year.

"We have completed the excavation work with the help of 27 local-hired workers, said Swadhin Sen.

The temple's foundations reach almost 8 metres underground, with a 2 metre high structure above land level. The "rathas" consist of different sized vertical projections along the temple's north, south and west sides. There is also a square sanctum which the experts believe was used for worship and a fourentrance is along the eastern edge image discovered. of the site.

structure featuring a curvilinear tower," says Professor Seema Haque of the team. "This too is a very rare feature among the ancient brick temples that have been found anywhere in both parts of Bengal."

According to retired professor of ancient Indian architecture from the University of Kolkata, Dipak Ranjan Das, the site does have some similarity with the similarly unusual Siddheshwar Temple of Bahulara in West

Bengal's Bankura. During excavation, experts have uncovered shards of stone sculptures and pottery as well as decorated bricks and other stone objects. "We presume many of these pieces are part of a chakra disc, conch, mace and parts of legs with garlands. These are all iconographic attributes of Vishnu," says pillared room that is suggested to Swadhin Sen, noting that these be an assembly hall. The temple's are separate to the Mohini

"The sanctum was a super- was probably used until as late as the 16th century, after which it was abandoned for unknown reasons. "We assume multiple deities were worshipped in this edifice," says Sen.

The temple's discovery has not only thrilled the archaeologists but generated great local interest as well. "I have seen that heap of dirt there since my childhood," says centenarian Satyaram Roy of the area. "The site's land measures 49 decimals. I never thought there could be a 1000-year-old temple there!" He hopes the government will take good care of the site.

As news of the temple's discovery has spread visitors from near and far have converged to see it. At the current time the site attracts around 500 sightseers per day.

"This temple is a very good addition to our research in north Bengal over the past 15 years," says expert team member Professor Syed Mohammad

# HC clears way for DMP

There is no bar on the city police continuing collection of information following the HC verdict, he said, adding that the police cannot threaten a person for collecting information which might hamper his personal security.

Any aggrieved person would have the they violate any provision of the DMP rules and regulations while collecting information, Motaher told The Daily Star.

The HC bench of Justice Moyeenul Islam March 15. Chowdhury and Justice Ashish Ranjan Das came up with the judgment after disposing of the writ petition that challenged the legality of the provision.

Petitioners' lawyer barrister Aneek R Haque said they would decide on moving an appeal before the Appellate Division of the Supreme Court after receiving the full text of the HC judgment.

Three SC lawyers, including Aynunnahar the city police was allowed to take any step Siddiqua, filed the petition as a public interest litigation on March 20.

According to the petition, the DMP rules and regulations of 2006 did not authorise the police to collect information about tenants.

Under the provision, information could be collected on individual cases, not on a mass scale, it said.

The DMP on February 29 announced right to take legal action against the police if that it had been collecting "identification information" from landlords and tenants since November last year and asked the city residents to provide information to it by

On March 27, the HC issued a rule upon the government to explain why the provision should not be declared unconstitutional and illegal.

Earlier on March 13, the HC bench of Justice Moyeenul Islam Chowdhury and Justice Md Iqbal Kabir rejected another petition that sought an order to stop collection of tenants' information. The court said under the DMP rules and regulations to prevent terrorism and militant activities.
