

# CALLING ZIA 'FIRST PRESIDENT' 2 more damage suits filed against AL MP

Two more cases were filed yesterday against Awami League (AL) lawmaker Maj Gen (ret'd) Shubid Ali Bhuiyan for calling former president Ziaur Rahman "the first president" of Bangladesh.

Two AL leaders filed the cases with the court of Metropolitan Magistrate Sattabrato Shikder against the lawmaker for his "defamatory" remark.

The two are: Abdur Rahman, vice-president of Bangladesh Jatiya Hawks' League and Azizul Haque Patwary, general secretary of Bangabandhu Foundation central committee.

After a hearing, the magistrate asked the officer-in-charge (investigation) of Sher-e-Bangla Nagar Police Station to investigate the allegation and submit a report by October 20.

On August 17, Shubid, also chairman of the parliamentary standing committee on the defence ministry, at a meeting made the remark about Ziaur Rahman, according to the case statement.

The statement added that the lawmaker not only dishonoured the Father of the Nation by making such remarks, but also violated the country's constitution.

Earlier on August 22, Md Zilani Sarkar, a Jubo League leader in Daudkandi upazila of Comilla, filed another case with the same court against the AL leader demanding Tk 5,000 crore as compensation for his comment.

# 6 fined for power theft

A mobile court fined six persons over Tk 10.95 lakh for using electricity through illegal connections in Chandaona, Baroboika, Bhogra and South Shalna in Gazipur.

The court, led by Fatematuz Zohra, executive magistrate of the district administration, also sued Fazlul Ali, Fazlul Haque, Alif Uddin, Shahab Uddin, Abul Hossen and Mozammel Haque.

It severed their six illegal electricity connections.

# 'RECRUITMENT ANOMALIES' SC seeks opinion on terminated doctors at BSMMU

The Supreme Court yesterday sought opinions from Attorney General Mahbub Alam on how to keep the qualified doctors among 111 who were appointed at Bangabandhu Sheikh Mujib Medical University (BSMMU) as medical officers in 2006, in service.

The apex court asked him to submit the opinions to it by Sunday after discussing with the BSMMU authorities, Sharif Bhuiyan, a lawyer for the doctors, told The Daily Star, adding that the doctors were terminated.

The Appellate Division passed the order while hearing five petitions filed by them seeking review of its February 22 order rejecting their leave-to-appeal petition against a 2010 verdict of the High Court that had declared their recruitment process illegal for "anomalies".

However, the aggrieved doctors claimed that they were recruited on March 1, 2006 following an interim order of the HC, adding that they followed due process of recruitment and had their jobs regularised.

# BBIN MOTOR VEHICLE AGREEMENT On-trial cargo vehicle leaves for Delhi

A cargo vehicle left Dhaka for New Delhi on a trial run under the Bangladesh Bhutan India Nepal (BBIN) Motor Vehicle Agreement on August 27.

The vehicle with garment products will travel to New Delhi via Benapole-Petrapole-Kolkata and Lucknow.

It reached Kolkata on Sunday, and will reach New Delhi on Thursday, said a press release of the Indian high commission yesterday.

Meanwhile, the trial run for a Kolkata-Khulna bus service will take place today at 12:30pm and the vehicle will reach Khulna at 7:30pm on the same day.

The agreement was signed on June 15 last year.

"I got off the bus near Bangabhaban and then moved all the way on foot to Paltan," he said. "It took me till 3:30pm to get to Matsya Bhaban by bus from Paltan, and then I started walking again to the Sheraton hotel intersection."

All the roads to Shahbagh and Farmgate from the Jatiya Press Club were gridlocked around 3:00pm, said commuter Habibul Alam.

"I walked all the way to my Farmgate workplace from the Press Club, as there was no room left for moving on a rickshaw," he said.

The day before, traffic gridlocks reached an unbearable proportion due to a road block by the agitating school students, two VIP passages, and an anti-militancy procession.

the court seeking seven days' remand for him, said police.

Nuruddin, 60, was held at his Paikpara house in the city. Bangladeshi-Canadian Tamim, a "Neo JMB" kingpin and alleged mastermind of the Gulshan attack, was killed along with his two cohorts in the police operation code-named "Hit Strong 27" on Saturday morning.

Police picked up 10 persons including Nuruddin from the area after the incident. Police, however, questioned and released nine of them.

Police quoted Nuruddin as saying during primary interrogation that two youths namely Murad and Rana rented the flat claiming they were employees of a pharmaceutical company.

# Road crashes kill four

Four people were killed in road accidents in the country yesterday.

Our Dinajpur correspondent reports, Md Sazzad Hossain, 18, son of late Dalil Uddin of Birampur upazila, died as a bus hit him at Chararhat in Nawabganj upazila.

Our Thakurgaon correspondent adds, Goni Masud, 44, headmaster of Domino School Bangladesh in Thakurgaon municipality, was killed when a bus hit his motorbike on Thakurgaon-Panchagarh highway at Chowdhuryhat in Sadar upazila.

Locals beat the driver and blocked the road for an hour in protest.

Our Mymensingh correspondent adds, a grocer, Abdul Hekim Talukder, 56, of Netrakona Sadar upazila, died after a motorbike hit his bicycle in Thakurakuna Railway Station area in the upazila.

Meanwhile, Hasan, 10, son of Hasmot Ali of Bhaluka municipality, was killed as a truck ran him over in Bhaluka municipal area.

He said, as per the proposals, an electoral college would be formed with all elected representatives of the district's local government bodies and the former would then elect the 21-member district council.

Other recommendations include inclusion of upazila parishad vice chairmen in the electoral college, mandatory inclusion of the names of candidates' mothers for identification purposes and suspension of any district council member charged or convicted in a criminal case.

The law suggests a maximum Tk 50,000 fine or six months' imprisonment or both for violators of the electoral code of conduct.

Terming the election a landmark, veteran local government expert Dr Tofiq Ahmed, however, told The Daily Star the district council's electoral college system was in contradiction with the constitution and inconsistent with election procedures of other local government bodies.

He said the constitution has long been ignored in this regard and it was unfortunate that a newly proposed law was again contradicting the constitution.

Crucial decisions, such as removing the inconsistencies, should have been taken in consultation with district leaders, he added.

Urging the government to reconsider the changes, Dr Tofiq said the electoral college system was thought of during the law's formulation in 2000, times have changed and the act was full of inconsistencies.
