Following the incident, local administration, police, Iskcon authority and others concerned held a meeting, where the divisional commissioner and superintendent of police assured the temple authorities that a committee will be formed to investigate the situation and highest security for the temple will be ensured, said Rajat Kanti Gupta of Sylhet Puja Udjapan Parishad.

Villagers beat up a police constable suspecting him of being a cattle lifter in Lalmonirhat's Aditmari upazila on Thursday night.

The mob became even more furious when he identified himself as a police member, leaving him critically injured.

Later his colleagues rescued and rushed him to a local hospital, said police sources. Son of Jabbar Ali of Aditmari upazila, constable Saiful Islam, who is now attached

to Special Branch of police in the capital, went home on a four-day leave. Helal Uddin of the same upazila, who

allegedly instigated the incident, was arrested after the victim's father filed a case against four named and 40 to 50 unnamed persons with

Aditmari Police Station, added the sources.

According to the case statement, Helal borrowed Tk 4.4 lakh from Saiful two years back. On Thursday when Saiful went to ask Helal to pay back the money, he began shouting and sought help from the villagers, terming Saiful a cattle lifter. Hearing his scream, the villagers gathered and beat the constable up.

However, Helal's father Abdul Matin denied that his son borrowed money from the cop, saying he (Helal) did not even know Saiful. But Saiful said Helal was his friend.

Helal sought the villagers' help, as he noticed the constable moving suspiciously around a cowshed in the dark, alleged Matin.

The villagers were angry as many cows were stolen in the last one month, said a villager, Nur Islam.

## 3 workers burnt in fire

Three workers are fighting for their lives with burn injuries after a fire broke out in a plastic godown in the capital's Lalbagh yesterday.

Abdul Baten, 28, Humayun Kabir, 17, and Abdul Majid, 25, are receiving treatment at Dhaka Medical College Hospital with 95, 52 and 46 percent burns respectively.

The condition of the patients is critical as their respiratory tracks got burns, hospital sources said.

The fire that originated at a three-storey tin-roof warehouse around 1:30pm spread to the third floor of an adjoining building where the trio were working, said Fire Service officials.
