

#### Lightning kills 2 cousins

Two cousins were killed by lightning at Shibnagar village in Damurhuda upazila of Chuadanga on Friday. The deceased were Tamim Hossain, 12, son of Atiar Rahman, and his cousin Mamun Hossain, 13, son of Motiar Rahman of the village. Officer-in-Charge Fakhrul Alam of Damurhuda Police Station said thunderbolts struck the two while they were fishing in a local water body nearby their houses around 8:30pm. They died on the spot.

#### Man held with firearm

Rapid Action Battalion (Rab) arrested a man with a pistol and bullets from Ghoraghat upazila of the district yesterday. #### 1500 Phensidyl seized, 2 held

Police arrested two alleged drug peddlers with 1500 bottles of contraband Phensidyl syrup from Bhabanipur area in the town yesterday. #### Clinic owner fined

A mobile court here yesterday fined a private clinic Tk 2 lakh for not complying with rules and not maintaining hygienic environment. # devotee in Pabna

Muggers stabbed a Hindu devotee at Pathartola in the district town early yesterday.

The victim, Bashanto Kumar Das, 35, son of Akil Sutro Das, of Dakkhin Nagar village of Dinajpur, is a volunteer serving a Dinajpur temple of Satsangha Bangladesh. "After collecting money for the Dinajpur

temple, from the devotees in Chittagong, he came here by train on the way to Dinajpur early Saturday. To spend the rest of the night, he started for the temple here," said Topon Sarkar Hory, caretaker of Satsangha Bangladesh temple at Pathortola of Pabna. "Around 4:00am, four to five criminals

stabbed him near the temple and snatched his bag containing the collected money. Locals and temple men took him to Pabna Medical College Hospital," he said.

He is now out of danger, said doctors at the hospital.

"It seems Bashanto was stabbed only for mugging," said Abdulla Al Hasan, OC of Pabna Sadar Police Station.

Earlier on June 10, unidentified criminals hacked Nitta Ranjan Pandey, 60, a devotee of Hemayetpur Satsangha Ashram, and later IS claimed the responsibility of the incident.

## Muggers stab Hindu 700 rly quarters under illegal occupation

#### Flats safe haven for anti-social elements in Lalmonirhat

At least 700 of 1050 railway staff quarters under Lalmonirhat Railway Division of West Zone Railway went under illegal occupation during the last three decades, thanks to the negligence of the authorities concerned.

Anti-social and criminals activities occur in the illegally occupied quarters in Babupara, Station Road, Driver Para, Saheb Para, Surkimil Colony, Wireless Colony, Store Para, Hospital Road, Down Yard Para and New Colony areas in Lalmonirhat town but there is hardly any action, said locals.

Now only 350 staff quarters are legally used by railway employees, said sources at Lalmonirhat Divisional Railway Engineer's Office.

Of the 700 other flats, 250 are under illegal occupation by railway officials, 200 by political party men and 250 others by general people, said officials seeking anonymity.

Most of the illegal occupiers have rented the quarters for Tk 1000 to 2,500 a month each, they said.

Local people alleged that drug peddling, gam-

bling and prostitution are conducted in most of the grabbed staff quarters.

Several people living in the railway staff quarters at Saheb Para said they took the flats from railway officials and political party men on monthly payment basis.

They admitted that unwanted incidents frequently occur at many quarters.

Abul Kashem, officer in charge of GRP Police Station in Lalmonirhat, said, "Our duty is to ensure security of train passengers at the stations and trains. If the officials call us, we will conduct drive against alleged anti-social activities in the occupied quarters."

Ariful Islam, divisional engineer of railway in Lalmonirhat, said, "As many of the railway staff quarters remained unused for long, those went under illegal occupation. I have sent letters to the higher authorities seeking decision about these grabbed staff quarters but no response till now."

"I will call railway police to conduct drive against anti-social activities at these grabbed quarters soon," he said.

### Risky bamboo bridge only means

About 50,000 people of two unions in Madarganj upazila have been facing immense sufferings for want of a concrete bridge over the River Kharka for years, thanks to the indifference of authorities concerned. Commuters have managed shortcut journey to reach

their destinations by crossing a 300-foot bamboo bridge over the river that connects Gabergram Bazar and Paschim Tartapara village since 2001. The villagers with the help of local representatives join

hands to make the bamboo bridge on yearly basis spending about Tk 1 lakh in order to facilitate communication for the thousands of commuters, said locals. On the onset of every rainy season, the villagers build

new bamboo bridge there as the old one became very vulnerable for frequent uses by the inhabitants of 15 villages. Especially students and patients of the areas are the worst

sufferers due to the situation. "We are very tired of making the bamboo bridge over the river for long 16 years," said Pulok Parvez, president of

Gabergram Bazar Committee. As the upazila headquarters, upazila health complex, child and mother care centre, schools, colleges, banks, government and non-government offices and Gabergram bazar are located on another side of the river, a large number of villagers, who cross the bamboo bridge with risk of accidents, have

to face immense sufferings daily, said commuters. Contacted, Jugal Krishna Mandal, engineer of Local Government Engineering Department in Madarganj upazila, said they informed the higher authorities about the matter six months ago but to no effect yet.

#### Addict kills baby girl in Bogra

A teenage boy was killed and at least 20 others were injured in a clash between two groups of rival villagers over a disputed land in Bahubal upazila of Habiganj yesterday.

### Threat to agriculture

Locals blame ruling AL leaders

Illegal lifting of sand from Laghata River in Kamalganj upazila of the district has been posing a threat to the riverside people and agriculture.

Due to lifting of sand, large areas of cultivable land on both sides of the river have become barren and infertile, said Abdul Karim Kim, general secretary of Bangladesh Poribesh Andolon (Bapa), Sylhet chapter.

Marginal farmers in the upazila are unable to cultivate crops by using the water from the Laghata River, he added

When this correspondent visited the area on August 27, he found a huge quantity of sand being lifted from the river. A lot of water is also being wasted during the process.

A sand worker seeking anonymity said Towfiq Ahmed, chairman of Potonushar Union Parishad (UP) and Abul Bashar, general secretary of the Potonushar Union unit of

Jubo League, are lifting sand from the river. Every day, 10/12 trucks carrying sand are

posing a threat to a section of the road from Jugibeel area, said local farmers Ahad Mia, Delwar Mia and Burhan Mia. Locals dare not protest the sand lifting activities as the lifter is an influential local elite, they added.

Each truckload of sand is sold at Tk 700 to Tk 1,000, sources said. Upazila AL General Secretary Rafiqur Rahman

said they could not repair the Potonushar union main road due to shortage of sand, so he asked Abul Basharto lift some sand for the work. Abul Bashar said, "I don't know about

this matter. The sand workers gave you wrong information." Towfiq Ahmed said, "I am not involved

in sand lifting, but I know some villagers are lifting sand."

Mohammad Mahmudul Haque, upazila nirbahi officer of Kamalganj, said "We conducted mobile court drives and fined several sand lifters. We will take immediate steps to stop illegal sand lifting."
