General traders will be eligible to participate in the auction for these categories. General Traders may also apply for General Stalls and Food Stalls, Exporters, Manufacturers, Manufacturing Associations, Government/Autonomous Bodies, Chambers/Trade Associations,

Banks & Assemblers will be given preference for allotment of GS. (iii) Location map and numbers of Pavilion, Stall and Restaurant will be available in DITF-2017 Lay Out Plan kept at EPB Fair Secretariat and will also be available in DITF website. (iv) The quoted rate shall not be below the aforementioned "Floor Rate" in clause (A) and applicants should quote the rate in order of preference. Successful/selected bidder will have to pay 15% for

VAT & 5% for Tax on quoted rate as per Government rules in addition to the quoted amount. For local applicants, allotment of general stalls and food stalls will be done by lottery. Allotment for Premier Pavilion, General Pavilion, Premier Mini-Pavilion, General Mini Pavilion, Restaurant and Premier Stalls will be given to the highest bidders. In case of non-compliance of this rule, the security money and rent will be forfeited and cancellation of allotment (xviii) Any entrepreneur or enterprise which had been declared unfit to participate in DITF activities


