#### 3 ARSON CASES Court accepts charges against Khaleda, 79 of alliance

She leaves for KSA COURT CORRESPONDENT

A Dhaka court yesterday accepted charges against BNP Chairperson Khaleda Zia and 79 leaders and activists of the BNP-led 20-party alliance in three arson cases filed in January and February last year.

The court also issued arrest warrants against 71 activists of the alliance, including former BNP lawmaker Syeda Asifa Ashrafi Papia, showing them to be fugitives.

The others facing an arrest warrant include Maruf Kamal Khan, Sutan Salauddin Tuku, Habibunnabi Khan Sohel, Saiful Alam Nirob and Azizul Bari Helal.

Nine other accused, including Khaleda, are now out on bail in the cases.

Sessions Judge's Court passed the order after scrutinising the charges and documents. The court also ordered the officer-in-charge of

Darussalam Police Station to submit reports by October 18 on execution o the arrest warrants. Police in May and June

this year pressed charges against Khaleda and over 80 leaders and activists of the alliance for arson on buses during its threemonth-long non-stop movement last year.

Later on August 10, Khaleda got bail in nine arson cases after surrendering before two separate Dhaka courts.

Khaleda, accused in over 25 cases including ones over corruption, was not present at court yesterday as she went to Saudi Arabia for performing hajj. Amanullah Aman, now on bail, also went to perform hajj.

## Govt thinking of law to seize war criminals' wealth: Anisul

Amidst growing demand for confiscation of convicted war criminals' wealth, Law Minister Anisul Huq yesterday said the government was mulling over formulating a new law.

"People are demanding for taking steps about the properties...We are mulling taking steps following legal procedures...We will do it (begin the process) as early as possible," he told a press briefing at his Bangladesh Secretariat office in the capital yesterday.

The demand, including distributing the confiscated wealth among families which fell victim during the 1971 Liberation War, has long been made by freedom fighters, martyrs' families and pro-liberation organisations, including Ekatturer Ghatak Dalal Nirmul Committee.

properties can be taken by amending International Crimes (Tribunals) Act 1973 or by formulating a new law. Properties cannot be taken back

amending the act so that organisations, including Jamaat-e-Islami, can be tried over crimes committed during the Liberation War. The lack of clearcut provisions for punishment is considered a major obstacle to trying such organisations.

# Charges filed against 8 of Mymensingh, Jamalpur

The others are over killing of seven people of Kejaikanda Konagaon on August 5; brutal torture of two freedom fighters and their disappearance on November 12 and torture of one Abdul Latif, a freedom fighter's brother, and torching of his house

on November 12. The remaining incidents are the killing of Azizur Rahman on November 20 for assisting freedom fighters; and killing of doctor

disqualifications of a lawmaker but this issue of the minsters did not fall under the purview of article 66 even after they were punished.

In an oblique reference to a recent comment of a High Court judge that his ministry was "not paying enough attention" to Chief Justice Surendra Kumar Sinha's call for establishing a separate secretariat for the judiciary, Anisul said it was actually beyond his ministry's authority and that a

new law needed to be enacted. He said the present government was committed to ensuring independence of the judiciary while his ministry would do everything
