Toilets occupying river land a new way to kill Surma

Taking a stroll along the banks of the Surma river with the sun on your back amid hills and trees on its both sides is a unique experience that even compels one to hold their breath for a while to appreciate the river's beauty.

But, these days, the holding one's breath part has literally come true, not because of the splendour, but rather the stench than comes out of the newly built toilets on the ground floor of an under construction twostory building on the east side of the Surma river, near the Kazirbazar bridge in the area under Sylhet city.

There are eight such toilets and the waste is directly released into the river through pipes.

The toilets have been built by Kazirbazar Fisheries Agent Association (Kazirbazar Matsya Arotdar Samity). The association leaders said they have built the toilets

for the wholesale fish traders who sell fish near the area, so that they can take breaks in between work.

They also claimed they are constructing the building and the toilets on their own land.

Protesting, the green activists said the river banks cannot be sold. As per the Land Management Manual, no one is allowed to construct a building on the river banks let along toilets, they said.

Surma is already under constant threat of grabbing and pollution, said the green activists, adding, if buildings like these keep on mushrooming -- it will be the end of the river.

The spot is less than half a kilometre away from the Sylhet City Corporation, though they did not take any initiative regarding the matter, locals alleged.

During a recent visit, this correspondent saw that the construction of the toilets has almost been completed and are already in use for over a month.

"The illegal occupiers encroach upon the river banks, which not only impede the water flow but also can trigger waterlogging," said Tareq Ahmed, a resident of Kazirbazar.

"Before the air used to be filled with fish smell, and now the stench of human waste...," said Raihan Ahmed, his younger brother.

whom this correspondent met in the area after he got out of the building using the toilet, said, "This place is helpful for us. We can use the bathrooms whenever we want and take rest on the second floor.

When asked about the river pollution due to the human waste he did not answer.

Contacted, Jahangir Alam, general secretary of Kazirbazar Fish Traders' Association, said the land

belonged to the association and they have constructed the structure with their own funds. He also claimed that the SCC was informed.

But he failed to show any legal

documents regarding the ownership of the land. A city corporation official, seeking anonymity, said they were not informed about the matter. He said in

2013 they took an initiative to con-

struct some public toilets on the river

banks but due to protests and objec-

tions from the residents they did not. "The SCC should take necessary measures to stop this atrocity," said Abdul Hye Al Hadi, chief coordinator of Save the Heritage and Environment.

Abdul Karim Kim, the Surma river keeper and general secretary of Bangladesh Paribesh Andolon, Sylhet chapter, said, it was illegal to obstruct the natural flow of the river.

He also demanded that the corporation take quick action under the

Robber suspect in custody uses phone

He is wanted in over a dozen cases

A robber suspect was seen talking over cellphone in police custody while he was undergoing treatment with bullet wounds in the left leg at Rajshahi Medical College Hospital yesterday morning.

Samaddi alias Kanu, 30, of Shibganj in Chapainawabganj, who is an accused in over a dozen of criminal cases, was arrested during a "gunfight" between police and a robbery gang in Niamotpur of Naogaon on September 3, said Niamotpur police.

The phone belonged to his wife, said Rimon Rahman, a local journalist, who was taking photographs during the incident.

Two Rajpara police constables, who were supposed to be on guard, were not found there at that time, said Rimon.

The constables were not available for comments.



The accused took advantage of the indifference of the policemen scheduled to be there, said Iftekhair Alam, an assistant commissioner of Rajshahi Metropolitan Police, adding that actions would be taken after an inquiry.

An accused in custody cannot use a mobile as per law, he added.

reports: Dumbas are being smuggled into the country through different border points in Lalmonirhat.

Border Guard Bangladesh (BGB) men of Mogholhat camp seized five dumbas along the border while being trafficked into the country on Wednesday.

Nazrul Islam, 53, a cattle trader at Islampur border of Patgram upazila, brought six dumbas from India a week ago, and sold them for around Tk 1.3 lakh each to a cattle trader of Dhaka.

The livestock officials have kept the cattle markets in Pabna and Sirajganj under strict surveillance to monitor whether the animals were fattened by using drugs, reports our Pabna correspondent.

A woman was found dead in her in-laws' house in Fatehpur

Around 10:00am, members of her in-laws informed them that Topu committed suicide, they said, adding, they found Topu's hanging body after reaching her in-laws' house. Topu's parents claimed that they wanted to file a case but

police denied to take it. After the incident, they were absconding. Nasim Uddin, officer-in-charge of Chatkhil Police Station, said they will not take any case without getting the autopsy report.

on strengthening health workforce, which is vital to achieving universal health coverage, a key part of the Sustainable Development Goal, leaving no one behind.

At present, the density of health care providers in the region is 12.5 per 10,000 population, which is less than the WHO recommended minimum 44.5 per 10,000 population.

Khetrapal said while countries are trying to achieve expanding health workforces across the region, increasing staff retention particularly in rural areas and providing further training to enhance skills are also important.
