2012 RAMU MAYHEM UP chairman detained for alleged links

Detectives yesterday detained an Upazila Parishad chairman of the district for his alleged link to the 2012 attacks on Buddhist temples in Ramu of Cox's Bazar.

Tofail Ahmed, chairman of Naikkhangchhari upazila, was detained on "specific allegations", said Sanjit Kumar Banik, superintendent of Bandarban police.

He was detained from Rajarmath area of the town around 2:00pm, he

Earlier, Tofail appeared before a local court and also met Bir Bahadur U Shwe Sing, state minister for Chittagong Hill Tracts affairs. As he came out of the minister's

house, a team of Detective Branch of police picked him up and took him to their office for interrogation, the SP said.

Tofail stands accused in 11 cases. Sources said he was a leader of Islami Chhatra Shibir, student wing of Jamaat-e-Islami, when he was a student at Chittagong University. He had later got involved in Jamaat politics, they added.

Earlier in 2012, Tofail denied his involvement with Jamaat but admitted that he was a Shibir activist at CU

He went into hiding following the mindless arson attacks on the Buddhist temples and Buddhist community in Ramu on September 29, 2012.

Earlier, members of the Police Bureau of Investigation (PBI) arrested him at the Sundarban Hotel in the capital's Karwan Bazar on January 11. He was also arrested in November

2013 but was elected upazila chairman for the second time as he contested the polls from jail.

He later obtained a bail from the High Court and was discharging his duties as the chairman.

However, the LGRD ministry suspended him on October 10 last year after a court took the charges against him into cognisance. But Tofail was reinstated on October 14 following an HC order that came in response to his writ petition.

Investigators said the other 10 accused are their accomplices who played various roles in the murder.

They are Amanur's close aides Kabir Hossain, Samir and Farid Ahmed, his brothers' bodyguards Anisur Rahman Raja and Mohammad Ali, security guard Babu, Jubo League leaders Alamgir Hossain, Nasir Uddin, Sanowar Hossain and ex-municipality

sittings. He was elected uncontested in the January 5 parliamentary election in 2014. He won a by-election in 2012

from the same constituency.

Earlier, Prime Minister Narendra Modi strongly condemned what he called the "cowardly terror attack". "I assure the nation that those

behind this despicable attack will not go unpunished," Modi said in a series of Twitter posts. The raid came as tensions were

already running high in India's only Muslim-majority region, which has faced more than two months of protests following the July 8 killing of the commander of another Pakistanbased separatist group.

At least 78 civilians have been killed and thousands injured in street clashes with Indian security forces, who have been criticised by human rights groups for using excessive force.

In an even stronger response, Indian Home Minister Rajnath Singh tweeted: "Pakistan is a terrorist state and should be identified and isolated as such."

Pakistan rejected allegations that it was involved. "India immediately puts blame on Pakistan without doing any investigation. We reject this," foreign ministry spokesman Nafees Zakaria

told Reuters. India and Pakistan have fought two of their three wars since independence from Britain in 1947 over Kashmir, which is divided between them. Both claim the former princely

US ambassador to India, Richard Verma, also "strongly condemned" the Uri attack, which comes weeks after Secretary of State John Kerry visited New Delhi.

After that meeting Kerry urged Pakistan to do more to combat terrorism, while also announcing the resumption of trilateral talks with India and Afghanistan this month in New York, leaving Islamabad looking

isolated. WORST BODY COUNT IN YEARS The military death toll was one of the

worst it has suffered in a single incident during years of conflict in Indianruled Kashmir.

Before this attack, 102 people had been killed in separatist attacks in India's part of the Himalayan region this year. Among them were 30 security personnel, 71 militants and one civilian, according to a tally by the New Delhi-based South Asia Terrorism Portal.

Modi recently raised the stakes in the neighbours' decades-old feud by expressing support for separatists in Pakistan's resource-rich Baluchistan province.
