Mother tries to commit suicide after killing son in Rajshahi

STAFF CORRESPONDENT, A mother reportedly tried

to commit suicide after killing her seven-year-old son in New Budhpara area of Rajshahi city on Saturday night.

The deceased, Shahriar Alam Kabya, was a class-I student of Sheikh Rassel Model Primary School.

Police admitted his mother Taslima Khatun, 35, in an unconscious state to Rajshahi Medical College Hospital. She needed 13 stitches on her head. According to Kabya's

father Rofiqul Islam on Saturday evening he brought Kabya home from his paternal grandfather's house and left for his pharmacy. Upon returning, he broke open the door as no one responded from inside and found his son and wife in a pool of blood.

Police quoting Rofiqul said Taslima had psychological issues. Police recovered a knife and a scissor from the spot.

A new trend breeds seat crisis at JU library

The long queue of students with their bags waiting for the door of the central library to open so that they can grab a seat before anyone else is a common scenario between 6:30am and 7:30am at Jahangirnagar University.

Sometimes students who are tired of standing for a long time put their bags on the ground in a queue and come back later to reclaim the spot just before the gate opens.

The early rush of the students to the library to occupy a seat speaks volumes of the dearth of space.

The university was founded in 1970, but the library opened for students in 1986. Currently, it can accommodate only 436 whereas students triple of its capacity go there every day to study with their examinations ahead. As a result most students have to come back after failing to get a seat.

"We have to keep our bags in line by 6:30am if we are to ensure a seat in the library... Standing in the queue for a long time is exhausting," said Salekul Islam, a master's student of economics.

CRIMINAL CASES SC upholds Rizvi's bail

The Supreme Court yesterday upheld the High Court orders that had granted bail to BNP Senior Joint Secretary General Rizvi Ahmed in five criminal cases filed between 2013 and 2015.

His bail was upheld as the chamber judge passed "no order" on five petitions seeking stay on the HC orders that granted him six months' bail in the cases on September 7 following five bail petitions of Rizvi.

He cannot get released from the jail as he was arrested in another criminal case, Jahirul Islam Sumon, a lawyer for Rizvi, told The Daily Star.

Gas leak alert ignored

Say Tongi police; file murder case against 10 including owner over Tampaco fire

Although factory workers informed of a gas leak three days prior to the September 10 fire, authorities concerned of Tampaco Foils Ltd took no step to address it, leading to the loss of 34 lives till date, said Tongi police on filing a murder case yesterday.

Police in primary investigation found that the factory's buildings in the Tongi BSCIC industrial area became unfit for use four years ago, electrical wirings there were faulty and the boilers had no expiry labels, Officer-in-Charge Firoz Talukdar told this correspondent.

"Though they (management board) were aware of it, they did not take any measures. As a result, these people have died and it is tantamount to killing," he said.


