

Search for Managing Director of Bangladesh Submarine Cable Company Limited (BSCCL) (State Owned Public Limited Company)

Bangladesh Submarine Cable Co. Ltd (BSCCL), a state-owned Company that provides international data & voice bandwidth throughout the country, invites application from bona-fide citizens of Bangladesh to fill up the position of Managing Director, Headquarter in the city of Dhaka.

The Managing Director (MD) is the Chief Executive of the Company. He is responsible to lead a highly professional and technical team which maintains consortium submarine cable system at the cable landing station in Cox's Bazar and Kuakata and provides connectivity to international communication superhighway for data and voice communications.

The consortium submarine cable, namely SEA-ME-WE-4 and SEA-ME-WE-5, spreads from Singapore to France. The MD is responsible for overall management, operation and maintenance of the submarine cables in wet and dry segments and arrangement of sufficient spare parts for the landing stations. The landing station is maintained in an international standard in comparison with other member countries of the Consortium. The MD looks after the interest of the country in the Management Committee meetings of the Consortium where the submarine cable top level experts participate.

BSCCL has expanded business through obtaining IIG license along with Submarine Cable License and is presently supplying Internet Cloud/IP Transit to all big internet players including BTCL. BSCCL has already entered in the stock market since 2012 and is presently considered as one of the best companies in the share market.

Required Academic Qualification: The candidate must have B.Sc-Engineering (Electrical & Electronic/Electrical/Electronics/Telecommunications) from any recognized University; Candidates having MS/PhD/MBA will be taken into consideration in selection procedure.


