

# Two rights orgs worried over remand of child 'offender'

Ain o Salish Kendra and Bangladesh Legal Aid and Services Trust on Monday expressed deep concern over the remand of Tahrim Kaderi alias Russell, the 14-year-old son of dead militant suspect Tanvir Kaderi.

Mentioning the Children Act 2013, the organisations termed the remand "contradictory" to the constitution of Bangladesh and also demanded necessary steps in this regard, said a press release.

A juvenile court on Sunday remanded Tahrim for three days after he was arrested for "attacking" the law enforcers during a raid on a militant den in the capital's Azimpur on September 10.

His father Tanvir killed himself and his mother, Abedatul Fatema, 35, was injured during the raid and later arrested for suspected militancy.

In the release, the organisations said there was limited scope to remand children as their trial should take place in a children's court as per the 2013 act.

Moreover, police will have to interrogate children in presence of their families or relatives, and the law enforcers will not wear their official uniforms during the interrogation, said the release.

# Gazipur councillor's wife found strangled

The wife of a Gazipur City Corporation councillor, whose body was found in their Uttara Sector 7 house on Monday morning, has been found to have been strangled as per Dhaka Medical College morgue sources.

Nusrat Jahan Tumpa, 30, and her husband, ward 2 councillor Solaiman Miah, were last seen by her brother Sayeed who dropped them off at their house on road 4 on Sunday night, her father Nazrul Islam told The Daily Star.

A housemaid called up her mother next morning on finding the house locked and they broke in through the window to find the body on her bed, added Nazrul, a former general secretary of BNP's Konabari union unit.

Doctors at Crescent Hospital in Uttara declared her dead, he said. Uttara police said they recovered the body, containing bruises, that night and sent it to the morgue for an autopsy.

Konabari Police Outpost In-charge Sub-inspector Rafiqul Islam said Solaiman, son of Haji Nurul Islam of Bhabanipur area in Kashimpur, was on the run. His cellphone was switched off.

Nazrul said the couple had an altercation after Nusrat found a woman's photo in Solaiman's cellphone while they were going to Jamuna Future Park with Sayeed and his wife on Sunday.

Married for 12 years, they have an eight year old son, Nafi, who was with Nusrat's parents in their Uttara house on Sunday night.

Nazrul alleged that Solaiman began torturing Nusrat five years into their marriage and the couple used to frequently quarrel over Solaiman's alleged drug abuse and extramarital affairs.

# Bangladesh, Myanmar agree to resolve issues thru talks

Bangladesh and Myanmar agreed to resolve all the bilateral issues between the two neighbouring countries through dialogue.

The consensus came as Bangladesh Prime Minister Sheikh Hasina and Myanmar State Councillor Aung San Suu Kyi on Monday had a bilateral meeting on the sidelines of the 71st United Nations General Assembly

(UNGA) at the UN headquarters.

Briefing reporters after the meeting, the prime minister's Press Secretary Ihsanul Karim said the two leaders discussed outstanding issues between the two neighbouring countries and agreed to resolve all bilateral issues through dialogue.

During the meeting, Hasina welcomed the Kofi Annan Commission on issues of Rohingya.

She said Bangladesh has set an

example of effective cooperation with its other neighbours in combating terrorism and violent extremism.

Hasina invited the Myanmar leader to visit Bangladesh and Suu Kyi gladly accepted the invitation.

The premier's ICT Advisor Sajeed Wazed Joy, Foreign Minister AH Mahmood Ali, Principal Secretary Md Abul Kalam Azad and Foreign Secretary Md Shahidul Haque were present, among others.

# DND canal encroachment rampant

The pump, set up at Shimrail, is not functioning properly as the canals, which used to carry rain water to the pumping station failed to carry it due to encroachment and blocks at different points.

Though a pump is there but water does not reach the pump properly, he said and suggested setting up four pumping stations for the DND areas to solve its waterlogging problem.

Also, keeping water retention pond in front of a pumping station is a must, he added.

The DND area is situated between the Buriganga and Sitalakhya rivers and in the floodplain of the Meghna river. The Buriganga covers both the south and a part of the west side and the Sitalakhya is on the east.

At the beginning of the DND Project (1962-68) the area was primarily rural and the land was mainly agricultural

excluding the existing canals and homesteads. Now it has changed from an agro-rural to agro-urban area.

The urbanisation process is randomly progressing without any planning and the areas devoted to agriculture and water bodies are continuously being engulfed by it. Demra, Shyampur, Kutubpur, Matuail, Siddirganj, Godnail, Madaninagar, Bhuiga, Pagla, Fatullah and many other DND areas are being urbanised at a very fast pace.

In 1962, the DND project consisted of over 80 percent of agricultural land, and as on 2008 the agricultural land is less than 25 percent. In a separate study, the Japan International Cooperation Agency (Jica) projected that by 2032 there will be 94 percent of urban related areas while other minor parts will be water bodies or just open space.

Chief Engineer of Dhaka Water Development Board (Central Zone)

Abul Kalam Azad said Executive Committee of the National Economic Council (Ecnc) on August 8 approved a Tk 558.2 crore project titled, "Development of Drainage System (2nd phase) of DND Areas" to effectively address the vexing waterlogging problem of the areas.

The components of the project include excavating 93.98km canals, constructing 13.5km walkways, setting up two pumping stations at Shimrail (seven pumps having 5.5 cumec capacity) and Adamji Nagar (6 pumps having capacity of 5.5 cumec each), setting up three pumping plants at Pagla (having capacity of .28 cumec each), Shyampur (having capacity of .14 cumec each) and Fatullah (12 pumps having capacity of .28 cumec each), he said.

Currently there is a pumping station (four-pump) with 3.63 cumec capacity each at Shimrail.
