President Barack Obama, in New York at the UN General Assembly with world leaders, called on Americans "not to succumb to fear" as presidential candidates Hillary Clinton and Donald Trump sparred over how best to combat terror attacks.

Obama stressed that investigators saw no connection between the East Coast bombings and the Minnesota stabbings, where police said the assailant made "some references to Allah" in carrying out the attack.

Ahmad Khan Rahami, 28, was initially spotted by a police officer outside a bar in Linden, New Jersey around three hours after the FBI released his mugshot and described him as "armed and dangerous." When the officer approached the

suspect, he immediately whipped out a handgun and shot the officer in the torso, hitting his protective vest, said acting Union County prosecutor Grace Park.

In a subsequent police shootout, Rahami was shot multiple times outside an auto repair shop, several blocks west of the bar, she said.

The handgun was recovered at the scene and Rahami was taken to hospital where he underwent surgery, officials said.

Neither the first officer nor a second hit in the head by a fragment of bullet suffered life-threatening injuries, the prosecutor said.

Rahami was stretchered into an ambulance in the town of Linden, wearing a bloodied bandage on his right arm and moving his head moments after being taken into

custody. "Critical but stable," New York police commissioner James O'Neill told CBS News yesterday when asked if the suspect would likely survive.

\$5.2 MILLION BAIL, WIFE IN PAKISTAN He was charged with five counts of

attempted murder of a law enforcement officer and on two unlawful weapon possession counts, Park announced.

A judge set bail at \$5.2 million. Little is known about a suspect, who was not on the authorities' radar before the attacks. Born in Afghanistan, he worked at his family's fried chicken restaurant in

Elizabeth, New Jersey, and is a US citizen. Investigators will now focus on whether he had co-conspirators and on his motive in allegedly bombing New York's Chelsea neighborhood

scene of the Manhattan blast, and five pipe bombs were discovered late Sunday in a trash can in Elizabeth.

Kerry and Russian Foreign Minister Sergei Lavrov opened a meeting of the 23-nation International Syria Support Group (ISSG) in New York, where world leaders have gathered for the UN General Assembly. UN chief Ban Ki-moon opened

the assembly debate with a call to end the fighting in Syria. "I appeal to all those with influ-

ence to end the fighting and get talks started," Ban said. Monday's strike on the aid convoy

provoked outrage from UN officials, with aid chief Stephen O'Brien warning that if deliberate "it would amount to a war crime". The International Federation of

Red Cross and Red Crescent Societies said Monday night's raid destroyed at least 18 of 31 vehicles, as well as a Red Crescent warehouse in Orum al-Kubra in Syria's Aleppo province. "Much of the aid was destroyed,"

the IFRC said in a statement, stressing that "the attack deprives thousands of civilians of much-needed food and medical assistance."

Omar Barakat, who headed the local Red Crescent branch, was wounded in the strike and later died, IFRC spokesman Benoit Carpentier told reporters in Geneva.

'DARK DAY' FOR AID WORKERS

UN humanitarian agency OCHA said that the movements of all aid convoys in Syria had been suspended as an "immediate security measure" after the raid.

The attack marked a "very, very dark day for humanitarians in Syria and indeed across the world," OCHA spokesman Jens Laerke said, adding that it was "paramount that we are able to establish the facts through an independent investigation."

A Syrian military source denied any regime involvement, telling state media: "There is no truth to media reports that the Syrian army targeted a convoy of humanitarian aid in Aleppo province."

The Russian defence ministry also said that both its forces and the Syrian air force "did not conduct any strikes against the UN aid convoy."

The strike came just a few hours after the Syrian army announced the end of the truce on Monday night, accusing rebels of failing to "commit to a single element" of the US-Russia deal.

Heavy fighting almost immediately resumed, with activists and AFP correspondents on the ground in Syria reporting bombardments overnight and yesterday in several areas.

In the battleground city of Aleppo, air raids and artillery fire hit rebel-held districts until approximately 2:00 am, an AFP correspondent said.

The ceasefire was already under massive strain after a US-led coalition strike on Saturday hit a Syrian army post near the eastern city of Deir Ezzor, where government forces are battling the Islamic State jihadist group.

Issuing a suo moto rule (a move

the court makes on its own), the HC asked the UNO and the OC to produce relevant documents and papers on the allegation and conviction against the schoolboy before it on the same day. The HC also granted Sabbir, a

student of Protima Bonki Public High School, bail and asked him to appear before it on that day with relevant papers to ascertain his age.

It also asked the UNO and the OC to explain why the conviction and sentence of Sabbir under the ICT Act through a mobile court should not be declared illegal.

The HC bench of Justice M Enayetur Rahim and Justice Ashish Rajgan Das came up with the order and rule following a report published in The Daily Star yesterday under the headline "Boy jailed for FB comment about MP".

Supreme Court lawyer Khurshid Alam Khan had placed the report before the bench for passing necessary orders, saying that convicting and sentencing a person under the ICT Act by a mobile court on the basis of a general diary was an abuse of powers.

An investigation was supposed to be launched into the allegation as a GD had been lodged against Sabbir, but the schoolboy was detained on the basis of the GD and a day later he was produced before the magistrate and was sentenced, he

Khurshid said the victim has to file a first information report with a police station against the accused and a court would then conduct the trial proceedings.

A mobile court can convict an offender on the spot during committing of an offence, but the mobile court sentenced Sabbir while he was in custody, the lawyer said.

He said the UNO, who led the mobile court, has reportedly considered Sabbir to be 19 years old even though he is a ninth grader.

If the schoolboy is under 18, he should have been tried in the juvenile court, Khurshid Alam added.

cult time." Two of the world's biggest stars, Pitt and Jolie formed a Hollywood power couple second to none, so famous they were known simply by

their combined first names. The A-listers wed in France in August two years ago, but have been a couple since 2004 and have six children together, three of whom are adopted.

Jolie is seeking physical custody of the children, with visiting rights for Pitt, according to TMZ, which said she was not seeking spousal support.

The couple was last seen together in public in mid July, just ahead of their second wedding anniversary.

Pitt came into the public eye 25

years ago with a much-talked-about shirtless debut as eye-candy in the hit movie "Thelma and Louise" -and went on to become a household name in Hollywood. A three-time Oscar nominee for

his acting, Pitt took home a golden statuette for best picture in 2014 as a producer of "12 Years A Slave."

He has built a resume of varied film roles, starring alongside some of the industry's other mega-watt stars: with Tom Cruise in "Interview with a Vampire," Anthony Hopkins in "Legends of the Fall" and George Clooney in "Ocean's Eleven." 'CLOSURE'

Jolie catapulted to stardom with her role in 1999's "Girl, Interrupted," taking home an Academy Award for best supporting actress for her fierce portrayal of a rebellious woman in a mental institution. She has since played everything

from a fairy tale villain ("Maleficent") to a sexy video game heroine ("Lara Croft: Tomb Raider") to the widow of assassinated American journalist Daniel Pearl ("A Mighty Heart"). The red carpet darling is now

better known for her humanitarian work than for her tabloid-ready actions, having served for several years as a goodwill ambassador for the United Nations High Commissioner for Refugees. More recently, she has been a vocal advocate for victims of sexual

One of the world's most visible symbols in the battle against cancer, she underwent a double mastectomy and removal of her ovaries and fallopian tubes to prevent an aggressive form of the disease that killed her mother, grandmother and aunt.

an earlier report had requested Bangladesh to provide further details on the mitigation measures taken for the power plant project considering the findings of the SEA.

Since the oil spill in the Sundarbans in 2014, the Unesco has been pursuing the government to monitor the long-term impact on the biodiversity of the Sundarbans.
