Raped college girl Huge croplands lost to Teesta, Dharla

About 450 bighas of land with standing aman paddy goes into rivers in Lalmonirhat

The Teesta and Dharla rivers devoured huge croplands in 12 villages under three upazilas of the district in the last one week.

The fresh erosion has taken an alarming turn in the last 6/7 days devouring several homesteads and a huge tract of cultivable land leaving a good number of people in utter uncertainty.

Due to the recent erosions, about 450 bighas of land with standing aman paddy have been devoured by the two rivers.

The affected villages are Kurul, Karnaour, Etapota, Char Kulaghat, Shiberkuti, Dakkhin Shiberkuti, Bagdora and Kalmati in Sadar upazila, Kutirpar and Balapara in Aditmari upazila, and Dawabari and Sindurna in Hatibandha upazila.

Amjad Hossain, 55, of Shiberkuti village, said the Dharla River has already devoured his two bighas of aman paddy field in the last three days while the rest two bighas face serious threat.

Farmer Sabur Ali, 48, of Etapota village, said the villagers are passing their days in constant fear of losing the rest of the croplands if the authorities concerned do not take immediate steps to check the erosion. The Teesta River has already

devoured five out of ten bighas of aman cropland while the rest are facing threat of devouring, said Faridul Islam, 55, of Dawabari village. Kulaghat Union Parishad Chairman

Idris Ali said he had already informed the authorities concerned about the worsening situation but they did not take any initiative to protect them despite repeated pleas.

Lalmonirhat Water Development Board Executive Engineer Abu Bakkar said they were conducting protection work to check erosion at the major vulnerable points, but it is not possible to protect the entire area due to fund limit.

Rigan, also known as Rafiul Islam Rafi and Ripon and Hasan, divulged the information to interrogators, according to officials of the Counter Terrorism and Transnational Crime unit of the Dhaka Metropolitan Police (DMP).

The 20-year-old "Neo JMB" operative was caught wounded during a police raid at Taj Manzeel, also known as Jahaj Building, in Kalyanpur on July 26.

On Sunday, Rigan gave his confessional statement before Metropolitan Magistrate Sadbir Yasir Ahsan Chowdhury.

During interrogation by the officials of the DMP unit, Rigan said one Robin gave them the firearms training and lessons in "motivational classes" at the dens.

Rigan wanted to go to Syria but Robin used to tell him that it would take some time. Robin also told him to do "something big" in Bangladesh to show off power before going to Syria, said one of the interrogators quoting Rigan's statement. On Robin's instructions,

Rigan, according to investigators, was introduced to several Shibir activists in Bogra in 2011.

wrote on Facebook, liked posts, and kept chatting with Sabbir," said an official, quoting Rigan.

He said Sabbir convinced

him to go to Syria to join "the war against America and its allies" to save the Muslims there. Sabbir also convinced two of his friends, Masud and Shihab, to do the same.

On July 23 last year, Rigan left home telling his mother and sister that he was going to his coaching centre.

But, he went to Shibganj Bus Stand with Masud and Shihab where Sabbir was

waiting for them. "Sabbir brought the three of us to Dhaka on a bus from Shibganj. It was evening. We were asked not to look around and we complied," the official quoted him as saying.

During the group's oneyear stay in the capital, they changed their locations at least five times, investigators claimed.

While staying in the dens, Rigan was introduced to Robin, Imran, Sohan, Iqbal, Obhi, Tapas, Abir and

Nayeem. He also told interrogators that two to three people unknown to him frequented

the dens.

Interrogators suspect that those people could be key militant leaders. Two weeks prior to the police raid, the militants

moved to the fourth floor of the six-storey building in Kalyanpur, investigators claimed. Rigan told investigators

that 11 militants were in the apartment during the raid. He used to offer his Of them, Iqbal fled firing his AK-22 while Rigan was injured and captured.

Sribordi Health Complex

Only 8 doctors for three lakh people!

Sribordi Upazila Health Complex is limping for shortage of doctors and other staff, much to the sufferings of local patients, especially the poor ones.

Due to the situation, patients do not get proper treatment and medicines at the 31bed hospital.

At present, on an average 300 to 350 people come to the outdoor department for treatment while 100 to 150 come to the emergency department every day. But there are not enough physicians to treat the patients, said Upazila Health and Family Planning Officer Dr Md Ibrahim Titon.

Officially, there are 15 doctors against 23 posts at the health complex meant for at least 3 lakh people in the upazila.

while five are on deputation, one is on maternity leave and another one has remained absent for long without permission, said Dr Titon.

Resident Medical Officer (RMO) Ziaul Haque has long been working at Central Medicine Stores Depot (CMSD) in Dhaka and four others at different government Md Anwar Hossain said they have already

Operation Theatre and anaesthetist. Besides, there are only five nurses against 10 posts, said Dr Titon.

Noor Mohammad, who was admitted to the health complex a few days ago with complaints of vomiting and abdominal ache, said he had to buy all prescribed medi-Of the 15, only eight doctors work here cines from outside pharmacy as the hospital did not provide him with any medicine.

Dr Md Anisur Rahman, in-charge of the hospital, admitted that there is acute shortage of doctors and serious crisis of medicine at the health complex.
