

Ensuring safe food a far cry

Law, regulations in place; Food Safety Authority formed but it cannot go into action due to shortage of manpower

A nationwide outcry against widespread food adulteration had prompted the government to replace the archaic Pure Food Ordinance of 1959 with a stringent Safe Food Act in 2013.

The promises were high-sounding -- there would be a single entity instead of 15 agencies in charge of curbing

food adulteration and chemical contamination; there would be dedicated courts dealing with food offenders; and plaintiffs would get 25 percent of the proceeds gained from penalties to be slapped on adulterators.


Three years on, consumers in Bangladesh have very little to cheer about. It took the government over 15 months to form the Bangladesh Food Safety Authority (BFSA) as mandated by the new law. The idea was that the BFSA would be consumers' one-stop answer to concerns over safe food.

Twenty months have passed since the inception of the BFSA, but the government has not yet sanctioned its required manpower. It has been eight months since the BFSA sought a 1,004-strong


organogram but the body, which has been expected to address the nation's food safety worries, is still limping with just an 11-man workforce. A chairman, four members, a secretary and five directors -- that is the

workforce the BFSA now has under its disposal.

With such a poor strength what the BFSA could pull off are: drafting seven rules required for making the Safe Food Act 2013 operational, SEE PAGE 2 COL 2

BANGLADESHI DEPORTED FROM KL Now in jail in 2 arms cases

Malaysian daily says he had met a 'Gulshan attack suspect', but no confirmation from Bangladesh police

The Bangladeshi businessman deported by the Malaysian authorities early: from Bangladesh, Focuses this month was accused in two arms cases around 11 years back.

Piyar Ahmed Akash was made an accused in the cases filed with Feni Sadar Police Station and Sudharam Police Station in Noakhali in 2005 for · before midnight. stealing two AK-47 rifles from 10 truckloads of sophisticated weapons: seized in Chittagong on April 2, 2004.

Outsider meddles with drug; DMCH patient dies

A patient died in Dhaka Medical College Hospital yesterday, after a non-professional person allegedly administered a drug into the nebulizer of the victim.

Biplob Mondal, 24, from Keraniganj was undergoing treatment at the neurosurgery department of the hospital for his head injuries caused by a motorbike accident in Keraniganj on September 18.

He suddenly started complaining breathing problem around 3:00pm yesterday and his relatives sought help from a nurse to put him on a nebulizer but no one attended him, said his cousin Subash Mandal.

Instead of the nurse, a youth came in and said the nurse had sent him. "We did not know who he was. We thought he might be somebody from the hospital," said Subash.

The youth named Sumon administered a drug in the nebulizer machine and as Biplob started inhaling, his condition began to deteriorate, claimed Subash.

Biplob died a few minutes later, he added.

Soon after his death, Biplob's relatives caught Suman and beat him up before handing him over to the DMCH SEE PAGE 2 COL 6

BSF kills two

Bangladeshis

In Jhenidah, BSF men gunned down cattle trader Jashim when he along with some other men went to Baghadanga border area to bring in cattle from India, reports our correspondent.

Lt Col Tajul Islam of BGB 58 battalion said they heard some traders went to the border area in Maheshpur upazila around 3:30am yesterday to fetch Indian cattle.

"As the traders reached Hazrakhali area in India, BSF soldiers from Ramnagar camp fired shots at them, leaving Jashim dead on the

9-year-old killed in city road crash

He was hit, run over by bus while jaywalking

His mother was waiting at home to have lunch together on his return from Juma prayers. But what returned instead was his body wrapped in a shroud.

Nine-year-old Robiul Awal, a madrasa student, was killed as a speeding bus ran him over at Karwan Bazar in the capital yesterday. He was a student of Amborsha

Hafizia Madrasa in the same area. The accident happened around 2:00pm when Robiul and two other boys were trying to cross the Kazi Nazrul Islam Avenue near the Dhaka Wasa building at Karwan

Bazar, said a witness. Tea vendor Mohammad Imon said a speeding bus of a private company hit and dragged Robiul yards towards the Bangla Motor intersection. The other two boys were unhurt.

The bus fled.

Locals rushed critically injured Robiul to Dhaka Medical College Hospital where doctors declared him dead.
