2 killed in Kushtia AL infighting

Two Awami League activists were killed and around 30 people injured in a factional clash over establishing supremacy in Majhpara village of Kushtia Sadar upazila yesterday.

The dead are Iman Ali, 35, of Majhpara and Sahabuddin, 55, of Baidyanathpur.

Sub-inspector Atiqur Rahman,

in-charge of Abdalpur Police Camp, said several hundred supporters of Jhaudia Union Parishad Chairman Keramat Ali got locked in a clash with supporters of Bokhtiar Hossain, a former chairman of the union, around 9:00am.

Bokhtiar is also the president of Jhaudia union AL, while Keramat is the joint secretary of Kushtia Sadar upazila AL.

Police said there had been a longstanding rivalry between the two AL leaders over establishing supremacy in the area. Things got worse after Keramat was elected the UP chairman as an independent candidate in June 11, defeating AL nominee Bokhtiar.

The rival groups used arms and sharp weapons during the hourlong clash yesterday. They also vandalised at least 25 houses in the village, some 36 kilometres off Kushtia town.

According to police, the two dead were supporters of Keramat and activists of Jhaudia union AL. Iman died of bullet wounds while Sahabuddin of hacking injuries.

Many of the injured received treatment at Kushtia General Hospital and private clinics in the

Proloy Chisim, Kushtia superintendent of police, and Zoynul Abedin, additional superintendent of police, rushed to the spot

around 10:00am. Zoynul said law enforcers later brought the situation under control. Additional police forces were deployed at the village to avert any

law and order situation.

Autopsies were carried out on the bodies of the two AL men at Kushtia General Hospital in the afternoon. Police later handed over the bodies to the deceased's families.

Preparations were underway last night for filing two cases with Kushtia Islamic University Police Station in this regard.

FROM PAGE 16 Bangladesh and India are jointly implementing the project despite strong opposition from local environmental groups. Indian power company BHEL has been awarded a contract to set up the plant.

The state minister said the government will come up with its response to the observations and queries from Unesco, and then it will make a decision considering the future situation.

Nasrul said the government will conduct an environmental impact assessment study for each of the power hub to find the right solution to mitigate the impact of

power plants on environment. The government has planned to boost power generation to 40,000 MW by 2030 from the existing 10,000 MW, he added.

"We'll have to conduct a study to determine the impact on environment before taking up any project," he told the workshop.

Officials of ERM, a consulting firm which conducted the cumulative impact assessment on Siddhirganj power plant, made a presentation on their study report.



Moreover, a new 10-storey building, Dhaka Medical-2, with 600 beds is functioning without any permanent employees, he added.

At the burn unit, most of the bandaging job, which should actually be done by trained people or doctors, is done by unauthorised outsiders, a source at the DMCH said.

"We informed the hospital authorities and the health ministry but there was no response. Three hundred employees are required only for the unit whereas there is none," said Samanta Lal Sen, the coordinator of all government burn units in the country.

The outsiders work under the doctors' supervision, he added.

About 400 patients receive treatment at the unit.

Meanwhile, the hospital authorities have formed a three-member committee to look into the death of Biplob Mondal, 24, who had been admitted to the hospital with head injuries after a motorbike accident began to deteriorate, he claimed

Biplob from Keraniganj, who had been undergoing treatment at the neurosurgery department, suddenly started complaining of breathing problems around 3:00pm on Friday. His relatives sought help from a nurse to put him on a nebulizer but no one attended to him, said his cousin Subash Mandal.

A youth came in and said the nurse sent him. "We did not know who he was. We thought he might be somebody from the hospital, Subash said.

The youth named Sumon then administered a drug into the nebulizer machine and as Biplob started inhaling, his condition Biplob died a few minutes later.

Soon after his death, Biplob's relatives caught Sumon and beat him up and handed him to the DMCH camp police, said Sub-Inspector Bachhu Mia, in-charge of

the police outpost. He was later handed over to

secured place. "The fire became more devastating because of those chemicals."

However, it still remains unknown what exactly caused the blaze. Titas officials declined to discuss it, saying their job was to investigate gas and gas line related issues.

Gazipur district administration, industries ministry, Fire Service and Civil Defence and Department of Inspection for Factories and Establishments also formed committees to investigate the Tampaco inferno.

Meanwhile, death toll from the incident rose to 36 as search and rescue team found another body at the site yesterday.

Deputy Director Aktaruzzaman of Gazipur Fire Service said remains of a body was recovered from the debris around yesterday noon. The body could not be identified immediately, he said.

So far, 29 bodies have been identified.

The fire broke out after a huge explosion at the foil factory on the morning of September 10 when workers were changing their shift at the four-storey factory.

Twenty-four bodies were found that day while around 50 persons suffered injuries as the fire led to the factory building collapse three days ahead of the Eid-ul-Azha.

At least 11 persons are said to remain missing.

On Wednesday, relatives of nine of the 11 workers gave DNA samples to the authorities concerned to

identify their loved ones. Two cases were filed against the Pasha died in Zimbabwe in 2001.

The SITE Intelligence Group, a US-based organisation that monitors terrorist activities, on Friday said the Islamic State released a video from Bangladesh for the first time about the attackers. About five hours before that

post, SITE Intelligence in another tweet said: "#ISIS promoted forthcoming vid from #Bangladesh, marking 1st production from the group's division there. Appears to focus on #Dhaka attack."

In the video, in which they appear to have spoken before the attack, they are heard saying that they would target anyone who they call the "enemies of Islam".

Happy to get

The school has 175 students from pre-primary to class-V and is run by Education and Development Foundation, a Spanish NGO.

The sources said the school building was constructed at a cost of Tk 70 lakh and the contractor handed over the building to the authorities concerned on August 10.

ATM Rafigul Islam, coordinator of Education and Development Foundation in Mymensingh, said the union parishad member went to the school the same day and claimed Tk 2 lakh.

"As we expressed our inability to pay, he locked the school and left," added the coordinator.

He also warned not to open the school until he received "his dues", the sources said.

"We tried to manage the issue locally and informed local elites and political leaders," said the official.

"Finally, we informed Kamrul Ahsan Talukder, upazila nirbahi officer of Bhaluka, of the matter and he called the UP member at his office and asked him to open the school on August 20," said the coordinator. However, the member did not

pay heed to the UNO's instructions. The UNO along with upazila

officials and Officer-in-Charge Mamun-or-Rashid of Bhaluka Police Station went to the school Thursday afternoon and opened the school. The school managing commit-

tee has filed a general diary with Bhaluka police. "Punitive measures will be taken

Merkel now wants migrant deals with other countries

German Chancellor Angela Merkel, under fire at home over her refugees policy, called Saturday for Europe to secure deals with third countries to send back migrants who do not qualify for asylum.

Speaking after talks in Vienna with leaders along the Balkan migrants trail into Europe, Merkel said the continent must "stop illegal immigration while living up to our humanitarian responsibilities". To this end "it is necessary to get agree-

ments with third countries, especially in Africa but also Pakistan and Afghanistan... so that it becomes clear that those with no right to stay in Europe can go back to their home countries," she told reporters. Last year hundreds of thousands of peo-

ple, many fleeing the Syrian war, trekked up

from Greece through the western Balkans to

northern Europe, in the continent's biggest migration crisis since 1945. Populist parties across Europe have stoked concerns about the influx, not least Alternative for Germany (AfD), which has stolen support from Merkel's centre-right

party in recent state elections. On Monday Merkel said for the first time that the influx could have been better handled.

In March, under pressure from Austria, Balkan countries closed their borders, and the flow has since slowed dramatically, although 100-150 still make it to Austria every day, Vienna says.

The same month the EU struck a deal with Turkey -- home to more than three million refugees -- under which Ankara promised to halt the inflow in return for billions in aid and other sweeteners.

The pact may yet collapse, however, in the wake of the July 15 coup attempt in Turkey.

As illustrated by a large fire at a refugee camp on the island of Lesbos on Monday, Greece meanwhile remains under severe strain, with more than 60,000 people

stranded. An EU scheme to relocate them -- and others in Italy -- around the bloc has failed to live up to expectations, while extra administrative assistance promised by the EU has been insufficient.

Merkel on Saturday said that EU countries' participation in the relocation scheme has been "too slow", saying this could "increase the pressure" on Greece's border with Bulgaria.

"It is unacceptable that the countries that first receive (the migrants) bear the burden," Greek Prime Minister Alexis Tsipras said in Vienna, according to ANA.

The PM said if a party makes a mistake, it has to pay for it. "We went for elections but the BNP-Jamaat did not join it. They burnt people to stop the elections. Am I to give them the scope for burning people?

"But they took part in local government

elections," she said. Trying the war criminals was a national obligation, Hasina said, adding, the Awami League had promised the country that it would ensure the trials of war criminals.

She also said her government, through awareness campaigns, has been able to increase the involvement of the people against militancy. "The people are now more aware... they

are the ones informing us [about militant activities]," she added.
