Quader tells parliament

The construction of the Padma bridge will be visible from December, Minister for Road Transport and Bridges Obaidul Quader told parliament yesterday.

"The work for setting spans on piers of the Padma bridge will begin in December and January next year," Quader said while replying to lawmakers' queries.

The minister said 38 percent of its construction had

already been completed.

Replying to a query, Quader said the government was going to implement the country's 55km first expressway from Dolairpar point of Mayor Mohammad Hanif Flyover to Bhanga of Faridpur via Buriganga-1 bridge and the Padma bridge.

He said a number of flyovers will also be built under the expressway project along with service lanes to expedite the road communication of south-western region.

SC stays bail of ex-BASIC Bank officer STAFF CORRESPONDENT

The Supreme Court yesterday stayed till October 31 a High Court verdict that granted permanent bail to sacked deputy managing director of BASIC Bank

Fazlus Sobhan in two cor-

ruption cases.

Following two petitions filed by the Anti-Corruption Commission (ACC) seeking stay on the HC verdict of September 8, the apex court asked the ACC to file two leave to appeals with the SC against the HC verdict by October 31.

Now, Fazlus cannot get released from jail, said ACC's lawyer Khurshid Alam Khan.

On January 8, the ACC arrested Fazlus at the capital's Motijheel in two corruption cases involving Tk 58 crores. The arrest followed the filing of over 50 cases by the ACC in September last year against a number of bankers and borrowers linked with the Tk 5,000crore BASIC Bank scam that took place between 2010 and 2013.
