Two AL Men Killing 7 arrested

Police yesterday arrested seven local Awami League activists in connection with Saturday's factional clash at Majhpara village in Kushtia Sadar upazila, which left two men of the ruling party killed and 30 others injured.

The arrestees are Raihan Ali, 46, Mobarak Hossain, 45, Abdul Aziz, 45, Kutub Uddin, 52, Md Azim Uddin, 44, Shamim Biswas,

20, and Akam Uddin, 32. They are from Majhpara and Bodiyanathpur villages in the upazila, said Shafiqul Islam, officer in charge of Islamic

University Police Station. Kushtia Chief Judicial Magistrate's Court sent them to jail.

Hindu family under threat

Local tout got their 35-decimal land registered through forgery

Premchand Robidas and his family in Aditmari upazila of the district are passing worrying time amid threat by a local tout who got their 35 decimals of land registered through forgery 15 months ago.

Premchand, 55, is owner of 116 decimals of land including homestead and 100 decimals of arable land at Goalpara village of Mahishkhocha union in the upazila.

"Last week, I came to know that local tout and drug peddler Shah Alam, 38, son of late Idris Ali, got my 35 decimals of arable land registered through forgery on February 5 in 2015, as he was trying to occupy my rest 81 decimals of land in the same way," said Premchand. "My five-member family depend

on agriculture. I have no relation with the tout. I never gave away my

photograph and voter ID card to anybody or put my thump impression on any paper," said illiterate Premchand, known as a very simple and honest man in the village.

Premchand's wife Arati Bala

Robidas said Shah Alam and his men are giving them threat as they complained to local people. "Two hundred people at the village sat together and asked Shah Alam to return

the land to its owner Premchand. After this, an angry Shah Alam and his relatives are trying to file false cases against the villagers," said Rafiqul Islam, a local. Mosaddek Hossain Chowdhury, chairman of Mahishkhicha union

to get back his land from Shah Alam. Alam did the forgery with the help of Rokon Uzzaman, a deed writer of Aditmari sub-registry office, showing another tout as land owner, office

parishad, said they will help Premchand

sources said.

Asked about the matter, Rokon Uzzaman said, "It was a great mistake. am trying to return the land to its owner Premchand from Shah Alam." Contacted over mobile, Shah Alam

declined to talk to the journalists. Ruhul Amin, president of Deed Writers Association at Aditmari sub-

registry office, said he will call a meeting soon to take necessary steps against guilty deed writer Rokon Uzzaman and help Premchand to get back his land. Kamrul Hossain, sub-registrar of

Aditmari sub-registry office, said, "Another sub-registrar was in charge during the forgery incident. A civil case has to be filed with the court, appealing for cancellation of the alleged false document. After its cancellation following court order, the land owner can take legal action against the tout, deed writer and others involved."

Jute output exceeds target

Farmers happy as prices are high in C'nawabganj

Jute farmers are happy in the district due to good production of the fibre and its fair prices in the local markets during the ongoing harvesting season.

They are busy cutting and processing the crop in Sadar upazila and Shibganj upazila as harvesting is going on in full swing. At present, most of the growers along

with their family members are engaged in harvesting, decomposing, segregating and selling the fibre. Sajdar Rahman, deputy director of the

Department of Agriculture Extension (DAE) in Chapainawabganj, said production exceeded the target as the crop grew well and the cultivation area was bigger. He said huge enthusiasm had been created among the growers this season and it would continue in future.

Farmers cultivated jute on 1,000 hectares of land against the target of 5,56 hectares, producing 7,550 bales while 500 hectares were cultivated last year, producing 4,599

bales, Sajdar said. Farmers are cultivating Tosha 38 (04), locally known as Misti Pat, local varieties

CVL 1, D 154, locally known as Tita Pat, and Mesta, and the quality of the jute is good, the DAE official added. Raw jute is selling at between Tk 1,500 and

Tk 1,600 per maund in the local markets this season, depending on quality. The market prices early in the harvesting season are lower than in the previous year, according to market sources. The price was Tk 2,200 last year. Jute grower Atabur Rahman of Shibganj

upazila, said he cultivated jute on six bighas of land in the current season and produced 48 maunds of raw jute, spending just Tk 18,000. He sold his produce at Tk 1,500 per maund. He hoped that he would be able to sell jute sticks for Tk 2,000 to Tk 2,500, so his net profit would be about Tk 30,000 to Tk 35,000.

BSF kills another

Indian Border Security Force (BSF) shot dead another Bangladeshi national in Chhat Karaibari border area under Roumari upazila of Kurigram yesterday, two days after the killing of a person in the same upazila. The deceased was Baharul Islam, 28, son of Baktar Hossain

of Chhat Karaibari border village of Datbhanga union under Roumari upazila, reports our Kurigram correspondent. On September 23, BSF shot dead a 25-year old Bangladeshi citizen in Roumari and a cattle trader in Jhenidah. Two days

earlier, the BSF killed another man in Lalmonirhat. Baharul, who was involved with smuggling, went inside 'no-man's land' of India-Bangladesh border at Chhat Karaibari village around 4:00am yesterday, said Subedar

Bangladesh (BGB) Battalion at Datbhanga in Jamalpur. BSF of Gutalu (Dipchar) camp in India opened fire at Baharul, hitting him on his chest, he said, adding that Baharul somehow returned to Bangladesh territory where he fell to the ground and died.

The body will be sent to Kurigram Sadar Hospital for autopsy, said Rafiqul Islam, sub-inspector of Roumari Police Station.

Man killed by addict son

A man was beaten to death allegedly by his addict son as the latter failed to get money for purchasing drugs in Sarishabari upazila of the district early yesterday.

The deceased is Momtaj Uddin, 55, of Phuldah Nayapara village under Bhatara union in the upazila.

His son Omar Ali, 18, who was used to taking drugs, demanded some money for the purpose, which the father refused, police quoted locals as saying.

Omar entered his father's room around 3:30am yesterday and started searching for money there.

Momtaj woke up from sleep and seeing Omar searching for money, he rebuked him.

An altercation followed and at one stage, angry Omar beat up his father mercilessly with a stick, leaving him critically injured, said Rezaul Islam, officer-in-charge (OC) of Sarishabari Police Station.

He was rushed to Sarishabari Upazila Health Complex, but succumbed to his injuries on the way, said the victim's family members. Omar fled the scene

soon after the incident. Police recovered the body and sent it to Jamalpur General Hospital morgue for autopsy, said the OC.
