A man who is believed to have masterminded operations of Jagrata Muslim Janata Bangladesh (JMJB) in Rajshahi in 2004 and been freed on being arrested three times since then was apprehended by police in Rajshahi's Bagmara upazila yesterday.

Arrested on a tip-off at the Hamirkutsa polythene market area around 11:00am, Mahtab Khamaru is wanted in a case filed with Bagmara Police Station in June under the anti-terrorism act, said Officer-in-Charge Selim Hossain.

Son of Mohammad Ali Khamaru of Talgharia village, he is also accused in two torture and extortion cases of 2004, the trials over which are now ongoing, he added.

The around 50-year-old identifies himself as a member of Jatiyatabadi Jubo Dal.

However, police say he

was a regional commander of Jama'atul Mujahideen Bangladesh (JMB) and the second-in-command of executed JMB leader Siddiqul Islam Bangla As per information

revealed over the years by sources including JMB, locals, law enforcers and intelligence agencies, Mahtab was arrested on November 27, 2005; March 9, 2007 and July 23, 2012

According to a US embassy cable released by Wikileaks, he was released in 2005 as per the then prime minister Khaleda Zia's elder son Tarique Rahman's request to the state minister for home.

The sources said prior to announcing their presence, top JMB leaders operated under the JMJB banner on an experimental basis in Naldanga of Natore, Bagmara of Rajshahi and Atrai and Raninagar upazilas of Naogaon.

Militants' bodies to be buried unclaimed

Says Home Minister Asaduzzaman

The bodies of all militants killed in law enforcers' raids will be given to social welfare organisation Anjuman-e-Mafidul Islam for burial as unclaimed bodies, Home Minister Asaduzzaman Khan Kamal said yesterday.

On September 22, five dead Gulshan café attackers and a chef were buried at the Jurain graveyard in the capital as nobody claimed their bodies, the minister said.

"We will hand over the rest of the bodies to Anjuman-e-Mafidul Islam as their families are not willing to receive them," Kamal told reports at his ministry office.

The bodies of 14 other militants killed in separate police raids at

Kalyanpur, Narayanganj, Mirpur and Azimpur have been kept at the Dhaka Medical College (DMC) morgue following autopsies.

Recently, DMC urged Dhaka Metropolitan Police to take necessary steps to take back the militants' bodies from its mortuary because it was overflowing.

Woman jumps off Ctg hospital building

A 25-year-old woman reportedly attempted to commit suicide by jumping off a four-storey hospital building at Anderkillah in Chittagong city yesterday.

Shamima Talukder, daughter of Abul Bashar, did a midwifery course at the adjacent nursing institute of the Jameson Red Crescent Maternity Hospital in 2014, said in-charge of the hospital Mostafizur Rahman.

When Shamima was found on the ground, she said no one was responsible for the incident and did not disclose the reason behind the attempt, he said, adding that she was in touch with the institute and the hospital and might have gone there to visit a friend.

Shamima is undergoing treatment at Chittagong Medical College Hospital. Kotwali police are investigating the matter.

Family of stolen baby refuses to leave DMCH

The poor family of a three-month-old baby girl, who was stolen from Dhaka Medical College Hospital (DMCH) on Thursday, has been waiting anxiously at the hospital for the last four days for her rescue.

Her destitute parents, who are from Shibchar upazila of Madaripur, yesterday said they would not leave the hospital until they got the girl back.

"I want my daughter back. I will stay if it takes time," said Nasima Begum, mother of the child.

The woman and her three daughters had been staying in the hospital for the last two and a half months with her husband Bahadur Dhali who was admitted to the hospital for a brain tumour.

On Thursday, a woman introducing herself as an attendant of an expecting

mother stole the baby girl. Bahadur said he could not go here and there to search for his daughter due to his

weak physical condition. It will be difficult

for them to go back to their village and return again to Dhaka, he added.

After Bahadur underwent a surgery about two weeks earlier, he was about to get released from the hospital on Saturday, but the family refused to leave after the baby was stolen.

An unidentified woman stole the girl by tricking her elder sister into bringing the baby out of the hospital building on Thursday afternoon.

The woman identified her as Khadiza,

said Nasima. Nasima, 28, a mother of three daughters, said the woman, clad in burqa and aged about 35 to 40, went to the family at the corridor of the neurosurgery ward and exchanged pleasantries.

She told Nasima that she was attending her sister who was expecting a baby. She inquired Nasima about her daughters and

also said she was a mother of four sons. Later she tricked Nasima's eldest daughter Shorna, 10, when Nasima was sleeping,

Relations with govt not always cordial for media's critical role

Indian press council chairman tells Dhaka discussion

STAFF CORRESPONDENT Relations between the mass media and a government cannot always be cordial because of the critical watchdog role the media has to play, said Justice Chandramauli Kumar Prasad, chairman of Press Council of India (PCI), in the capital

yesterday. It is possible only if an ideal government is in place, he told a bilateral discussion on "Media development and Indo-Bangla relationship"

organised by Jatiya Press Club on its premises. A journalist's capability to question with confi-

dence makes journalism a great job, he observed. Justice Prasad is leading an 11-member PCI delegation comprising renowned editors and journalists, who arrived in the city on a five-day visit.

The PCI, established in 1966 by the Parliament, with the objectives of protecting press freedom and improving the standards of journalistic practice, is an independent body, in the formation of which the government has no direct intervention, he said.

with the Press Council of Bangladesh (PCB). Igbal Sobhan Chowdhury, media advisor to the prime minister, said that the media community has been demanding for more empowerment of the press council to defend press freedom and

rights of journalists. Chowdhury told the Indian delegation that Bangladeshi televisions channels are not shown in India although all the Indian channels are shown uninterruptedly in Bangladesh.

Prasad said it is not due to any prohibition but due to regulatory reasons.

The Indian delegation explained that regulatory rules require a high amount of fees to downlink foreign channels in India, adding that they would raise Bangladesh's concern at relevant

Monjurul Ahsan Bulbul, president of Bangladesh Federal Union of Journalists and senior vice-president of the National Press Club, said that the issue was raised at all levels including with the former premier of India but to no avail.

PCB Chairman Justice Md Mamtaz Uddin Justice Prasad added that his council would like Ahmed and Jatiya Press Club President to sign a memorandum of understanding (MoU) Muhammad Shafiqur Rahman were also present.

Khoka's Gazipur land confiscated

In the first phase, the towers will be built in Dhaka, Chittagong, Gazipur, Narayanganj, Sylhet and Comilla, he said. Barracks are also being constructed in all districts to miti-

The accused killed his elder brother Abdul Mannan and raped his elder sister Jomila Khatun after abducting them, he
