He repeatedly questioned me about it and I replied I did not write

that. "Then I was taken to the MP's house. I saw that the MP was sitting on a sofa. I was produced before the MP. He [the lawmaker] asked me what I had written against him. Then he hit me twice. I didn't mind, thinking he might be angry. The MP asked the OC

to take me to the police station. "I was taken to the police station where the OC severely tortured me blindfolded and threatened me with crossfire. Fearing crossfire, I confessed I wrote that. The OC asked me not to write such things anymore. After three days, I was taken to the UNO's room. The UNO kicked on my chest, and I fell unconscious. Someone took me away. I was taken to the police station and the OC told me I was handed two years' imprisonment."

Sabbir burst into tears and told the court that he wanted justice. The court asked him if anybody had

taught him to say all these before it, and whether he had carried marijuana.

He replied that nobody had taught him, and that he does not smoke marijuana.

"We have formally communicated with the Nepal government and told it that we would not be able to attend the Saarc summit," a top official of the Bangladesh foreign ministry told The Daily Star yesterday.

Asked about the reason, the official said Dhaka in a formal letter has informed the Saarc chair that Islamabad made "uncalled for reactions after the execution of war criminals in Bangladesh that amount to direct interference in the internal affairs of a sovereign country, which is totally unacceptable."

Diplomatic tensions between Bangladesh and Pakistan have long been escalating, with each government summoning the other's envoy to lodge strong protests over the execution of war criminals, mostly Jamaat leaders for their crimes against humanity during the Liberation War in 1971.

Diplomatic sources said there was an early indication that uncertainty could loom over the summit following the recent escalation of diplomatic tension and developments in the South Asian region. There were media reports that

The telecom regulator has blocked Istition, a popular Bangla blog in Bangladesh, at a law enforcement agency's request. On Sunday, Bangladesh

Telecommunication Regulatory Commission (BTRC) directed the International Internet Gateway opera tors and other relevant operators to block Istition immediately until further notice.

Top BTRC officials have confirmed the matter but declined to make official comments on it. "In many cases, we also get

requests from intelligence agencies [to block various sites] and we have nothing to say about it," said one of the officials. "We don't block anything on our own. Sometimes, the BTRC works on

he added. The BTRC officials said Istition was blocked just in Bangladesh and it could still be viewed from abroad
