Learning at two schools in the district is being hampered as the classrooms go under water even after a moderate rain. About 1,000 students of

Jharbari High School and Jharbari Government Primary School in Shotogram union under Birganj upazila suffered as their classrooms go under water if it rains.

The students have to attend their classes in ankle-deep water that entered due to incessant rain from Friday.

Maisha, a student of Jharbari Government Primary School, said classrooms and the playground of their school often go under water if there is a little rain. Many students avoid attending classes due to the water-logging as it often causes coughing and itching. "It is really difficult for us to keep our legs under water for a long time," she added.

Md Kawsar Hossain of the same school said stagnant

problems and many skip classes for this reason. Headmistress Shahnaz

Parvin Jharna said her school, which was founded in 1935, is the oldest primary school in the district and has 294 students.

Blaming the poor drainage system for the waterlogging, she said they have been holding classes in inundated classrooms during the rainy season for the last six years. Shahnaz said when the water recedes it smells so bad that it is quite impossible for the students to stay in their classes for long.

She said she had requested local UP Chairman KM Kutubuddin several times to solve the problem but in vain.

This correspondent tried to reach Kutubuddin for his comment but he did not receive the phone call.

Jharbari High School Headmaster Golam Mostafa said such water-logging would continue until a drain is built to pump out the water.

A lawyer has filed two cases against eleven newsmen of different regional newspapers and online portals with senior judicial magistrate court in Kalapara upazila town, accusing the defama-

In the cases, one filed against seven journalists on Sunday and another against four others on Monday, Senior Judicial Magistrate Md Anisur Rahman asked the officer in charge (OC) of Kalapara Police Station to take lawful action after proper investigation, said OC GM Shah Newaz.

According to the case filed by lawyer Jalal Uddin Talukder, the accused published news in their media, terming him 'communal' and he filed a Tk five lakh defamation suit against each.

Mejbah Uddin Mannu, president of Kalapara Press Club, said the two cases are false and those were filed to harass the journalists.

SUDDEN BUS STRIKE IN SIX DISTRICTS

Commuters suffer

Thousands of passengers are suffering due to a sudden bus strike called jointly by the Bus Mini-Bus Sramik Union of Barisal and Jhalakathi.

The indefinite strike started from yesterday, protesting against Chairman of Pirojpur Sadar Upazala Parishad Md Mojibur Rahaman Khalek, who tortured a bus driver on September 24, said, President of Bus Sramik Union in Jhalakathi Md Mojibur Rahman.

Road communication between Barisal and Jhalakathi, Pirojpur, Khulna, Bagerhat and Barguna has been disrupted due to the strike.

Jhalakathi Bus Sramik Union, was taken to Pirojpur Sadar Hospital and then shifted to Jhalakathi Sadar Hospital for his safety, Mojibur added.

"We gave the authorities two days to settle the issue, but none pay any heed to it, so we were forced to call the indefinite strike for our rights," he said.

The sudden strike brought untold sufferings for the commuters as they did not find any transport.

"I wanted to go to Barisal to visit a doctor, but there is no transport," said Dulal, who was waiting with his sister for a bus at Bagri bazar of Rajapur.

"I had to pay five times more fare than usual for going to my college in Rajapur," said Kartik Chandra Das, a lecturer of Rajapur Degree College in Jhalakathi.

Like Kartik, some passengers hired auto-rickshaws at higher fare for going to their destinations. "All kinds of communications

will be suspended if we do not get justice for the torture on our colleague," the workers threatened.

No steps had been taken to solve the problem till filing of this the report at around 5:00 pm yesterday.

"We are trying sincerely to solve the problem as soon as possible," said Subhas Chandra Saha, superintendent of police in Jhalakathi.

Five bamboo bridges for flood-hit people

Fulchhari upazila administration has constructed five bamboo bridges on temporary basis on different roads, that got damaged following breach of Ratanpur flood control dyke at Singira, to restore communications between the upazila and district headquarters.

Of the bridges, one was constructed at Purbo Salua and two at Hatathpara on Fulchhari-Goonvari road, one at Hajirhat on Goonvari-Badiakhali road and another at Dhakkhin Burail on Kalirbazar-Machervita road.

During the last flood, breaches developed in the dyke on the bank of the river Jamuna, damaging 35 kilometres of roads. Five concrete bridges collapsed and a bailey bridge was affected partially due to high velocity of surging water.

Hasan Ali, a rickshaw-van puller of Purbo Salua village, said they had to face acute financial crisis as they could not ply the rickshaw-van in the area after collapse of the concrete bridges.

Upazila engineer of Local Government Engineering Department AKM Akhterul Ahsan said they have already written to the higher authorities for fund to construct new concrete bridges but to no effect yet.

Brutality on newlywed to divorce her husband

In-laws brutally tortured a newlywed woman for hours in a bid to force her to divorce her husband in Thakurgaon Sadar upazila on Monday.

The victim, Nehar Begum, 25, daughter of late Bashir Mohammad of Dangipara village in the upazila, with a fractured hand is undergoing treatment at Thakurgaon Sadar Hospital.

Police arrested Ashraf Ali, 50, a member of Ward No 3 of the union, for torturing the woman.

The victim's family members said Ashraf's nephew Nur Islam of Rampur village married Nehar about a month ago without the consent of his family.

Since their marriage, the couple had been living at a rented house at Madarganj village in the upazila.

In a bid to settle the matter between the two families, both of them went to their respective houses on Monday morning.

Around 11:30am, Ashraf along with his son Jewel and nephew Abdus Sobhan went to Nehar's paternal house and asked her to divorce his Nur Islam.

As she declined to accept their proposal, they beat her in front of her family members mercilessly with sticks.

At one stage, they forcibly picked her up, confined her to a room of the Jamalpur UP office building and tortured her for hours since 1:00pm.

Hearing cries for help, villagers informed the police of the matter around 9:00pm. Later, a police team led by Sub-inspector

Siraj-ud-Doula of Sadar Police Station rescued Nehar from her confinement and admitted her to Thakurgaon Sadar Hospital.

Nehar filed a case with the police station accusing her husband Nur Islam, several inlaws and UP member Ashraf the same night.

This correspondent tried several times to contact with Nur Islam over phone but there was no response.
