Save Kuakata beach project on cards

Tk 200cr plan for green sea wall, geo-tube in line with Kerala model of India

Water Development Board (WDB) is going to take up a mega project to save Kuakata beach from erosion.

The Tk 200 crore project titled 'Kuakata Sea Beach Protection and Development' will follow the Kerala model of India. Under the project, 'green sea wall' and 'geo-tube' would be set up on the beach and in the sea. Md Abul Khayer, executive engineer of

WDB in Kalapara, said they had completed the feasibility study and design for the project and will submit a development project proposal to the higher authorities for approval.

'Geo-tube' is a sand-filled plastic tube that will be set up around 15 to 20 metres under the sea to protect the shore from tidal surges. 'Green sea wall' is a special type of dyke built with earth-filled sacks on which grass can grow, he added.

A WDB team led by Chief Engineer (Design) Md Jahangir Kabir took part in a discussion at Indian Institute of Technology

(IIT) in Madras in this regard last year. They also visited the 'green sea wall' there and planned to apply the technology in Kuakata.

Prof V Sundor of Sea Engineering Department at IIT visited Kuakata in November last year. WDB took up this project after discussions with him, Khayer said. Water Resources Minister Anisul Islam

Mahmud and State Minister Nazrul Islam visited Kuakata beach on September 1 this year and assured the residents that they would take steps to save Kuakata beach from erosion. Kuakata Municipality Mayor Abdul

Bareq Mollah said the beach is an eyecatching tourist spot but it is losing its natural beauty due to erosion caused by tidal surge. If erosion can be stopped, many investors would go there and the tourist spot would be a very pleasant place, he added. The government should also take up

sustainable development projects to improve the tourist spot, Bareq said.

Durga gets final touch

Idol makers are passing busy time ahead of puja

With Durga Puja, the biggest religious festival of Bangalee Hindus, around the corner, artisans of Lalmonirhat, Bogra and Mymensingh are passing busy time, putting final touches on

At least 417 Puja mandops (temporary temples) have been set up in five upazilas of Lalmonirhat to celebrate the festival, the worship of the goddess, Durga, to be held on October 7-11, reports our correspondent.

Idol makers from different areas of the district as well as those coming from Bogra, Tangail, Faridpur, Rajbari, Nilphamari, and even India, weeks before the occasion are busy putting final touches on the clay images of the deities at the temples.

Idol maker Narayon Chandra Roy, 50, of Roypara village in Sadar upazila, said they are working round-the-clock putting final touches on the idols.

Meanwhile, hiring rate of drummers has almost doubled ahead of the festival, said members of different temple managemen committees.

Due to their high rate, many temple committee members are yet to hire drummers although a few days are left to celebrate Durga Puja. A drummer is now charging Tk 8-20 thousand for

four days while it was Tk 4-8 thousand last year, said some members of the committees. According to our Bogra correspondent, all-out preparations to celebrate the five-day celebration

of the district. As part of the celebration, at least 619 mandops have been set up in the district, said Bogra police.

12 Years into Murder

Killers of Dipankar yet to be arrested

Over a decade into the brutal murder, journalist Dipankar Chakrabarty's killers are yet to be brought to justice.

Dipankar, 54, former vice president of Bangladesh Federal Union of Journalists, was hacked to death at Shannalpara in Sherpur municipality on October 2 in 2004 when he was returning home from his workplace in Bogra town.

His son Partho Sharothi Chakrabarthy later filed a murder case with Sherpur Police Station, accusing unidentified criminals. The case was later shifted to Criminal Investigation Department (CID).

But two consecutive investigation officers submitted final reports and the complainant placed naraji (no-confidence) petition to the court each time.

Failing to trace out the main killers, the then Assistant Superintendent of Police (CID) Abdus Samad Mia submitted final report, releasing 7 suspected arrestees in mid-2013. Demanding further investigation and

punishment of the killers of Dipankar, journalists of Bogra will form a human chain in the town today.

Father cries for return of missing daughter

A man of the Hindu community, at a press conference called by him yesterday at Mymensingh Press Club, demanded immediate rescue of his daughter, who has been missing for over a month.

Manik Chandra Das, a tea stall owner at Amirabari Namapara area in Trishal upazila of the district, said his daughter, a student at a local college, faced stalking by Rakib Miah, son of Rafiqul Islam of the village, for long.

Rakib proposed his 'love' to her several times in the last four months. As the girl refused every time, Rakib threatened that he would teach her a good lesson, Manik alleged.

"When my daughter went to collect water from a tube-well at local Kashiganj Bazar around 7:00am on July 23, Rakib and his accomplices abducted her. She has remained untraced

since then," he said.

He said he informed Rakib's family members about the incident but they did not help him.

Manik said he filed a case with Trishal Police Station accusing Rakib, his parents and his cousin Faruq, a rice trader, the following day, but police did not take any steps to rescue his daughter.

Since filing of the case, the Dinajpur accused and their men have been threatening him to withdraw the case or face dire consequences, he alleged.

Leaders of the district and Trisha upazila units of Hindu-Bouddhist-Christian Oikya Parishad (HBCOP) met with Trishal police regarding the matter.

President of the Mymensingh unit of HBCOP Advocate Bikash Roy, advocate Proshanto Kumar Das and Gouranga Saha were present at the press conference, among others.
