# Farmlands near Payra in peril

Government move to set up port there triggers rush for land purchase

If one goes deep inland in Kalapara of Patuakhali near the Payra Port, hundreds of signboards could be seen on pieces of land covered by Aman seedlings.

After the government moved to establish the port there, the quiet farming neighbourhood has changed. There is rush for buying land by public and private firms and local wealthy people to set up various establishments close to the port that is on 6,000 acres of land.

Prices of land surrounding the port skyrocketed and so did the tension among land owners, according to some locals of Tiyakhali union. Some have sold land without their co-owners consent, while some others are trying to buy land off co-owners.

Prior to the government's announcement to build the port there, locals usually sold three decimals of farmland for less than Tk 20,000. But the prices began soaring after the government announcement in 2013. Now, the prices are between Tk 30,000 and

In some cases, the prices went up even higher following the government's move to acquire land for the port, for public agencies to set up five power plants, a land-based Liquefied Natural Gas (LPG) terminal and an oil refinery, according to data from Patuakhali DC office.

For example, state-run North West Power Company Ltd has sought 1,015 acres to build a 1,320MW power plant. Bangladesh-China Power Company Ltd has already started building a 1,320MW power plant near the new port. Rural Power Company Ltd, Ashuganj

Power Company Ltd, Sena Kalyan Sangstha, Bangladesh Petroleum Corporation and Petrobangla have also lined up for land to build power plants, oil refinery and LGN terminal in the area.

The government has approved three 1,320MW power plants of the five proposed plants, said Payra Port Authority (PPA) acting chairman Capt Md Saidur Rahman.

#### Diplomatic ties with Pakistan to continue Says PM

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said Bangladesh's diplomatic relations with Pakistan will continue alongside dis-

putes although Pakistan has been making various adverse statements on the ongoing war crimes trial.

" ... whatever [adverse thing] they [Pakistan] are saying, we're protesting that...our diplomatic relations with them will continue alongside disputes," she said.

Hasina made the comment while replying to a query during her scheduled press conference on her recent visits to Canada and the USA. The conference was organised at her official residence the Gono Bhaban.

She said Pakistan is a defeated force and it was compelled to recognise Bangladesh in 1974.

## Man with a mission for school children

Kulaura primary schools turning colourful for young learners

Pioneering Sharif-ul-Islam, who works as the upazila primary education officer in Moulvibazar's Kulaura, knows how to make a lot from a little. In efforts to encourage attendance and inspire young learners, he has set about transforming the upazila's 193 primary schools from drab, run-of-the-mill institu-

tions into campuses that can only delight. Most of Kulaura's primary schools have become "colourful schools".

"The majority of children who attend our school," says Abu Sayeed Md Shafique Rahman Siddique, head teacher of Amir Solfu Government Primary School in Kulaura, "are from struggling rural families. Earlier, we had

### Tahmid freed on bail, cops find he'd no link

Tahmid Hasib Khan, who had been detained over the Gulshan café siege, was released on bail yesterday.

The Chief Metropolitan Magistrate's Court in Dhaka passed the bail order after a peti-

tion was moved by his lawyer. Also, police turned in a probe report with a prayer for relieving him of the accusation that he had involvement in the terror attack.

In the prayer, police said they found no evidence of his links to the Gulshan attackers or any other militants.

The court fixed Wednesday for hearing on the report, submitted by Inspector Humayun Kabir of the Counter Terrorism and Transnational Crime (CTTC) unit of DMP. It was sent to the court's general recording section on September 28, sources

Jahangir Kabir, senior jail superintendent of Dhaka Central Jail in Keraniganj, told The Daily Star last night they released Tahmid at 10:15pm on completion of all formalities.

Tahmid, a Canadian university student, and Hasnat Karim, a former private univer-

sity teacher in Bangladesh, were arrested on August 3 under section 54 of the Code of Criminal Procedure (CrPC), according to police.

Section 54 says police can arrest any person on suspicion without any warrant.

Police produced them before a Dhaka court on August 4 and sought 10 days' remand for each, but the court granted eight days.

After the remand ended, police produced Hasnat before the court as an accused in the Gulshan attack case on August 13.

Though Hasnat, now in jail, was shown arrested in the case that day, Tahmid was

kept detained under section 54. While praying for their remand, police had said, "It appeared during primary interrogation that the said accused [Tahmid and

Hasnat] instigated the militant attack." Police further said they needed to interrogate them "about patronising members of militant organisations, their connections with militant outfits and for arresting other terrorists".

### Militants attack Indian army camp in Kashmir

At least six militants attacked an Indian army camp in north Kashmir last night, killing one border guard and wounding another, two weeks after a similar attack killed 19 of its soldiers and ratcheted up tensions between India and Pakistan.

Local reports that two attackers had been killed could not
