'Criminal' killed in 'gunfight' with Rab

An alleged criminal was killed in a "gunfight" with members of Rapid Action Battalion in Tangail last night.

The deceased is Nurun Nabi alias Munshi, 35, of Thanapara area in the Nurun Nabi and his two accompli-

ces snatched a motorcycle in Sirajganj and were on their way to Dhaka, claimed Mohiuddin Faruque, commander of the crime prevention company (CPC)-3 of Rab-12.

Acting on a tip-off, a Rab team took position in Dorun area by the Dhaka-Tangail highway around 9:00pm to arrest the criminals, he

Sensing the presence of the Rab team, the criminals opened fire on them, forcing the Rab men to fire back that triggered a "gunfight", Mohiuddin told The Daily Star.

Nurun Nobi was injured in the gun battle. His two associates, however, managed to flee.

He was taken to Tangail Medical College Hospital where doctors

declared him dead. The Rab members recovered a

foreign-made pistol, three bullets, a magazine, a machete and a motorcycle from the spot. Nurun Nobi was the leader of a

robber gang called "Munshi" group and accused in about two dozen criminal cases, including nine for murder and 12 for robbery and snatching, filed with different police stations in Tangail, Gazipur and Mymensingh, the Rab commander claimed.

The Daily Star could not independently verify the claim.

> The ministry of law is currently vetting rules for the ECA area around the Sundarbans. Once the rules are passed, the department would swing into action regarding the polluting industries.

The draft ECA rules prohibit setting up any industry or conduct any activities that pollute the land, air or water and also cause sound pollution.

The Bangladesh Environment Conservation Act of 2010 also prohibits anyone from setting up industries or construct other establishments in the buffer zone, an area within 10 kilometres of the forest.

There are dozens of existing conventions, policies, rules, guidelines, treaties, and protocols that restrict such activities close to the reserve forest, also a UN natural heritage site. Some of these legal barriers have been erected by the present government. Environment experts think all these

Narrator is Safi: DMP

The narrator of the recent video purportedly by Islamic State featuring the five Dhaka attackers is Tahmid Rahman Safi, a Bangladeshi man now reportedly in IS stronghold Syria, police said.

Investigators came to the conclusion through matching the voice on the video with voice recognition software, Monirul Islam, chief of the Counter Terrorism and Transnational Crime unit of Dhaka Metropolitan Police, said yesterday.

Safi is the son of former election commissioner and home secretary late Safiur Rahman.

The 32-year-old was a singer and made it to the top 15 in the first season of the country's popular talent hunt show Close Up 1, his friends earlier said. He was also the first man seen in a

video released soon after the July 1 Gulshan attack praising the attackers. Tahmid left the country on April 23

last year, saying he was going on a honeymoon, his family members said at the time. On September 23, the SITE

Intelligence Group, a US-based organisation that monitors terrorist activities, said that the IS released a video from Bangladesh for the first time about the Holey Artisan attackers.

"IS Releases First Video from Bangladesh, Focuses on Dhaka Attackers," the group tweeted.

The five attackers -- Nibras Islam, Rohan Imtiaz, Meer Mubasheer, Khairul Islam Payel and Shafiqul Islam Uzzal -- stormed the Holey Artisan restaurant and killed 20 hostages, 17 of them foreigners. They were later killed in an army operation.

In the video, in which they appear to have spoken before the attack, they are heard threatening that they would target anyone who they call the "enemies of Islam".

According to a provision under Section 176 of the Penal Code, anyone shall face maximum one month's jail term or Tk 500 fine, or both, for hiding information to government official. In the petition, the IO said they

brought charges against Tahmid of violating the provision. Police also prayed for relieving

Tahmid of the accusation that he was involved in the terror attack. On Sunday, the court granted bail to

Police then kept claiming they had released Hasnat and Tahmid after questioning, but their families insisted that the two never returned home and could not be reached by any means.

Over a month later, police came up with a claim that the two were arrested on August 3 under Section 54 of the Code of Criminal Procedure (CrPC). Section 54 says police can arrest any person on suspicion without any warrant.

Law enforcers told the media about the arrests the next day, August 4, when the two were produced before a court for the first time.

Monirul Islam, chief of CTTC, at a briefing yesterday said police needed Tahmid's cooperation to verify some information. He was sent notices more than once but he didn't show up.

The official added Tahmid was arrested under Section 54 for withholding information and not cooperating with the police in investigating
