A gang with a microbus and a pick-up was preparing to commit robbery on Sagardighi-Bharadoba Road at Sholakuri in Ghatail around 1:30am, when locals caught one of them and beat him dead, said Mohammad Kamal Hossain, OC of Ghatail Police Station.

The deceased, aged around 30, could not be identified.

Later, locals caught three more robbers when they were trying to flee on the microbus.

The three -- Nahid Hossain, 20, of Tangail, Delwar Hossain, 28, of Chandpur, and Sumon Khan, 34, of Dhaka, were handed over to police.

Docs struggle to cope with rabies

Shortage of vaccine hampers treatment as number of dog bite patients on rise in Nilphamari

Amid sharp rise in the number of dog bites during the ongoing breeding season, when some of the animals turn mad and tend to bite people, shortage of anti-rabies vaccine (ARV) in the district civil surgeon's office store hampers treatment of the serious patients.

The breeding season of dogs is from mid-September to mid-November, said district livestock officer Shahjamal Khondokar.

On a visit to Bazar, Kalibari, Madhar, Post Office, and Ananda Pul intersections in the district town, this correspondent saw dozens of crazy street dogs in big groups fighting on crowded roads, creating panic among pedestrians.

The street dogs have bitten a large number of people, including school children, who are flocking to

Nilphamari 250-bed hospital for ARV, but it is not available there.

Resident Medical Officer (RMO) Dr Hasanur Rahman said around 800 patients visited the hospital in September for treatment with bite injuries, 95 percent caused by dogs.

Five hundred seventy-five patients with dog bites visited the hospital in August, 450 in July and 312 in June, indicating that the number of such patients rises during the breeding season of dogs.

"We need around 800-900 vials of ARV a month during this emergency period, but we had only 100 vials in September, which is inadequate," Dr Hasanur said.

"With this meagre supply, we were able to give treatment to only 100 patients in September, as a patient needs a full vial containing four injections to be taken four times at certain intervals," the RMO said.

The vaccine supply was only 50 vials per month in June, July and August, he added.

Doctors say that if a victim is not injected with ARV within a certain time, he could be infected with hydrophobia and die.

ARV with brand name Rabix vc, supplied by Incepta Vaccine Ltd, is usually given free in government hospitals.

Imported vaccines Rabipur from India and Verorab from France are found in the open market, but they are very costly. A full course of four injections of Rabipur costs Tk 2,600, while Verorab costs Tk 3,000.

Court orders cops to sue BNP leader's son

Tk 100cr defamation case against another in Rangpur

40 mahogany trees felled

College principal blamed in Panchagarh

At least 40 valuable mahogany trees were cut down illegally on the premises of Amlahar Degree College in Sadar upazila of Panchagarh in the last few days.

Local people said Principal Mobarak Ali arranged cutting down the trees of the college at night in the last few days to sell them to wood traders. This correspondent on Friday saw a good num-

ber of logs of matured mahogany trees on the college ground. The people who cut down the trees also felled two trees in front of the quarters of the subassistant agriculture officer.

When asked, Principal Mobarak said the trees were felled for making furniture for the college, locals said on condition of anonymity.

College managing committee members Abdus Sattar and Hasinur Rahman said the principal took permission

from the deputy commissioner (DC) about one and a half years ago for cutting down several trees, saying it was necessary for construction of a building.

Since then, the principal cut down trees in three phases, mentioning the permission, and sold them and embezzled the money, they said.

Tapan Kumar Sharma said he had submitted a complaint to the upazila agriculture officer against Principal Mobarak as he cut down trees within their quarters.

Magura Union Sub-Assistant Agriculture Officer

Principal Mobarak said he had felled the trees to make furniture for the college after taking permission from the DC, but could not show any document to support his claim.

DC Amal Krisna Mandal said he didn't give such permission to anybody within a year, adding that he would look into the matter.

1,200 families deprived of cheap rated rice

At least 1,200 families in Phulbari upazila of the district have been deprived of getting rice at Tk 10 per kg, thanks to the callousness of Shibnagar union parishad (UP) chairman.

Upazila Food Control Officer Modhusudan Dutta said seven UP chairmen were asked to submit lists of beneficiaries by August 8.

Of them, Shibnagar UP Chairman Mamunur Rashid placed lists of the ultra-poor families without recquired papers and photographs of beneficiaries on August 28, he said.

However, Mamunur said he submitted list of beneficiaries with required papers and photographs on August 28.

Modhusudan Dutta said the list was placed on August 28, 20 days after the deadline.

Besides, the list was full of mistakes and many necessary papers, copy of National Identity cards and photographs were missing, he said.

Stolen baby rescued in Joypurhat
