Rights bodies worried over attack on Sylhet girl STAFF CORRESPONDENT

Samajik Protirodh Committee, a platform of 69 women, human rights and development organisations, yesterday expressed deep concern, resentment and condemnation over a Bangladesh Chhatra League man recently attacking a college student with a machete in Sylhet.

The platform in a press statement demanded a fair and neutral investigation, proper departmental and legal action against the culprit and proper treatment and security for the victim, Khadiza Begum Nargis.

The committee also demanded formulation of a separate law following a High Court judgement on resisting sexual harassment and stalking.

The 23-year-old student of Sylhet Government Women's College was hacked repeatedly on October 3 by Badrul Alam, a fourth-year student of Shahjalal University of Science and Technology and a senior assistant secre-

tary of the BCL unit there.

The attacker delivered blows on Khadiza's head with a machete, and the sharp weapon went beyond the skull multiple times damaging the brain, said doctors. Later, the students along with locals caught and beat Badrul up and handed him over to police. The girl is undergoing treatment in the ICU of Square Hospital in the capital.

Meanwhile, Ain o Salish Kendra in a separate statement also protested incidents like murder and attacks and threats on women, stating that panic in the minds of people was increasing as they were not getting due justice.

Though law enforcing agencies are claiming that the law and order situation is under control, these kinds of incidents are creating insecurity among women, said the statement.

Start registration to allow hiring domestic help

Prothom Alo roundtable urges govt

Domestic helps should be hired following a certain registration process while a regular investigation in the capital's households is also needed to stop child labour and violence, speakers told a conference yesterday.

They also said most of the domestic help torture cases get adjourned without punishing the perpetrators. Labour and human rights activist said these at a roundtable organised by Bangla daily Prothom Alo at its office in the capital.

The government should launch a mandatory registration process for recruiting domestic helps so that children can be stopped from getting hired. Also a regular investigation at Dhaka houses is needed to ensure children are not working as domestic helps, said Sultan Uddin Ahmed, executive director of Bangladesh Institute of Labour Studies (BILS).

"We have to change our mindset to stop violence against the domestic help," said Mujibul Haque, state minister for the ministry of labour and employment, adding, the government is planning to form a law for the domestic helps in this regard.

Salma Ali, executive director of Bangladesh National Women Lawyers' Association, said the government's support is needed so that the victim's family can get justice.

Rasheda K Choudhury, a former caretaker government adviser; Prothom Alo Editor Matiur Rahman; and Syeda Munira Sultana, project coordinator of International Labour Organisation also spoke.

SUCCESS IN SOLAR ENERGY, ELIMINATING OPEN DEFECATION

Dhaka lauded at Delhi summit

Sustainable and renewable energy is the future and time has come to enhance international cooperation to facilitate its supply for all as one in every five people still lack access to electricity, said experts yesterday.

Stressing exploring options for renewable energy, they said the policymakers should focus on reducing carbon intensity of energy.

Still three billion people rely on biomass for cooking and heating which is a dominant contributor to greenhouse gas emission, they added.

The experts were addressing a session, "Mainstreaming sustainable development goal 7: Affordable and clean energy for all" on the first day of a four-day World Sustainable Development Summit in New Delhi.

The Energy and Resource Institute organised the summit in collaboration with United Nations

Development Programme (UNDP) with the slogan "Beyond 2015: People Planet and Progress". President Pranab Mukherjee is

going to formally inaugurate the summit today. WSDS is among the first international platforms to discuss the new development agenda following the

adoption of the Sustainable

Development Goals (SDG) and the signing of the Paris Agreement at the 21st Conference of Parties (COP21). Many developing countries including Bangladesh achieved remarkable success in using solar energy, said Rachel Kyte, chief executive officer and

special representative of an organisation, Sustainable Energy for All. "If some particular government go for coal fired power plant at this moment that would be an individual incident. But in general all countries

including India are focusing more and

more on renewable energy," she said. The renewable energy market is getting competitive and is cheaper than before, she added in a keynote speech in the renewable energy session.

Speakers in some sessions said Bangladesh was an example for developments like eliminating open defecation and providing loan to landless ultra-poor people. "India is learning from Bangladesh about how to get success in eliminating open defecation," said Vijay Kumar, former director of National Wastelands Development Mission, at a luncheon interaction on the theme of rural development and poverty reduction.

Dr Ajay Mathur, director-general, Teri, said, "We all hope this summit proves to be the time when we are able to take action from a few to the most. This will largely come from action by the government, civil society, businesses, and the public at large.

Some of the key thematic sessions deliberated on challenging issues including climate resilient agriculture, energy costs in India's context, mainstreaming affordable and clean energy and creating stronger linkages between climate risks and policy and practice.

Helping the transition to low global warming potentials refrigerants and higher efficiencies, using multistakeholder simulations to examine impacts of food policy choices in India and Asia and mainstreaming biodiversity for responsible business also came up for discussion.

These sessions were in partnership with World Bank, European Union, International Finance Corporation, UNDP, CARIAA, Ingersoll Rand and International Union for Conservation of Nature, among

1,095 children killed in 4yrs

A total of 1,095 children were killed in various incidents, including homicide, abduction and suicide, in last four years, said a study report of non-government organisation.

Child Rights Advocacy Coalition, a platform of 10 NGOs, yesterday presented the report at a discussion in the capital. The report is based on data taken from Bangladesh Shishu Adhikar Forum (BSAF).

The report said 967 children were reported to be raped during the four years while 521 children were raped in 2015 and 199 in 2014.

Tania Nusrat Zaman, head of child rights and protection, Plan International, highlighted that even though there is a law that birth registrations of newborns should be done

within 45 days but parents do not intend to do so. Speakers mentioned that a specific budget should be mentioned for child education and recommended that all cases of child torture and rape should be brought under

Kazi Reazul Hoque, chairman of National Human Rights Commission of Bangladesh, Nur Khan, acting executive director of Ain o Salish Kendra; SM Rashid, advisor of Educo, and Hagar Russ, director of Save the Children, also spoke.

HC asks 3 lifers

Md Salim and Saiful Islam alias Bilai Saiful.

Naser, Humayun and Salim have been sentenced to life term imprisonment and Saiful's acquittal has been cancelled by the HC on February 12, 2014 for killing

Rabbani. In the full verdict, the HC said convicts Humayun, Naser and Salim, who are on bail, have been directed to surrender before the trial court within eight weeks from the date of receipt of this judgement to serve out their respective sentences.

"Resultantly the conviction of accused Humayun Kabir Chowdhury and Abu Naser Chowdhury under section 120B/302 of the Penal Code is hereby affirmed but their sentences are enhanced to suffer imprisonment for life with a fine of Tk 50,000 instead of five years," it said.

Besides, conviction of Salim by a speedy trial tribunal in Chittagong is hereby affirmed, said the HC bench of Justice M Enayetur Rahim and Justice Akram Hossain Chowdhury in the verdict.

The judges, however, said they scrapped the lower court judgement of Bilai Saiful's acquittal. "The trial court is directed to pass a fresh judgment in light of the observations made in the body of this (HC) judgment."

"We are of the view that learned judge of the Druta Bichar Tribunal rightly and lawfully found Abu Naser Chowdhury and Humayun Kabir guilty for committing murder of the deceased under section 120B/302 of the Penal Code.

However, the learned judge has committed an error in awarding lesser sentence to accused Abu Naser and Humayun Kabir; the learned judge awarded an inadequate sentence of five years against them having though there is a provision of capital punishment or imprisonment for life under section 120B of the Penal Code for the same offence,' the judges observed.

They said, "In view of the evidence, facts and circumstances as remained in the case and the discussions made herein above, we are in a considered view that the said punishment awarded by the trial court should have to be altered and enhanced." The Druta Bichar Tribunal, Chittagong in April, 2005

gave five years' imprisonment to Naser and Humayun, life term imprisonment to Selim, Mohammad Hashim and Abdul Malik Sohel, and acquitted Saiful. The same year, the convicts appealed to the HC against

the verdict while the government filed two revision peti-

tions seeking death penalty for the accused. acquitted on February 12, 2014 by the HC.

Hashim had been acquitted earlier while Sohel was
