Mymensingh A private hospital in Bhaluka upazila was sealed yesterday by a mobile court following allegation that a carrying woman died due

to doctor's negligence on Wednesday. A court led by Executive Magistrate Afroza Akhter raided Tahmina General Hospital and Diagnostic Centre and sealed the clinic

around 11:00am. The court also detained Saidur Rahman, 26, an employee of the hospital, from the spot, said Officerin-Charge (investigation) Mohammad Hazrat Ali of Bhaluka Police Station.

Later, the court sentenced Saidur to five-day imprisonment for storing contaminated medicines, the OC added.

Meanwhile, a threemember probe committee was formed yesterday to investigate the death of the patient and was asked to submit its report within 15 working days.

Harijan girl beaten in school by outsiders

Intruders beat a female student of Class-X inside the classroom of CM Ayub Girls' High School in the town yesterday.

Soma Das, 15, daughter of Bijoy Das of Fakirpara Harijan colony in the municipality area, faced the wrath of the mother and brother of her classmate Afsana Begum, for visiting the latter's house, said the victim and school sources.

"Fatema Begum, mother of Class-X student Afsana Begum of the school, and her son Farukh Hossain entered the school forcibly around 11:30am. They beat Soma Das inside the classroom, blaming her of stealing a mobile set," Dipendranath Jha, headmaster of the school, told this correspondent over cell phone.

The girl started bleeding from the nose and mouth due to the beating.

On information, police went to the school and brought Fatema Begum and the victim to the police station.

Shortly afterwards, local Ward Councilor Waliur Rahman went to the police station and brought them to school and arranged an arbitration after calling guardians of Soma and Afsana in presence of the headmaster.

When the matter was disclosed to the local police high-ups and newsmen, police asked the victim's guardian to file a case against the

offenders. Soma Das told this correspondent, "After I came to school from Afsana's house, her mother Fatema and brother Farukh came to school and said a mobile phone was stolen from their house.

"They searched my bag but didn't find any phone. After sometime, they came again and wanted to search my bag again. But without completing the search, they said the phone was found from here. And they started beating me in the classroom.

"As I am from the Harijan community, Afsana's guardians could not accept my visiting her at the house and beat me, falsely blaming me for stealing.

Waliur Rahman said he tried to settle the matter as it was a trifling incident.

Headmaster Dipendranath Jha said, " didn't say anything as the local influential people came to settle the matter."

"It seems that the incident occurred as Afsana's guardian could not accept visiting the house by her classmate Soma, a Harijan girl," said Abu Hanif, sub-inspector of the local police station.

Additional Superintendent of Police Dewan Lalon Ahmed said they have taken the matter seriously and police will take stern action after proper investigation.

Procedure of filing a case was on as of submitting this report at 6:00pm.

8 Jubo League men arrested with drugs

Rapid Action Battalion (Rab) arrested eight Jubo League activists from Bonpara area in Boraigram upazila on Wednesday and seized 250 grams of heroin from their possession.

The arrestees are Jubo League activists Zillur Rahman, 34, Abul Bashar, 33, Mridul Kumar, 36, Mahidur Rahman, 30, Kalam Mia, 35, Shakil Hossain, 34, Abdur Razzak, 34, and Faruk Hossain, 26.

ASP Anwar Hossain of Natore Rab camp said a team of the law enforcers, acting on a tip-off, raided the area at midnight and arrested the eight Jubo League activists.

Rab also seized 250 grams of heroine and several Yaba tablets from them, the ASP added.

Bridge work stalled

The work of a bridge over the Nautara River on Lalmonirhat-Nilphamari-Panchagarh road in Dimla upazila under the district has remained stalled for about a year due to a dispute between the construction firm and the upazila engineer of Local Government Engineering Department (LGED).

For want of the bridge, tens of thousands of people of Jaldhaka, Dimla and Domar upazilas in Nilphamari, Hatibandha and Patgram in Lalmonirhat and Deviganj and Boda in Panchagarh have to cover additional 20 kilometres to go to different destinations by buses and trucks.

Work order to construct the 75-metrelong and 5.5-metre-wide concrete bridge was given to construction firm Messrs Shamimur Rahman JV on March 27 last year to complete it by this year, said sources of upazila engineering department in Dimla.

The estimated cost to construct the bridge was about Tk 2.37 crore but the firm agreed to do it for about Tk 1.96 crore, some 18% less, allegedly to receive the work order easily.

Saiful Islam Lenin, chairman of Nautara union parishad, said the firm started the work in time and brought construction

materials but removed those within a few

Saidul Islam, site caretaker of the construction firm, said after starting the work, the upazila engineer made a number of deliberate objections, making it difficult to continue the work.

Abu Jafar Saleh, upazila engineer of LGED, said, "The contractor started using low quality stones and cheap composite cement and planned to do low quality work for piling. I will not allow sub-standard work by any means."

Contractor of the work, Md Jewel claimed that he did not use any low quality materials.

"As per rule, certain amount of initial fund is to be released to start the work but the authorities concerned didn't release any money for the purpose. Besides, two pillars of the old bridge sold in auction are still standing in the river, making it difficult to continue the work," he added.

Executive engineer of LGED in Nilphamari, Belal Hossain said the work order in favour of the construction firm might be cancelled and the deposit money forfeited if it fails to do the work in time as per schedule.

HYBRID BEAN FARMING

Golzar a model for Bogra farmers

MAMUN-UR-RASHID, Bogra

An elderly farmer has become a role-model for other farmers by growing off-season hybrid beans in his two-bighas of land and earning good profit.

He is Golzar Hossain Bablu, 60, son of said. late Jahir Uddin Pramanik of Joypurpara under Dupchanchia upazila of the district.

While visiting the area last Friday, this correspondent saw the elderly farmer working enthusiastically in his bean field. His age does not dissuade him from working in the heat or in the rain.

Golzar Hossain said he used to cultivate paddy or sometimes vegetables on his two bighas of land, until he read a newspaper story about the success of a hybrid bean grower of Muladula area under Pabna dis-

With the help of an agriculture officer, he went to Muladula and talked with the farmer about the process of farming hybrid bean.

bean. He bought seeds for Tk 2500, he

He sowed the seeds on two bighas of land in the middle of May, and the beans started sprouting by the end of July. He has been reaping the crop for over a month, Golzar

He said he spent Tk 1.2 lakh on seeds, bamboo, cotton, labour and pesticide. He gets over one maund of beans per week, and the price is Tk 70-80 per kg in the market. He is hoping to make a profit of Tk 4-5 lakh in the current year, he added.

Sometimes the plants were attacked by pests, but he used pesticide at the suggestion of the Department of Agriculture Extension (DAE) and controlled the attack, Golzar

Local farmer Anis Ali said, seeing the honesty, determination and devotion of Golzar, some farmers of the area, including himself, have started cultivation of hybrid
