Bodies of the two female madrasa students were recovered from the Shankha river yesterday morning, two days into a boat capsizing in the river at Anwara upazila in Chittagong.

The deceased are --Jannatul Mawa, 12, daughter of Md Siraj and Hanufa Akhter, 14, daughter of Md Mostaque -- of Purbo Juin Dandi of the upazila.

The boat carrying female students of Jata Nurain Senior Madrasha of Banshkhali capsized in the river while they were going to attend their exams on Thursday.

Out of the 19 students, ocals rescued 17 instantly. Mawa and Hanufa, class VI and class VII students

respectively, went missing. Fishermen found their body floating near the place of the accident, said Dulal Mahmud, officer-in-charge of Anwara Police Station, adding, bodies were handed to their families.

The boat was capsized after its propeller got entangled with fishing net.

# HC still to rehear appeals to examine lower court verdicts

More than two years after the Supreme Court asked the High Court to "expeditiously rehear" and dispose of appeals from among 35 corruption accused, mostly politicians and their family members, the HC is yet to finish its job.

None of the 27 appeals filed was adjudicated yet. The HC started hearing only one of the appeals, challenging the lower court verdicts that jailed the accused to different terms in separate

corruption cases. Attorney General Mahbubey Alam told The Daily Star that he did not know why the HC could not settle any of the appeals because they were related to the corruption cases filed by the Anti-Corruption Commission (ACC).

It would be better if the appeals are heard and disposed of quickly, he added.

The HC bench led by Justice Md Ruhul Quddus started rehearing the appeal filed by former BNP lawmaker engineer Manjurul Ahsan Munshi in July, and it may resume the hearing proceedings after the ongoing annual vacation

Khan told The Daily Star.

He said the HC could not rehear other appeals, as its relevant benches were overburdened, and some of the documents were not produced before them on time.

Some of the appeals have been included in the cause lists of the HC benches for their hearings, he said.

The Appellate Division has so far scrapped several HC verdicts that acquitted around 35 people, including Relief and Disaster Management Minster Mofazzal Hossain Chowdhury Maya and former BNP minister Nazmul Huda, in separate corruption cases.

The HC will examine through rehearing of the appeals whether the lower court verdicts that sentenced the accused were correct or not, he said.

Advocate Khurshid said the SC cancelled the Selim, former BNP state minister Amanullah acquittals of the accused, considering that the HC verdicts on them were not correct, since it did not properly consider the relevant evidence and the corruption allegations against

them. ends, on October 30, ACC lawyer Khurshid Alam the corruption accused in the cases against them wife Afia Haque, former Islami Oikya Jote lawmaker in the light of an SC judgment that acquitted

former Awami League minister Mohiuddin Khan Alamgir in a similar case.

The lawyer said the SC had acquitted Alamgir, declaring illegal a 2007 ACC notice that asked him to submit a wealth statement. There were no ACC commissioners appointed then and Alamgia was in jail at that time, he added.

Then the commission gave a similar notice to

around 50 corruption suspects, he said. Apart from Maya and Huda, other corruption accused whose acquittals were rescinded by the apex court include Huda's wife Sigma Huda, former BNP state minister Iqbal Hasan Mahmood Tuku, BNP leader Mir Mohammad Nasiruddin and his son Mir Helal Uddin, ruling Awami League lawmaker Haji Mohammad Aman and his wife Sabera Aman, former AL lawmaker Joynal Abedin Hazari, former BNP lawmaker Hafiz Ibrahim and his wife Mafruza Sultana, former AL lawmaker Mockbul Hossain and his wife Fatema Tahera Khanam, former The ACC counsel said the HC had acquitted commissioner of customs Jahurul Haque and his

# Dhaka, Berlin vow to tackle terror

Bangladesh and Germany have held a discussion on the scourge of terrorism and violent extremism and vowed to work together to address this global challenge.

Both sides also discussed orderly migration and mobility of people within the context of the meeting of the Global Forum for Migration and Development (GFMD), to be held in Dhaka in December.

Germany is scheduled to take over the chairmanship of the forum from Bangladesh.

The bilateral talks were held between Foreign Minister AH Mahmood Ali and his German counterpart Dr Frank-Walter Steinmeier in Berlin on Friday, the Bangladesh foreign ministry said yesterday.

During the meeting, the foreign ministers discussed all aspects of bilateral relations and agreed to work closely to strengthen and expand areas of mutual cooperation between the two countries.

Terming the relationship between Bangladesh and Germany warm and deep, Foreign Minister Mahmood Ali reiterated Prime Minister Sheikh Hasina's invitation to German Chancellor Angela Merkel to visit Bangladesh to

take the relations to a new height. Referring to a recent World Bank report,

Foreign Minister Mahmood Ali apprised his German counterpart about the sustained economic progress of Bangladesh and urged the German side to seize the opportunity to broaden their engagements in Bangladesh, particularly in terms of trade and investment.

Both ministers also exchanged views on regional and international issues of mutual interest, including the ongoing refugee and migration crisis in Europe.

Foreign Minister Mahmood Ali was warmly received in Berlin and extended full state protocol, including ceremonial motorcades escorting him to all the official programmes.

Upon arrival at the German foreign ministry, Foreign Minister Mahmood Ali was received by Dr Frank-Walter Steinmeier who showed him some documents from their archives recalling establishment of diplomatic

relations between Bangladesh and Germany. Foreign Minister Mahmood Ali visited the German parliament, the Bundestag, and held a meeting with Niels Annen, spokesperson on Foreign Affairs of the Social Democratic Party (SPD) Parliamentary Group in the Bundestag and chairperson of the SPD's Commission for International

The SPD is a major partner of the ruling
