The Directorate General of Health Services (DGHS) yesterday published results of the MBBS admission tests held on October 7.

The results have been uploaded to the DGHS website, and candidates can instantly check their results," DGHS Director General Prof Dr Abul Kalam Azad told The Daily Star.

This year over 90,000 candidates applied for admission. Of them, 85,207 candidates appeared in the tests for 3,212 seats in public and 6,205 seats in private medical colleges, Prof


Azad said. The highest mark is 85.5 and the lowest is 70..., he mentioned.


The pass mark was 40 in the 100 marks Multiple Choice Question test, scored by 29,183 candidates.

"This year we got the answer scripts checked in computerised systems by two independent groups -- one of Dhaka University and the other of the Shahjalal University of Science and Technology," said the official, adding that there was no chance for the results to be wrong.

The images of the answer sheets have been recorded in the computer systems. Anyone complaining about the results can easily have a chance to see their answer sheets, as the authorities would not need to search for

manual files, the DG said. The admission process will start on October 20.

Anti-govt protest fails for lack of nat'l unity

Says BNP Secretary General Fakhrul

BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday blamed a lack of national unity for movements being unsuccessful in ousting the incumbent government from power.

"The situation of 1990 and 2016 is not the same. There is no example of success of a mass movement being attained without forging a national unity. It is sad that there has been no progress towards national unity till now," he said.

Fakhrul was addressing a discussion Jehad Smriti Parishad organised in the capital's Dhaka Reporters Unity on the Jatiyatabadi Chhatra Dal leader who sacrificed his life during the anti-autocracy movement in 1990.

Fakhrul said the nature of international and regional politics of 1990 was totally different from that of the pres-

Jehad's death generated a tough movement against the then autocratic government and united the whole nation, but at present times hundreds of people have been killed during the anti-government movement but it could not create any appeal among people, he said.

Pointing to a new regulation bill for the foreign-funded NGOs, he said the government has targeted NGOs, it would never let off anyone and none would get rid of this government without national unity. The Foreign Donations (Voluntary Activities) Regulation

The EC has a legal obligation to complete the polls to a city corporation within the last 180 days of its tenure.

With this, any city corporation election is going to be arranged along party line for the first time in the country according to the Local Government (city corporation) Act 2009, which was amended in November 2015 paving the way for political parties to field candidates alongside independent contestants for the mayoral post.

Earlier the countrywide municipal and union parishad elections were held along the party line.

The NCC went to election on October 30, 2011 when Dr Selina Hayat Ivy was elected the country's first female city mayor.

Comilla City Corporation went to polls on January 5, 2012 when BNP-backed mayoral candidate Monirul Islam Sakku came out victorious.


Bangladeshi state minister appreciated UAE's offer and briefed that with four million solar homesteads, Bangladesh holds the highest record for solar panel
